### STAFF RECOMMENDATION:

That the Advisory Committee on Environmental Sustainability provide comment and endorse the Environmental Framework Process.

#### PURPOSE:

To provide ACES with a process for developing an environmental framework that identifies the communities environmental programs and services and seeks public input into defining a community vision for a greener Nanaimo in the future.

#### BACKGROUND:

At their 2014-JUN-11, the Advisory Committee on Environmental Sustainability received a presentation from Wally Wells, Business Representative on the ACES Committee, and Gail Adrienne, representing Nanaimo Area Land Trust, on a proposal to develop an environmental framework document for the City of Nanaimo. At that meeting, the following motion was unanimously approved:

"It was moved and seconded that the Advisory Committee on Environmental Sustainability endorse the concept of developing an environmental framework for Nanaimo using a partnership model and that staff return with a report on the mechanics of developing the framework."

On 2015-MAY-11, the Finance and Policy Committee of the Whole received a delegation from Paul Manly, and Trevor Greene, requesting that the City of Nanaimo pass a municipal declaration respecting people's right to live in a healthy environment. This declaration is based on The Suzuki Foundation's Blue Dot Project (<u>http://bluedot.ca/#the-plan/</u>) to have the right to a healthy environment added to the Canadian Charter of Rights and Freedoms. This was subsequently endorsed by Council on 2015-JUL-20 with amendments that integrated the development of the environmental framework into the declaration.

#### DISCUSSION:

Both the Corporate Strategic Plan and planNanaimo (the City of Nanaimo's Official Community Plan) provide an overarching vision and direction for Council and the community on a variety of issues, including protecting the natural environment. Committee members feel these documents could be complemented by creating a framework document that identifies all environmental policies and initiatives in Nanaimo, whether as part of a City program or another organization in the community.

It is expected that an environmental framework would provide context for how each policy and initiative contributes toward protecting and enhancing the City's natural urban environment; identifying future emerging environmental issues, and partnership and collaborative opportunities to address them.

The following is a draft phased process for consideration and discussion by the Committee:

<u>Phase 1 (Fall 2015)</u> – Identifying current environmental assets and resources.

- Send activity update to Council at the start of the process
- Identify stakeholders in the community.
- Establish an environmental framework review team (ACES members / stakeholders).
- Update environmental mapping / environmental assets and resources inventory and provide opportunity for stakeholders / public to review and comment on any draft maps.
- Review with ACES and Council.

<u>Phase 2 (Winter / Spring 2016)</u> – Community engagement: Provide opportunities for the public to define a green vision for Nanaimo. Provide opportunities for community stakeholders and residents to participate in a SWOT analysis (identify strengths, weaknesses, opportunities and threats) of current environmental policies, initiatives, programs and identify potential gaps.

- Online Survey.
- Hold forum with community stakeholders.
- Provide opportunity for the general public to participate while enjoying the environment (i.e. Idea Flags on Sway-a-Lana Bridge)

Phase 3 (Spring / Summer 2016) – Plan Preparation and Adoption.

- Prepare draft framework and vision.
- Review with ACES and Council.
- Public open house (to review draft framework and receive input).
- Prepare final draft framework.

Phase 4 – (Fall 2016) - Plan Approval and Implementation.

- Review with ACES and Council.
- Hold open houses and community review.
- Committee and Council approval.
- Implementation.

## RE: BUTTERTUBS MARSH MANAGEMENT PLAN REVIEW

### STAFF RECOMMENDATION:

That the Advisory Committee on Environmental Sustainability receive this report for information.

### PURPOSE:

To provide ACES with background on the Buttertubs Marsh Management Plan review process in preparation for their review and comment once the draft plan is received in the fall of 2015.

### BACKGROUND:

The Buttertubs Marsh Conservation Area is located adjacent to the Millstone River, within the City of Nanaimo. This 22 hectare conservation area consists of reclaimed wetlands (75%) and is bordered by a shrub mixed-forest complex which provides superb public trails, nature view points, and important educational opportunities. The Conservation Area has significant wetland values for a number of species including one red-listed and six blue-listed birds, and one red-listed and one blue-listed reptile species.

There has been a management plan and co-management agreement in place between the City of Nanaimo (through Parks, Recreation and Environment) and the Nature Trust of British Columbia (owner of the wetland) since 2004. A Management Committee meets regularly to review operational activities and to implement the current management plan.

The Buttertubs Marsh Conservation Area is one component of a larger wetland, river and floodplain complex which includes an adjoining property known as the "West Marsh". The West Marsh property, located at 175 Pryde Avenue, was acquired in 2012 by the City of Nanaimo and Ducks Unlimited. The land is zoned as a natural park and has an Ecogift designation that provides passive recreation and education opportunities, consistent and compatible with the conservation purposes for which the land was purchased.

#### **DISCUSSION:**

The Buttertubs Marsh Conservation Area Management Plan was prepared in November 2004. Since then the Buttertubs Management Committee has been meeting two to three times a year. The Committee is represented by a variety of different interests including the City of Nanaimo, Ministry of Forests Lands and Natural Resource Operations, Nature Trust of British Columbia, Ducks Unlimited Canada, and volunteer representatives from the Friends of Buttertubs Marsh.

In January 2015, the Management Committee agreed to proceed with a review and update of the existing management plan and to include the West Marsh property as part of the update, taking into account the unique property ownership mandates for each of the properties.

A request for proposals was prepared that required the services of a consultant to complete the following:

- Summarize the biophysical and land use information collected since 2004 and coordinate the update of relevant mapping with the City of Nanaimo GIS department;
- Highlight what has been achieved in meeting the original management objectives and recommendations, and identify gaps and shortfalls in the existing plans implementation;
- Expand the scope of the management plan to include the West Marsh and Valley Oak Parks, while recognizing the unique ownership mandates of the properties; and,
- Provide recommendations for immediate actions for the next three to five years.

Madrone Environmental Services have been working on the update since April 2015 and are expected to provide a draft management plan for review later this fall. In order to receive greater public input, City staff will review the revised plan with ACES and will seek input on the process and the recommendations received.

# ENVIRONMENTAL PLANNING AND DEVELOPMENT:

- Met with BC Hydro's Power Smart Sustainable Communities Manager to review current community energy efficiency programs with the City and to prepare a longer term work plan and partnership. A fall workshop with staff is currently being planned to identify specific opportunities to partner with Building Inspections and Planning and Design in implementing existing policies and developing new programs and incentives within the development process.
- Currently working with the Nature Trust of British Columbia Lands Manager and Madrone Environmental Services in a review and update of the Buttertubs Marsh Management Plan. Met in August to review draft maps and to give the consultant further guidance. Draft plan is anticipated in October 2015.
- Ongoing research into designing the process for the City's Environmental Framework

# DEVELOPMENT APPLICATION REVIEW & DEVELOPMENT REFERRALS:

- Received four development permit area and one subdivision application for review.
- Attended two follow up property site visits for ongoing development permit applications.

# PROJECT / PROGRAM DEVELOPMENT:

- <u>Goose Management Program</u>: Met Guardians of Mid-Island Estuaries to discuss goose management practice in the Mid-island area and to discuss organizing a technical workshop on goose management practice in the Province and on Vancouver Island.
- <u>Knotweed Awareness Program</u>: City of Nanaimo, Parksville, and Qualicum Beach continue to receive calls and requests from homeowners, reporting Knotweed in the City. The information was passed onto the Coastal Invasive Species Committee (<u>http://www.coastalisc.com/</u>). 19 knotweed sites from 2014 have been re-treated. Up to 20 newly identified sites are expected to be treated in 2015.
- <u>Invasive Plant Management Program</u>: Provincial Permits have been applied for to remove knotweed from the bank of the Millstone River near Bowen (West) Field.
- <u>Vancouver Island Beggartick Plant Recovery Program:</u> Currently one site seeded with Beggartick seed and a second site has been prepared to research canary reed grass control. Another research plot will be prepared this fall in Third Street Park.
- <u>Brechin Boat Ramp Upgrade</u>: Environmental assessment and review of Parks Operations boat ramp upgrade project.

• Currently enrolled in online courses to obtain Certificate in Community Energy Management through the <u>Community Energy Association</u>.



New Oil to Heat Pump Incentive Program for B.C. Homeowners

**2 Sept 2015, Victoria, BC** - Up to \$1,700 per home is available to help British Columbians upgrade from oil heating to efficient electric air source heat pumps through the Oil to Heat Pump Incentive Program.

The program is funded by the B.C. Ministry of Energy and Mines' Innovative Clean Energy (ICE) Fund and administered by City Green Solutions, a non-profit energy efficiency organization.

"With the cooler weather of fall and winter approaching this is an excellent time for homeowners to think about investing in enegy efficient heating solutions. Incentives of up to \$1,700 to upgrade from oil heat to electric heat pumps will make it easier for British Columbians to lower their heating bills and reduce household greenhouse gas emissions," says Bill Bennett, Minister of Energy and Mines.

"An oil to heat pump upgrade is one of the most important things we can do to reduce greenhouse gas emissions from existing homes. Participating homes' typical carbon reductions will be better than taking a car off the road for 15 years," explains Glenys Verhulst, Oil to Heat Pump Program Manager.

"Heat pumps are very efficient home heating systems because they use only a small amount of electricity to move a large amount of heat, to provide comfortable temperatures in the home year-round. An oil to heat pump upgrade will reduce a typical home's energy bills by \$1,300 to \$2,700 every year, and will eliminate the risk of costly damage to air, soil, and waterways from home heating oil leaks," adds Verhulst.

To qualify, homeowners must install a qualifying central or mini-split heat pump and remove their oil tank and oil heating system. Incentives are available on a first-come, first-served basis while funds last.

The Innovative Clean Energy (ICE) Fund is designed to support the B.C. government's energy, economic, environmental, and greenhouse gas reduction priorities and advance B.C.'s clean energy sector.

## Background

 A heat pump system typically pays for itself in energy savings quickly and can deliver a return on investment of 20 - 39%.

- Cleanup costs from home heating oil spills typically range from \$65,000 to \$118,000, are the responsibility of the homeowner, and are generally not covered by home insurance.
- Heating oil spills can be environmentally damaging. Oil can contaminate soil and water; harm or kill fish, pets, and other animals; and pollute air in the neighbourhood.
- Heat pumps provide comfortable, clean, and affordable heating and cooling year round.
