(c) Environmental Services Report – December 2014 – April 2015.

2589 Kenworth was a development site that was cleared without permits in place. The developer was fined and charged with 19 different counts of tree removal. He subsequently contested this and a Court date was set; however, 3 days before Court the developer plead guilty to 10 counts of tree removal and 1 count of entering a setback area and paid the fines associated to these charges.

Green Lake water sampling for E-coli was undertaken. Residents were on septic systems two years ago and then City put in a pump station for connection to sanitary sewer system. 77 out of a possible 99 properties have connected into the new sewer system in the Green Lake area. There is only 1 residence on the lake that has not applied for a permit to connect.

Beaver Dam management – Richard's Marsh. In November the dam shifted and plugged the culvert – with appropriate regulatory approvals the dam was moved to allow for flow through the culvert while maintaining water levels in the Marsh. The dam was not removed. Recently water levels have dropped again and that is being investigated. There is regular maintenance in Divers Brook as there are 3 dams there. All work is done with Provincial approval. Council passer a "no rapping" bylaw for City properties. The habitat is being managed without removel of the beavers or the dams.

Brechin Boat Ramp – enforcement was looking at user conflicts at the ramps. A user group Committee has been formed by the Parks, Recreation and Environment Department.

# RE: THE BLUE DOT PROJECT & THE DECLARATION ON THE RIGHT TO A HEALTHY ENVIRONMENT

#### STAFF RECOMMENDATIONS:

That the Advisory Committee on Environmental Sustainability provide staff with input and recommend that Council endorse the declaration of "The Right To A Healthy Environment", as amended.

#### PURPOSE.

To provide ACES with a report on the following:

- Assess the process of pertinent communities who have adopted the Blue Dot initiatives;
- Review existing City and community policies and initiatives and how they relate to the Blue Dot initiatives; and
- Identify a process to address the Blue Dot initiative in the context of the City and community of Nanaimo's current and future policies and initiatives.

#### BACKGROUND:

On 2015-MAY-11, the Finance and Policy Committee of the Whole received a delegation from Paul Manly, and Trevor Greene, requesting that the City of Nanaimo pass a municipal declaration respecting people's right to live in a healthy environment. This declaration is based on The Suzuki Foundation's Blue Dot Project (<u>http://bluedot.ca/#the-plan/</u>) to have the right to a healthy environment added to the Canadian Charter of Rights and Freedoms. One objective of the project is to have municipalities across Canada aspire to adopt the declaration "The Right To A Healthy Environment" and through local governments, encourage provinces to adopt these resolutions to fulfill the requirements for a change in the Federal charter of rights and freedoms.

After the delegation spoke, Council made the following motion:

"...... that Council refer the "Right To A Healthy Environment Declaration" document to the Advisory Committee on Environmental Sustainability as well as to Staff for comment and that ACES and Staff report back to Council within two months."

#### **DISCUSSION:**

The Blue Dot Project's declaration has been presented to a number of communities across British Columbia. The following table lists pertinent communities on Vancouver Island, the Lower Mainland, and the Interior of British Columbia that have received delegations and made decisions on whether or not to support the declaration for a healthy environment.

While many communities have adopted the declaration, the majority also recognized the environmental programs, policies and initiatives they already have in place but felt it was still support the overall effort to see a set of rights to a healthy environment added to the Charter. Communities that decided not to adopt the declaration felt there communities already had done significant work and felt it was not necessary to adopt the Blue Dot Declaration.

Many of the City of Nanaimo's policies are consistent with the Blue Dot Movement's Municipal Declaration. Also relevant is Nanaimo's participation in regional programs that address greenhouse gas emissions reduction and drinking water quality.

These policies and directives include the City of Nanaimo's Corporate Strategic Plan, Official Community Plan, Corporate Climate Action Plan, Community Sustainability Action Plan, Transportation Master Plan, and Urban Forest Strategy. The City is also a signatory to the Provincial Climate Action Charter and a member of the Federation of Canadian Municipalities Partners for Climate Protection.

The City has also implemented a number of programs and initiatives as a result of the direction from these over-arching policies, including:

Within Parks, Recreation and Environment:

- Establishing over 631 hectares of City Parks;
- Over 140 kms of trail; and,
- Zoning the majority of parks as Natural Parkland.

Within the City's Buildings and Facilities:

- New and renovated City buildings require working towards LEED standards for design and construction under the City Green Building Policy;
- The Energy Conservation and Management Policy sets energy efficiency conservation targets for all buildings; and,
- Through the City's Purchasing Power Delegation Bylaw 2013 No. 7175, staff are asked to consider the economic, social and environmental impact of purchasing choices for the City.

Within the City's Vehicle Fleet:

- The City has purchased Hybrid and Electric vehicles;
- Diesel vehicles now use a biodiesel blend in City vehicles; and,
- Anti-idling techniques are included in City staff driver training.

Within the Engineering and Public Works Department:

- A street asphalt-recycling program has been in place for over 10 years;
- A Ditch-infill Policy was developed to handle requests to fill in open ditches. A review is now required that balances each request with the merits of retaining the ditch as a permeable swale for environmental benefit;
- An expanded curbside recycling and food waste collection program; and,
- A review and update of the stormwater section within the Manual of Engineering Standards and Specifications to more effectively utilize rainfall as a resource through engineered storm features; rather than as a waste product.

Through the City's Green Incentive Programs:

- Toilet Rebate Program home owner rebates for purchasing water efficient toilets;
- Woodstove Change-out Program home owner rebates for purchasing more efficient burning woodstoves;
- Clothes Washer Rebates home owner rebates for upgrades to more energy efficiency appliances; and,
- Real Estate Energy Efficiency Program Incentives for Realtors who complete energy efficiency awareness training.

Beyond the City of Nanaimo's many policies, directives, programs and initiatives, the greater community of Nanaimo has been active in spearheading and maintaining a wide range of environmental initiatives and programs that complement the many City initiatives. These include, but are not limited to:

Local and Safe Foods Programs:

- Foodshare programs;
- Community Gardens;
- Farmers Markets (on the increase annually); and,
- 7 to 10 Club, and Loaves and Fishes.

Environmental Stewardship and Land Protection Initiatives:

- Nanaimo & Area Land Trust;
- Georgia Strait Alliance;
- Neighbourhood stream keeper and habitat stewardship groups; and,

 Voluntary neighbourhood stream and land clean-ups by groups and individual residents.

**Recycling Initiatives:** 

- Nanaimo Recycling Exchange; and,
- Regional Recycling.

Both the Corporate Strategic Plan and planNanaimo (the City of Nanaimo's Official Community Plan) provide an overarching vision and direction for Council and the community on a variety of land use issues, including protecting the natural environment.

Staff supports the intent of the Blue Dot Project Declaration. However, staff feel additional reporting and evaluation commitments will require extra committee and staff time without adding measureable benefit to our local community and environmental outcomes. Implementing the proposed declaration will add more work to provide accountability that is accomplished through other programs and measures.

The Advisory Committee for Environmental Sustainability recognizes that there is an opportunity to set a clearer community vision on the environment. As endorsed in the ACES work plan, environmental policies and programs will be assessed within a Community Environmental Framework process that showcase to the public the progress made to date on improving our environment and help identify areas to focus on in future. In addition, this process can help provide direction for becoming a 'greener' community and will assist council in determining its strategic priorities for the environment.

A separate report will be prepared and forwarded for consideration that will outline the process and seek Council endorsement.

Given this proposed approach, Appendix A provides a revised declaration, with Section 5 of the declaration outlining a set of objectives for completing the environmental framework. Appendix B is the original Declaration as presented on 2015-MAY-11.

#### <u>APPENDIX A</u>

## DRAFT DECLARATION OF THE RIGHT TO A HEALTHY ENVIRONMENT FOR NANAIMO

WHEREAS the David Suzuki Foundation Blue Dot Movement has inspired many Canadians to request that the right to a healthy environment be enshrined in the Charter of Rights and Freedoms through support of the following motion;

AND WHEREAS the City of Nanaimo understands that people are part of the environment and that a healthy environment is inextricably linked to the well-being of our community;

AND WHEREAS the City's Strategic Plan of Council and Official Community Plan (planNanaimo) provides a strong policy foundation to pursue actions and initiatives that contribute toward a healthy environment;

AND WHEREAS the City of Nanaimo has the opportunity to show support for the application to include the Declaration of the Right to a Healthy Environment within the Federal Charter of Rights and Freedoms, joining other Canadian cities in reaffirming our commitment to social, environmental and economic sustainability;

THEREFORE BE IT RESOLVED THAT the City of Nanaimo shows support by endorsing the following declaration:

That all people have the right to live in a healthy environment, including:

- The right to breathe clean air;
- The right to drink clean water;
- The right to consume safe food;
- The right to access nature;
- The right to know about pollutants and contaminants released into the local environment;
- The right to participate in decision-making that will affect the environment.

The City of Nanaimo has the responsibility within its jurisdiction and capacity under the *Community Charter* to respect, protect and promote these rights;

The City of Nanaimo will apply the precautionary principle; where known threats of serious or irreversible damage to human health or the environment exist, The City of Nanaimo will take reasonable and cost effective measures to prevent the degradation of the environment and protect the health of its citizens. Lack of full scientific certainty shall not be viewed as sufficient reason for The City of Nanaimo to postpone such measures.

The City of Nanaimo shall apply full cost accounting; when evaluating reasonably foreseeable costs of proposed actions and alternatives, the City of Nanaimo will consider costs to human health and the environment.

By December 31, 2016, the City of Nanaimo will complete a Community Environmental Framework and assess its current environmental objectives, policies, programs, targets, timelines and actions within its jurisdiction and determine a community environmental vision for itself. This process will include a review of options to:

- Ensure equitable distribution of environmental benefits and burdens within the municipality;
- Ensure infrastructure and development projects follow a 'No Net Loss' approach in protecting the environment including air quality;
- Confirm the City addresses Climate Change by reducing greenhouse gas emissions and implementing adaptation measures;
- Continue to follow the direction of the Official Community Plan in encouraging density through a node and corridor approach;
- Prioritize walking, cycling and public transit as preferred modes of transportation;
- Ensure adequate infrastructure for the provision of safe and accessible drinking water;
- Promote the availability of local and safe foods, and ongoing food security and sustainability practices and programs;
- Further reduce solid waste and promote recycling and composting, with a goal toward reaching a universally accepted Zero Waste target;
- Establish and maintain accessible green spaces in all residential neighbourhoods;

The City of Nanaimo shall review these objectives, targets, timelines and actions on a regular basis, and evaluate progress towards completing and maintain the City's Community Environmental Framework.

The City of Nanaimo will work together with residents to further develop and promote this community as a "green community" that is a preferred visitor destination and location for new residents and businesses seeking such a community.

The City of Nanaimo shall consult with residents as part of this process.

#### APPENDIX B

## City of Nanaimo Declaration The Right To A Healthy Environment

Whereas the **City of Nanaimo** understands that people are part of the environment, and that a healthy environment is inextricably linked to the well-being of our community;

The City of Nanaimo finds and declares that:

1. All people have the right to live in a healthy environment, including:

The right to breathe clean air

The right to drink clean water.

The right to consume safe food.

The right to access nature

The right to know about pollutants and contaminants released into the local environment.

The right to participate in decision-making that will affect the environment

- 2. The City of Nanaimo has the responsibility, within its jurisdiction, to respect, protect, fulfill and promote these rights.
- 3. The City of Nanaimo shall apply the precautionary principle: where threats of serious or irreversible damage to human health or the environment exist, the City of Nanaimo shall take cost effective measures to prevent the degradation of the environment and protect the health of its citizens. Lack of full scientific certainty shall not be viewed as sufficient reason for the City of Nanaimo to postpone such measures
- 4. The City of Nanaimo shall apply full cost accounting: when evaluating reasonably foreseeable costs of proposed actions and alternatives, the City of Nanaimo will consider costs to human health and the environment.
- 5. By Dec 31st 2016, the City of Nanaimo shall specify objectives, targets and timelines and actions the City of Nanaimo will take, within its jurisdiction, to fulfill residents' right to a healthy environment, including priority actions to:
  - Ensure equitable distribution of environmental benefits and burdens within the municipality, preventing the development of pollution "hot spots";
  - Ensure infrastructure and development projects protect the environment, including air quality;

- c. Address climate change by reducing greenhouse gas emissions and implementing adaptation measures;
- d. Responsibly increase density;
- e. Prioritize walking, cycling and public transit as preferred modes of transportation;
- f. Ensure adequate infrastructure for the provision of safe and accessible drinking water;
- g. Promote the availability of safe foods;
- h. Reduce solid waste and promote recycling and composting;
- i. Establish and maintain accessible green spaces in all residential neighbourhoods.

The City of Nanaimo shall review the objectives, targets, timelines and actions every five (5) years, and evaluate progress towards fulfilling this declaration.

The City of Nanaimo shall consult with residents as part of this process.

6. And be it further resolved that the MUNICIPALITY call on the Province of British Columbia to enact a provincial environmental bill of rights to fulfill the right of every resident to live in a healthy environment by supporting favourable consideration of this matter at the Union of BC Municipalities 2015 Convention.

#### ENVIRONMENTAL PLANNING AND DEVELOPMENT:

- Site meeting with SFN to review stream restoration proposal for Departure Creek and to discuss trail maintenance within District Lot 56 (East Linley Valley).
- Held site meeting with City staff and consultants on removing knotweed from a 8 meter stretch of shoreline along the Millstone River in Bowen Park. Removal and restoration plan currently being prepared.

#### **DEVELOPMENT APPLICATION REVIEW & DEVELOPMENT REFERRALS:**

- · Four development permit/rezoning referrals received and reviewed.
- One property site visit to assess its suitability for park purchase.

#### PROJECT / PROGRAM DEVELOPMENT

- <u>Real Estate Energy Efficiency Program</u> REEP Team met with Vancouver Island Real Estate Board (VIREB) to request the Energuide Rating be added to the VIREB MLS Listings. Request currently being considered. Currently seeking support to expand the training program for Realtors to other local movements in the VIREB region.
- <u>Invasive Plant Management Program</u> Invasive Plant Awareness Month Working with Nanaimo Broom Busters provided support for 12 volunteer broom cutting events. Two "Drop Zone" invasive plant drop off sites in Bowen Park. Currently working with Coastal Invasive Species Committee (<u>http://www.coastalisc.com/</u>) on launching a Knotweed Awareness Program in the City from June to November 2015.
- <u>Vancouver Island Beggartick Plant Recovery Program</u> Parks Operations staff met with FLNRO Species at Risk Coordinator onsite and prepared the first research site. Beggartick seed planted both onsite and in the City greenhouse to build up seed stock for planting in the fall.
- Bike to Work Week (BTWW) As part of the Bike to Work Organization Committee, helped organize and host the BTWW Kick Off "Commuter Challenge" at Bowen Park; Nine Celebration Station sites at different locations in the City; and, the BTWW Finale event in Beban Park.


