ADVISORY COMMITTEES TERMS OF REFERENCE

(adopted 2010-JAN-25)

The following Terms of Reference apply to all Advisory Committees of the City of Nanaimo unless otherwise noted.

Appointment and Term

The member(s) of Council will be appointed annually by motion of Council.

Other members will be appointed for a three-year term commencing April 1st in the year following a general local government election *(does not apply to PNAC)*. At-large members will be appointed by Council. Council will ratify appointments of members recommended by their specific associations.

Members of the Committee will serve without remuneration.

Chair

The Committee will elect the Chair annually at the first meeting following April 1st from amongst its members.

Meeting Procedures

All points of procedure not specifically provided for in these Terms of Reference shall be decided and determined in accordance with the current Council Procedure Bylaw.

Except where the provisions of the *Community Charter* apply, all Committee meetings shall be open to the public. Where the Committee wishes to close a meeting to the public, it may do so by adopting a resolution in accordance with the *Community Charter*.

The order of business is to be as set out in an agenda package to be provided to Committee members in advance of the meeting date. All decisions of the Committee will be reached by consensus or a majority vote of the members present.

Minutes of the meeting will be adopted by the Committee at its next regular meeting. After adoption, minutes will be circulated to Council for their information. Originals of the minutes will be signed by the Chair of the Committee and forwarded to the Legislative Services Department for safe keeping.

Reporting to Council

The Committee may report to Council on any issue within its mandate or other issues as requested by Council.

The Committee Chair will present recommendations of the Committee to Council for their consideration.

<u>Budget</u>

The annual budget of the responsible department will include funds for the operation of the Committee.

Staff Support

Staff support will be determined by the City Manager or his/her designate. Typical support functions include the following:

- Organizing and preparing the agenda, in conjunction with the Committee Chair;
- · Distributing the agenda packages to Committee members;
- · Taking and preparing draft minutes;
- Managing the files of the Committee, as necessary;
- Maintaining a list of outstanding issues for Committee action;
- In conjunction with the Chair, drafting Committee reports to Council;
- Provide professional advice on issues discussed by the Committee;
- Other duties as authorized by the City Manager or his/her designate

6. **DELEGATIONS:** (10 MINUTES)

(a) Delegation request by Joanne Sales, and Judy Broserio, BroomBusters Invasive Plant Society, regarding the 2015 season.

Ms. Sales provided a PowerPoint presentation on the removal of broom. BroomBusters would like the City to demonstrate a desire and commitment to remove broom in the City. They request that the City consider establishing a Bylaw to ensure that property owners take responsibility for broom removal on their property. Ms. Sales will provide a copy of the Parksville Bylaw, which covers all invasive plants and noxious weeds, for the Committee.

\$20K in funding is available in the City's Invasive Plant Management Rogram budget. Some funds can be allocated to coordinate pick up sites be sites need to be identified in advance. There is currently no Bylaw in place; however, the Development Services Division does not allow clear cutting to happen prior to development. The City's Property Maintenance Bylaw also requires homeowner's to prevent noxious weeds from encroaching onto neighbouring roperties.

It was noted that there is a heavy growth of ivy a ross from the Beacon (possibly Port Authority Property). Richard Harding advised hat Mike Davidson should be contacted to determine if this is City property and whether it is covered under the maintenance contract.

Invasive plant month is May, and there is a possibility of also having one in the fall. Staff to consider how to increase media awareness of invasive plants and will return to the Committee with a strategy.

It was moved and seconded that the delegation be received. The motion carried unanimously.

Legislative Services and department staff have begun the process to notify, by way of public advertisement, all NGO groups and members-at-large that the City is seeking applications from individuals and nominations by groups for membership on the ACES due to the expiry of current member terms on 2015-MAR-31. Letters have been sent to the Chamber of Commerce, School District 68, Vancouver Island University, and the Snuneymuxw First Nation for their nominations.

9. **STAFF REPORTS:**

(a) ACES 2015 Work Plan R. Lawrance, Environmental Planner

Purpose: To obtain ACES's and Council's approval on the 2015 Work Plan.

Staff advise that the major piece of work will be the environmental framework.

Staff will also review the possibility that a Watercourse Habitat Compensation Bank can be developed for the City. This would be a useful tool where development has limited room to do restoration on site. Developer and provide funds to be utilized for other watercourse restoration projects within a defined area, such as the same watershed.

Committee members expressed concern with the concept of a compensation bank – feeling that all streams are connected and to componise a part of the watercourse compromises all of it. Further conversations bout what would qualify for the bank still needs to take place. It would not be about to be used lightly – a fairly high bar would need to be set. Suff would discuss with other communities for their input. A suggestion was made that staff look at fish values and water qualities and have other agencies avolved (for example DFO) in the development of such a program.

UBCM - Committee members asked i staff would be attending and addressing changes that have been made. Staff to look into attendance and presentation.

Committee members felt that there should be a section in the work plan that would cover "Programs/policies to be monitored and promoted." (In the interest of not losing sight of past committee initiatives – ex. Pesticide use Bylaw.)

Committee requested that headings to be grouped and carried over to the new work plan.

Re: the Pest de Bylaw Education - Committee members expressed concern that pesticide use and the Bylaw product sheets are not readily available at supply outlets. Perhaps they could be bigger or have a larger sign with tear

(b) Review of The Woodstove Changeout and Burn It Smart Programs R. Lawrance, Environmental Planner

Purpose: To review the regulatory options for managing smoke from wood burning appliances and report back to the Committee with recommendations.

<u>Staff Recommendations:</u> That the Advisory Committee on Environmental Sustainability recommend that Staff:

- 1. review the City of Nanaimo's Burn It Smart educational material with woodstove retailers and report back to the Committee with recommendations on improving the program;
- 2. work with Bylaw Services and Building Inspections and reurn with recommendations on developing a woodstove appliant bylaw for the City of Nanaimo; and,
- 3. review the existing Woodstove Change-out Program and explore opportunities to include low / no carbon energy change outs and report back to the Committee with recommendations.

Committee members requested that recommendation to be amended to read "work with Bylaw Services and Building Inspections to determine if a City of Nanaimo woodstove appliance bylaw of other enforcement mechanisms are appropriate or required and return to the committee with recommendations; and."

Committee members suggested that staff also work with VIHA regarding policies on emissions/air quality.

The Committee was revised that if the Fire Department is clear that if it is a safety issue, they will address it.

Within B.C. 42 local governments have specific Bylaws.

It was moved and seconded that the recommendations, as amended, be adopted. The motion carried unanimously.

RE: RESTORATION PLAN FOR VANCOUVER ISLAND BEGGARTICKS (Bidens amplissima)

STAFF RECOMMENDATION:

That the Advisory Committee on Environmental Sustainability receive this report for information.

PURPOSE:

To receive for information, a plan to conduct restoration trails for Vancouver Island Beggarticks in Third Street Park.

BACKGROUND:

Vancouver Island beggarticks (*Bidens amplissima*) is an annual plant that grows in a variety of wetland habitats including ditches, willow wetlands, old riverbeds, pond margins, streamsides, bogs, and tidal or non-tidal river edges (Klinkenberg and Klinkenberg 2001). Preferred habitats are usually sunny, have water levels that fluctuate from high in the winter and spring to low in the summer, and are used as resting and preening areas by waterfowl, which are probably the main dispersal agents (Ganders *et al.* 2002a). The species is a Pacific Northwest endemic, found only in southwestern British Columbia and northwestern Washington (Ganders *et al.* 2002b). In British Columbia, it is primarily found on southeast Vancouver Island and in the Lower Mainland, which as of 2008 supported more than 85% of the species known global range (Klinkenberg 2008).

The species was designated as Special Concern in 2001 by the Committee on the Status of Endangered Wildlife in Canada because of declines in populations and its restricted distribution (Klinkenberg and Klinkenberg 2001). It was subsequently listed as Special Concern in Canada on Schedule 1 of the *Species at Risk Act* in 2003 (Government of Canada 2014a). The British Columbia Conservation Data Centre listed the species as vulnerable (S3 - uncommon) in 2008 and it was subsequently placed on the Province of British Columbia's Blue list (British Columbia Conservation Data Centre 2014). Under British Columbia's Conservation Framework, Vancouver Island beggarticks ranks as priority 1 under goal 1 (contribute to global efforts for species and ecosystem conservation) and goal 2 (prevent species and ecosystems from becoming at risk) (British Columbia Conservation Data Centre 2014). The primary threats to

Vancouver Island beggarticks include competition from non-native invasive plants (e.g., reed canarygrass (*Phalaris arundinacea*) and purple loosestrife (*Lythrum salicaria*)), mowing, infilling of wetlands by development and alteration of hydrological regimes (Vancouver Island Beggarticks Working Group 2014).

DISCUSSION:

A management plan for Vancouver Island beggarticks was prepared in March 2015, which outlines the status of the species, threats to its survival, and management goals, objectives, and actions for recovery (Vancouver Island Beggarticks Working Group 2015). Two of the recommended management actions in this plan are to 1) prepare site specific restoration plans to mitigate threats associated with this species and 2) test techniques and the feasibility of restoring and reintroducing the species in suitable habitat by establishing and monitoring experimental populations. To help achieve the above management actions for the species, a restoration plan was prepared for Jingle Pot Marsh, an ecosystem within Third Street Park where Vancouver Island beggarticks previously existed naturally.

Jingle Pot Marsh is located in the City of Nanaimo on southeast Vancouver Island, British Columbia. Vancouver Island beggarticks was first recorded at this location in 2001, with the last documented occurrence of a naturally occurring plant in 2007. Habitat loss through development activities, competition from native and non-native plant species, and a lack of disturbance are the main factors that have contributed to the extirpation of the species. Efforts to reintroduce the species following its extirpation were tried but failed to result in the re-establishment of sustainable populations.

A working group on Vancouver Island Beggartick Restoration from the Ministry of Forests, Lands and Natural Resource Operations (FLNRO) met with City staff and visited Jingle Pot Marsh in September 2014 to discuss and collect information for this restoration plan. Six sites were assessed for the presence of Vancouver Island beggarticks and their potential to restore the species. One historical re-introduction site was found to support one small flowering plant and other possible small plants that were believed to be Vancouver Island beggarticks, but no plants were found at other sites assessed. Three of the six sites had moderate to high restoration potential, one had low to moderate potential, and two had low potential (See Appendix 1 for air photos identifying the sites). The main threat to the species and its habitat at Jingle Pot Marsh is competition from non-native, invasive plant species, particularly reed canary grass (*Phalaris arundinacea*) and it was agreed that research on methods to control this plant would be a secondary focus of this project.

Funding and in-kind support has been offered by FLNRO, who have applied and received funding through the provincial Land Based Investment Strategy (Species at Risk). A funding proposal has also been sent to Environment Canada under its National Wetland Conservation Program. We are currently waiting to hear confirmation that the proposal has been approved.

One of the first steps needed is to increase the amount of viable seed for the proposed research plots. Beginning in the spring of 2015, the working group would like to work with the City to prepare two sites (defined as "south wetted area" and "west ditch" in Appendix 1) for planting of existing seed for the purpose of seed harvesting later in the fall. In the fall of 2015, research plots would be prepared for treating canary reed grass on two additional sites ("south marsh" and "east pond" in Appendix 1).

At this stage, we would like to inform the Committee of this restoration plan and confirm that it contributes to meeting the goals of the Management Plan for the Vancouver Island Beggarticks in British Columbia, the City of Nanaimo's Invasive Species Management Strategy, and the Jingle Pot Marsh Vegetation Management Plan. In addition, this plan could provide a template for the development of additional restoration plans and actions for the species and for reed canary grass control at other sites. The City of Nanaimo, British Columbia Ministry of Forests, Lands, and Natural Resource Operations, and Vancouver Island University will be working together as stakeholders to work collaboratively to implement this restoration plan.

This restoration plan will be reviewed and revised, as necessary, after the 2020 growing season to ensure restoration activities are working effectively to achieve stated goals and objectives.



ENVIRONMENTAL PLANNING AND DEVELOPMENT:

• Initial meeting to discuss the review and update of the online City of Nanaimo Habitat Atlas. Text and graphics currently being prepared.

- REEP website now online (http://www.vireb.com/reep). Held two meetings with Realtors at the Nanaimo Golf Course and the Grand Hotel to provide an update and congratulate 45 realtors who have completed training through the REEP program. Currently completing educational videos and planning for a second round of realtor training, beginning in April 2015. Held follow-up meeting with Vancouver Island Real Estate Board to discuss forward planning for REEP and for including the Energuide Rating on the MLS listing.
- 2015 Woodstove Change-out Program began 2015-JAN-05. To date, 26 rebates have been issued.
- Met with Parks staff to discuss re-establishing a tree donation program. Draft program plan reviewed by staff and currently being prepared for final adoption.
- Continuing with the density bonus review for green design in Schedule D of Zoning Bylaw 4500. Currently reviewing existing categories and points system.
- Working with the Buttertubs Marsh Management Plan Committee to begin an update of the Plan that includes consolidation of all conservation lands under one plan within the marsh complex area. Completed a Request for Proposals process and have hired a consultant to complete the plan update.
- Working with the Nanaimo Estuary Management Committee to complete a plan review and revised work plan for the Committee. Currently looking into creating a part time coordinator position to work with committee partners in implementing management plan actions.
- Helped support and attend Wetland Conservation in Eastern Vancouver Island: A workshop for municipal and regional stakeholders, sponsored by the BC Wildlife Federation.
- Arranged for an information meeting with planning staff and the energy manager for Island Health to discuss potential low carbon heating system alternatives for the existing heating boilers at the Nanaimo Regional General Hospital.

DEVELOPMENT APPLICATION REVIEW & DEVELOPMENT REFERRALS:

- Nine development permit/rezoning referrals received and reviewed.

- Attended staff corporate energy management review with BC Hydro.
- Attended presentation by Doug White on the Tsihqot'in Court Decision and the significance of the Douglas Treaty.
- Attended VIU presentation on climate change information labels on gas pump nozzles. Presentation was made by Robert Shirkley from Our Horizon (<u>ourhorizon.org</u>).
- Supervised three volunteer invasive plant removal events involving ivy removal from trees and removal of ground ivy from a test area in Bowen Park.
- Organized and participated in a Plant Salvage event that transplanted over 50 sword fern plants to a site in Piper's Lagoon Park.
- Arranged for space and attended Nanaimo Car Share Coop AGM.
- Working with Bike to Work Week Planning Committee. Involved in events planning and coordination for Bike to Work Week Nanaimo (https://www.biketowork.ca/nanaimo).
- Meeting with Snuneymuxw First Nation Executive Director and his staff to discuss collaboration on environmental restoration projects. Follow-up site visits with Parks staff being arranged.
- Parks Operations Tailgate Meeting held for new and existing staff on City environmental topics (watercourse setbacks, trail maintenance, invasive plant management, goose / beaver management issues).

VOLUNTEERS IN PARKS (VIP) PROGRAM:

 Playground start up meetings were held at Janes Park and Jesters' Way Park in February 2015. Both groups made presentations to the Parks and Recreation Commission on 2015-APR-22 and were approved for \$30,000 and \$25,000 respectively from the VIP Program.

- Staff are working with the neighbors around Broadway Park to re-initiate a VIP project at this site. The group has fundraised about \$15,000 for this project.
- Staff have met with the Nanaimo Community Gardens Society on several occasions to plan
 for the implementation of their greenhouse at Beban Park. A VIP grant of \$25,000 was
 awarded to this project in 2012. The group is moving out of their site at the RDN sewage
 treatment plant in August 2015.
- Site finishing will continue in 2015 at the newly installed Groveland Park and Hawthorne Park playgrounds. Landscaping and installation of benches and picnic tables is still required. The neighbourhood will help to plant the new trees for Hawthorne Park.
- The Westdale/Leslie Crescent Park Neighborhood Committee worked with staff to facilitate
 their visioning and assist in their proposal development. The Committee presented their
 proposal to the Parks and Recreation Commission on 2015-APR-22 and was approved for
 \$30,000 from the VIP Program.
- Invasive plant removal was carried out by the Stephenson Point and South End Neighbourhood Associations and Samaritan House, as well as at Bowen Park and Pipers Lagoon Park, in the late fall of 2014.
- More invasive plant removal work parties underway throughout the City. Currently promoting "Invasive Plant Awareness Month" through local media and the City webpage (www.nanaimo.ca/goto/invasives).
- Restoration projects at Janes Park were completed with the further removal of blackberry and reseeding of the area.
- Information requests about the VIP park improvement process have been made by neighbors in Sherwood Forest and Protection Island.
- The proponents of the Westwood Lake Picnic Shelter have met with an interdisciplinary staff team to discuss the details of their building permit and development permit applications as well as budgeting and moving their proposal and project forward.
- Hosted an annual VIP Appreciation Luncheon to thank volunteers in the VIP program. Staff
 provided a short presentation on the Invasive Plant Management and Plant Salvage
 Programs. RCMP also provided a short presentation on park safety.


