Why a Strategic Plan?

RDN has a long history of Strategic Planning by the Board

first Plan developed in 1994

brought strong policy and priority focus to the RDN = results and success

part of the reason the RDN has outperformed other RD organizations



Why a Strategic Plan?

Process and Plans have developed incrementally over time as they have been considered by subsequent Boards

each Board has developed a unique plan

some underlying "genetics" – long term focus

renewed approach again for the 2016-2019 Plan



Why a Strategic Plan?

Set the direction for the present term of office.

Establish individual and collective priorities.

Identify critical goals (priorities) for staff to work toward (actions) – part of the Board's role as policy and decision-making

Mission - The mission of the Regional District of Nanaimo Board is

To enhance the environmental, social, and economic well-being of the residents and communities in the region by providing services that are best delivered on a cooperative, region-wide basis;

Provide a range of community services in unincorporated electoral areas;

Act as the Local Government for the region's electoral areas.

In fulfilling this mission, the Regional District of Nanaimo plays two major roles:



Mission

1 To facilitate the development of collaborative strategies and plans to guide the provision of services, including but not limited to the:

- Regional Growth Strategy
- Official Community Plans
- Solid Waste Management Plan
- Liquid Waste Management Plan
- Drinking Water/ Watershed Protection Plan
- Regional Parks, Trails and Recreation Planning
- Transit Future Plan
- Community and Corporate Energy and Emissions Plans
- Emergency Preparedness Plan



Mission

2 To deliver a wide range of services at the community, subregional, and regional levels to support the implementation of these plans:

- Create, maintain, and enforce regulations for land use and buildings
- Provide solid waste collection and disposal services
- Operate wastewater collection and treatment facilities
- Operating drinking water, stormwater, and streetlight utilities
- Acquire, establish and maintaine regional and community parks and trails
- Operate recreational facilities and deliver programs



Mission

- Deliver public transit service
- Provide fire and emergency services
- Work with stakeholders to address regional housing affordability
- Measure, monitor, and report on performance

Action Areas

The five Action Areas reflect each of the RDN departments. The actions provide a balance between specific and general direction to RDN staff tasked with planning for and administering the region's broad range of services.

Strategic and Community Development

- Nanaimo Airport planning project continued
- Ongoing implementation of Agricultural Area Plan
- Secondment of Senior Planner to support liaison activities with First Nations
- Ongoing implementation of RGS Targets and Indicators, Reporting...
- Amend RGS clarification of 'Minor Amendments' and process
- Implementation actions from Housing Action Study
- Monitoring and Adaptation report progress on RDN strategic priorities
- Administer Northern Community Economic Development funding program
- Ongoing implementation of Green Building Action Plan incentives, outreach workshops Green Building Guidebook series





- Downtown Transit exchange Land acquisition (\$1.0 million) and Design (\$150,000)
- Service Plans for proposed expansion 5,000 hrs, 2015/2016 (\$145,000 2015)
- Ongoing work with VIU of Transit Service improvement and future Upass
- Ongoing work with First Nation on provision of handyDart services to community
- RDN Solid Waste Management Plan review
- Ongoing operational and fee changes arising from revenue reduction
- Capital program relocations, berm improvements, closure process... (\$2.0 million from reserves)
- Ongoing support for SW non-profit activities (NRE, School Education, waived fees) (\$340,000 2015)



Regional and Community Utilities

- GNPCC Outfall replacement (\$13.5 million 50-50 DCCs and reserves)
- GNPCC Secondary Treatment 2015 projects (\$3.5 million 50-50 DCCs and reserves)
- Rural Village Sewer Servicing EAs 'A' (DPPCC capacity), and 'H' Village Centre treatment plant design (\$350,000 Regionally Significant Gas Tax Grant funding)
- Asset Management project focus (4 treatment plants, 22 pump stations, >60km main collection trunk, 8 community water systems, 1 water treatment plant...)
- DWWP watershed monitoring network, rebates and educational programs, TeamWatersmart...





Recreation and Parks

- 12 Regional Parks, >70 km regional trails, >2,000 Ha of land
- 11/12 with Management Plans in place implementation projects Benson Creek Falls RP (Ammonite Falls) – Access and geotech review for stair project (\$55,000), (\$350,000 construction)
- Parksville to Coombs/Parksville to Frech Creek, E&N Trailway Project Design and Construction (\$2.6 million Regionally Significant Gas Tax Funds)
- E&N Trailway development in CoN (\$150,000 funds transfer)
- Morden Colliery RT Nanaimo River Bridge crossing and Trail approach design project (\$100,000 Funded by EA 'A' Community Works grant funding)
