Dear Grants Advisory Committee,

We are appealing our grant, Youth Sticking Together - Quality Foods Worlds Longest Hockey Game which was denied back in the beginning of July.

The two reasons we were given for the denial were Evident of Management and Fiscal Responsibility and Potential financial impact.

The financial impact to our City during our event was the parents and players whom came from out of town. The game had 13 players from the Victoria area and two from the Duncan area.

The players during the event stayed at the Nanaimo Curling Centre, however every player stayed at the Howard Johnston on the night of the 12th, then again for a celebration night on August 30th.

During the event we had a handful of parents/girlfriends who stayed in Nanaimo at hotels/ate in Nanaimo.

Total of 15 of our 40 players were from out of Nanaimo; while our Nanaimo players had family and friends come in to watch.

Our budget was based on previous attempts, however we did find that our food budget was lower then expected at first however several trips were made to Costco/Quality Foods during the game to pick up more supplies and we believe we executed our Marketing Plan to a tee.

The coverage of our city from a local level was covered in all the papers, radio stations and TV Networks, which then went to a wider audience CFAX 1070, CBC News Victoria/Vancouver/Toronto, Global News, BC1, Fox Sports, CBC TV, This Hour Has 20 Minutes and many other newspapers across Canada.

This event attracted over 1500 unique visitors during it's five day course and the three goals were met from a Committees and Players Stand point, the record was broken, money was raised for charity and the youth helped make a difference in our community by standing up to help out.

We hope you reconsider your grant application decision and help us present more money to our charities of choice.
