STAFF RECOMMENDATION:

That Council approve the appointment of Marcia McNeil for the balance of a three year term, ending August 2015, as the City's legal advisor relating to labour law.

PURPOSE:

To obtain Council approval to appoint Marcia McNeil as the City's labour lawyer.

BACKGROUND:

On August 13, 2012, Council appointed Heenan Blaikie as the City's legal firm in relation to labour law services. The appointment was for a 3 year term (to August 2015) with the option of 2 one year extensions.

The appointment of Heenan Blaikie was the result of a Request for Proposal. In its response to the City's Request for Proposal, dated July 12, 2012, Heenan Blaikie named Ms. Marcia McNeil as the primary labour lawyer assigned to the City. Ms. McNeil had been the City's labour lawyer prior to her joining the firm.


Ms. McNeil has recently advised that she is leaving the firm of Heenan Blaikie, effective August 31, 2013. She will be practising law under her own name, at least temporarily.

DISCUSSION

Marcia McNeil has been the primary labour law advisor for the City since November 2007 when her firm at the time (Fuller Pearlman) was appointed by Council. She has extensive experience in the areas of labour, employment and human rights law. City staff have developed a good working relationship with Ms. McNeil and have been satisfied with her work to date.

Ms. McNeil advises that there will be no change to her legal fees (\$275/hour). In order to ensure proper back-up, she has arranged for two of the partners at Heenan Blaikie (Susan Arnold and Peter Sheen) to provide labour advice in the event she is unavailable. These individuals had been originally named in the Heenan Blaikie proposal as "secondary lawyers" to the City. Their services will continue to be provided at the same hourly rate as for Ms. McNeil.

STAFF RECOMMENDATION:

That Council direct staff to proceed with the required Statutory Notification for Development Variance Permit No. DVP00215 at 5030 Banning Court.

PURPOSE:

The purpose of this report is to seek Council authorization to vary the provisions of "ZONING BYLAW 2011 NO. 4500", in order to permit the location of a heat pump to the side yard of a single residential dwelling and vary the side yard setback from 4.5 m to 4.4 m from the side yard lot line.

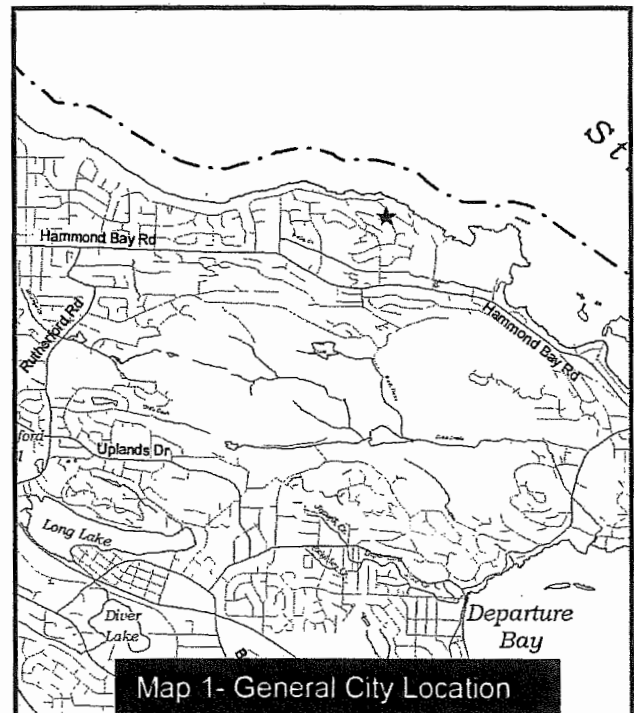
BACKGROUND:

A development variance permit (DVP) application was received from Richardson Homes Ltd. (Mr. Brad Richardson), on behalf of Mr. Paul Heising and Ms. Judith McFatridge, to vary the provisions of the City of Nanaimo "ZONING BYLAW 2011 NO. 4500" to permit the siting of a heat pump within the side yard.

Statutory notification must take place prior to Council's consideration for the approval of the variance.

Subject Property

The subject property, located at 5030 Banning Court, is included within a bare land strata subdivision. The property is included within the Townhouse Residential (R6) zone and is designated as Neighbourhood within the Official Community Plan (OCP). Given the bare land strata tenure of the property, in which the owner owns the surrounding property but the lot is accessed off a common strata road as opposed to a City road, the subject property is essentially a single dwelling residential lot.

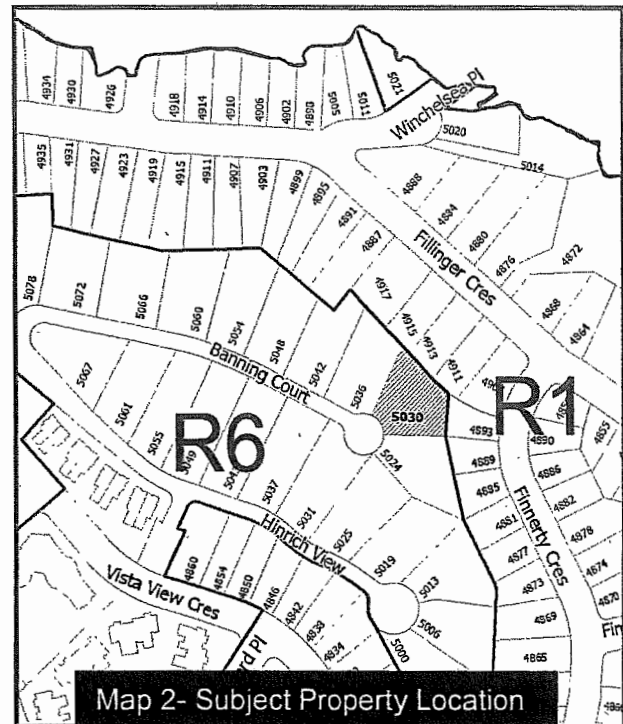

The surrounding area is entirely low density residential with neighbouring bare land strata properties bordering the subject property along both side lot lines, and fee simple single dwelling residential lots bordering the property along the rear lot line. The subject property includes a recently constructed single residential dwelling which was built on a steep slope, which runs downhill approximately 16 m from the front yard to the rear.

Board of Variance

The applicant has previously applied to the Board of Variance (BOV) to permit the placement of the heat pump within the side yard. At the meeting of 2013-JUN-20, the variance request was denied as a result of a 2-2 tie vote. The Board members who voted against the appeal did not believe the request to be a hardship.



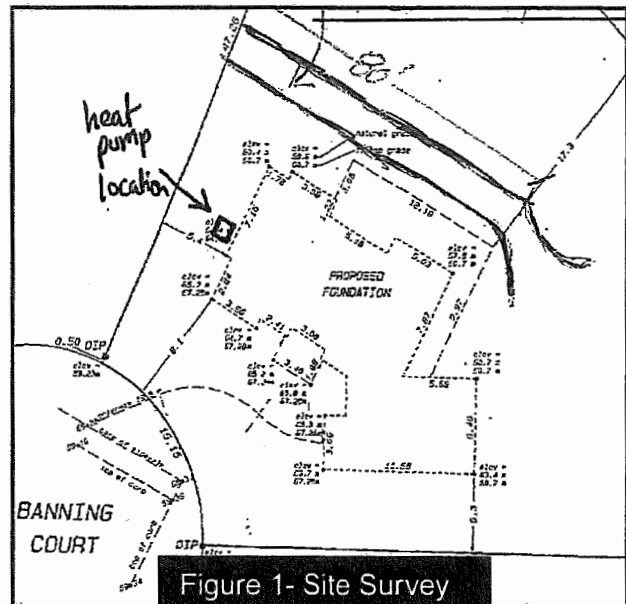
The BOV is required to find that undue hardship would be caused to the applicant if the bylaw was complied with. When considering whether or not to approve a DVP application, Council is not required to consider hardship.

An applicant who has been previously denied by the BOV is entitled to apply for a DVP for the same or a similar variance request. This should not be considered an appeal to the BOV decision, but as a separate application which may be deliberated on accounting for different criteria.

DISCUSSION:

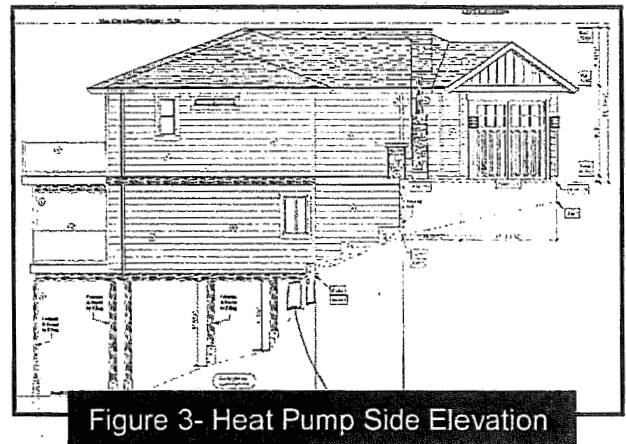
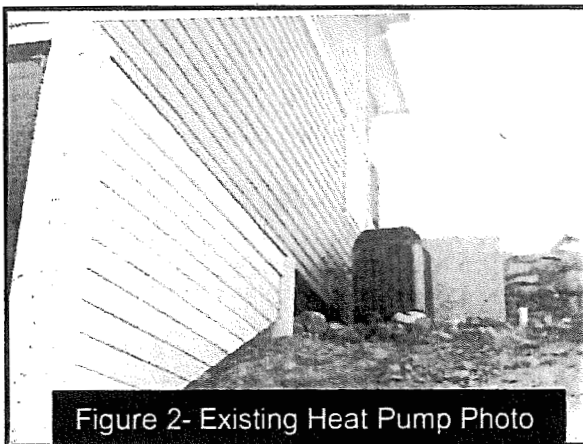
Proposed Development

The existing single residential dwelling under construction includes a recently installed heat pump within the north-western side yard 4.4 m from the property line that borders the property at 5036 Banning Court. The property owners at 5036 Banning Court



had previously indicated they have no concerns with the existing heat pump location or the requested variance to allow it. The heat pump is located behind a retaining wall and therefore is not visible from the road. A site survey indicating the location of the heat pump is included as Figure 1.

The dwelling itself was designed on pillars so that it is open underneath the two storeys. The applicant has advised that locating the heat pump within the rear yard, as required by the zoning bylaw, would result in greater noise disturbance for the property owner, as well as the neighbouring residents on Finnerty Crescent to the rear of the subject property. There are 2 to 7 foot high retaining walls in the rear yard area as shown on Figure 1 (Site Survey). A picture of the existing heat pump location is shown below as Figure 2, and northeast elevation drawing (the side the heat pump is located on) is also included as Figure 3. A photo of the rear of the building is included as Figure 4.



Applicants Rationale

A copy of the applicant's letter of rationale is included as Attachment A.

Required Variances

Section 6.5.2 of the City's Zoning Bylaw requires that where the principal use of a property is a single residential dwelling, heat pumps must be located to the rear of a principal building and shall not be closer than 4.5 m from the side lot lines. The proposed heat pump is located in the side yard and is 4.4 m from the side yard property line. A variance is required to permit the placement of a heat pump within a side yard and reduce the required side yard setback from 4.5 m to 4.4 m, a variance of 0.1 m.

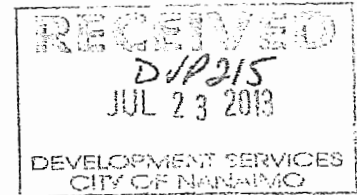

VARIANCE RATIONALE FOR HEAT PUMP LOCATION

APPLICANT: Mr Brad Richardson (Richardson Homes Ltd) on behalf of Mr Paul Heising and Ms Judith McFatridge

CIVIC ADDRESS: 5030 Banning Court



LEGAL DESCRIPTION:

STRATA LOT 22, DISTRICT LOT 51, WELLINGTON DISTRICT,
STRATA PLAN VIS6310, TOGETHER WITH AN INTEREST IN
THE COMMON PROPERTY IN PROPORTION TO THE UNIT
ENTITLEMENT OF THE STRATA LOT AS SHOWN ON FORM V

RATIONALE:

- The relocation of the heat pump to the back of our home would have a substantial negative impact on the residents of Fillinger Crescent with respect to operating noise and visual appearance.
- The residents of Fillinger Crescent granted us a one time access to the "Private Road" at the back of the lot in order to build our house. If our relocated heat pump would require servicing, we may not be able to obtain access permission from the residents at Fillinger Crescent.
- The heat pump is presently located at the side of our house with a retaining wall in front of it, to present good curb appeal to other homes in our Strata development.
- The owners of the home next to us, 5036 Banning Court, have signed a document stating that they do not oppose the current location nor do they find it a hindrance.
- Relocating the heat pump from its current location would go from being a non-issue to residents to a negative effect on several homes outside of our Strata.
- Due to the steep slope of the lot and the associated challenges for the maintenance of the heat pump, we believe that the present unit location is the best comprise taking the impact to other residents adjacent to our home into account.

RE: PACKAGING AND PRINTED PAPER - FINANCIAL INCENTIVES

STAFF RECOMMENDATION:

That Council:

- a) accept, in principal, the financial incentives offered by Multi-Material British Columbia for the collection of residential packaging and printed paper;
- b) authorize staff to negotiate an agreement with MMBC for a three year term.

PURPOSE:

This report provides information on the Province of BC Packaging and Printed Paper Stewardship Plan, its associated financial incentives as offered by the stewards of the plan - Multi-Material British Columbia (MMBC), as well as the impacts on City operations and client services.

BACKGROUND:

In May 2011, the BC Government amended the BC Recycling Regulation to include packaging and printed paper (PPP) generated by the residential sector. This amendment shifts the responsibility for managing these materials from existing collectors like local governments to producers. Stewardship assigns cradle to grave responsibility for the packaging they produce. It is intended to improve the recovery of PPP, incent producers to incorporate environmental considerations into the design of products, and ultimately generate less waste.

Under the Regulation, producers of PPP were obligated to submit a stewardship program plan to the province by November, 2012. Industry representatives subsequently created a not-for-profit agency, MMBC to develop and implement the plan by May 2014. Throughout this process, staff from the City and the RDN have been providing input, including through UBCM.

In November 2012, MMBC submitted an initial draft stewardship plan to the Province. The draft plan outlined the financial incentives to qualified collectors and processors of PPP and proposed that local governments be given right of first refusal to become qualified collectors. A formal response to the draft Plan was prepared by RDN and City Staff and communicated back to MMBC, through the RDN Board. On April 15, 2013 the government approved the MMBC stewardship plan

On June 17, 2013 Nanaimo staff received an offer letter along with a sample contract document from MMBC. Responding to the letter will signal whether the City is interested in continuing to provide residential collection services for PPP. No obligation is created by the letter or by the City's response. A response to the offer letter is required by September 16, 2013.

DISCUSSION:

The following is a discussion of the contents of the MMBC offer and its impacts on City operations and on our clients. The City's recycling program provides service to over 26,000 households, from single family to 4-plex. Each individual household, including suites would have MMBC's incentive applied.

MMBC Offer

The MMBC stewardship plan and associated funding has an implementation date of May 19, 2014. The contract term is fixed at three years as is the annual payment per residence. Businesses serviced by the City do not qualify for the MMBC benefit.

The MMBC incentive offer to the City is \$35.25/ residential household/year, and is made up as follows:

- \$32/year/ household serviced,
- \$0.75/household/year for public education and promotion associated with MMBC sponsored curbside recycling service,
- \$2.50/household/year to cover administration associated with MMBC sponsored curbside recycling service.

One condition of the offer is that residential clients receive a reduction of \$35.25 in their Garbage and Recycling User Fee, which will effectively pass the monetary benefit of the offer back to the residential client. The City does not have the option to use the revenue to fund other recycling programs. Business properties will continue to pay the full user fee.

RDN has received a very similar offer and will soon be seeking Board approval to proceed.

Financial Implications

The MMBC offer will result in just over \$900,000 annually in revenue to the City. This amount slightly exceeds the cost to the City of the recycling program, which includes the contract, administrative and public promotional support costs. From a financial perspective, staff views the offer at approximately break-even.

Based on Council's acceptance, and as the MMBC program starts midyear, the 2014 City Budget will be prepared anticipating prorated funding.

Changes to Customer Service

Garbage and food waste services remain unchanged.

Residents will notice modest changes in the recycling service provided. All materials will be picked up in a single container, with newspapers no longer required to be separated. Film type plastic such as shopping bags will no longer be collected at the curbside. Additional materials, not currently collected will be added to the service and include tetra-pak and gable-top containers, plastic and paper drink cups, and aerosol containers. Some of the fibre containing items like gable-top containers (milk cartons) and paper drink cups are also allowed in the household food waste stream. Residents may choose either method of disposal. Styrofoam, film plastic and glass must be taken to a drop off facility.

Changes to Program Administration

Under this program, the City becomes the collection service provider on behalf of MMBC through our current recycling contractor BFI Canada Inc. Staff have met with BFI and gone over the additional tracking, monitoring and reporting of PPP collection performance requirements as specified by MMBC. The final extension of the BFI contract which runs until March 31, 2015 was negotiated reflecting the City's best efforts at recognizing the potential MMBC impact. BFI's fee schedule may be adjusted if some minor administrative issues remain unresolved with MMBC.

In addition to the province wide promotion of the new program by MMBC, the City will provide advance and ongoing public education on the anticipated changes to service.

Municipal Solid Waste Collection Bylaw 2011 No. 7128 will require amendments resulting from this program. These are updating the materials collected and a new and separate user fee for business clients.

Outstanding Issues to Resolve with MMBC

Staff have identified a number of minor items yet to be resolved with MMBC. These include: the provision of curbside bags, timing for review and adjustment of the serviced household count on which payment is based, and performance targets including contamination levels and associated fines. There are also administrative obligations for tracking, record keeping and reporting mechanisms required for customer service interactions. These will need to be more tightly defined. Staff will work to resolve these issues prior to MMBC's September 16th submission deadline.

CONCLUSION:

MMBC is offering the City of Nanaimo a financial incentive of \$35.25 per year for each household serviced with recycling services and a response to MMBC is required by September 16, 2013. Should the City decline the offer, MMBC will initiate a process to set up its own collection services. Staff recommends that the City communicate its intent to participate by responding to the offer letter, recognizing that no legally binding or enforceable obligation or relationship is created by the MMBC letter or the City response. Staff will continue to pursue issues that require definition, clarification or negotiation, but consider MMBC's offer supportable and do not foresee any irresolvable issues.


Should the process proceed and result in MMBC providing the City a formal agreement, final acceptance and authorization must be approved by Council.

RE: 2013 SEWER RELINING

STAFF RECOMMENDATION:

That Council receive this report for information.

PURPOSE:

In accordance with the City's Purchasing Policy, this report is to advise Council of a public tender call of \$250,000 and above.

DISCUSSION:

This tender will reline existing asbestos cement sewers in the Cilaire and Beach Drive neighbourhoods, and on Albion Street. These sewer mains were identified to be in poor condition through the City's ongoing sewer video program. Relining rather than open cut excavation was chosen as most of the sewers are in backyards with significant existing structures and mature landscaping. The location of the work is shown on the attached map.

Work is expected to commence in October and be completed in November. The sewer relining will only impact the local area residents. Residents have already been contacted about the work on their properties and will receive project notices prior to construction starting.

The engineer's estimate for this tender, including contingency is \$500,000.



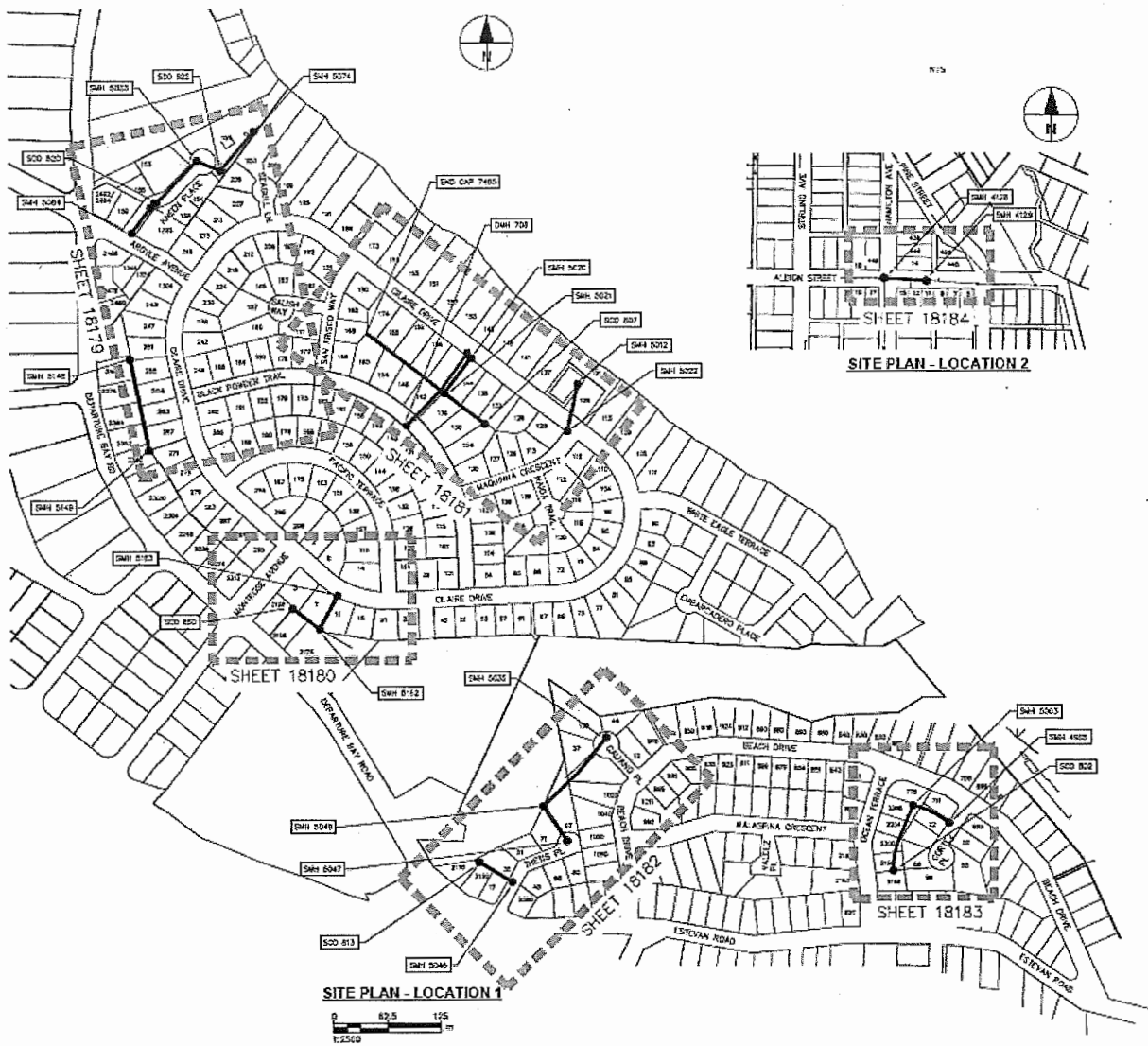

Dear Mayor Ruttan and Council,

I am the spokesperson for Stop The Great Lakes Nuclear Dump, a non-profit organization formed by a group of citizens who are deeply concerned about an important National issue: Ontario Power Generation (OPG) plans to build a nuclear waste repository to bury radioactive nuclear waste right beside the Great Lakes, 21% of the world's fresh surface water and the source of drinking water for 40 million people in two countries. The Great Lakes are a precious National treasure. Public hearings on this project commence on September 16, 2013 and approval could occur by the end of the year.

I am writing to you today to encourage the City of Nanaimo to join other cities and municipalities in Canada and the US that are taking action to oppose this ill-advised plan.

There are many reasons why the City of Nanaimo should be concerned about OPG's plan, namely:

- This nuclear waste dump will need to safely house the most lethal waste ever created by humans – radioactive nuclear waste, some of which remains toxic for 100,000 years.
- No scientist or geologist can provide a 100,000 year guarantee that this nuclear waste will not leak and contaminate the Great Lakes.
- A nuclear waste dump in limestone is unprecedented and unproven anywhere in the world.
- Despite the availability of land under Ontario government ownership and control (87% of Ontario's land mass is crown land), and despite the fact that OPG is wholly owned by the Province of Ontario, OPG did not consider or investigate any other sites for this nuclear waste repository.

You should know that opposition to OPG's plan is growing daily.

Our organization launched a petition that to date has gathered more than 19,000 signatures, including signatories from every Province and Territory in Canada, every US state, and 65 countries of the world. **Outside of Ontario, our largest number of petition signatories reside in BC; people in 116 BC cities and towns, including the City of Victoria, have signed our petition.** Various environmental groups are actively opposing OPG's plan. You should also know that concerned politicians in Canada and the US are passing resolutions formally opposing this nuclear waste dump.

We believe that the residents of Nanaimo deserve to know about this issue and have an opportunity to speak out for the protection of this precious National treasure.

I am writing to you today to ask the City of Nanaimo to consider formally expressing its opposition to OPG's plan and to speak out for the protection of the Great Lakes. If the City of Nanaimo were to consider passing a resolution about this issue, this would send a clear message to Canada's Minister of the Environment, Leona Aglukkaq that British Columbians view the Great Lakes as an important national resource that must be protected.


We wish to bring to your attention some of our reasons for asking you to support the resolution for GE Free BC which is being presented to the UBCM this September.

Dear *Ms. Rattan*,

This letter requests your support for the resolution on genetically engineered (GE, also known as GMO) crops and animals at the 2013 UBCM Convention. The resolution reads:

"that UBCM ask the British Columbia government to legislate the prohibition of importing, exporting and growing plants and seeds containing genetically engineered DNA, and raising GE animals within BC, and to declare, through legislation, that BC is a GE Free area in respect to all plant and animal species."

Serious concern has been expressed across BC about genetically engineered crops and animals. To date: 12 municipalities have passed individual resolutions declaring themselves a GE Free zone (Powell River, Salt Spring Island, Denman Island, Nelson, Kaslo, New Denver, Rossland, Richmond, Saanich, Metchosin, Telkwa, City of North Vancouver) and over 90% of voters in Area E and D of RDNO (Regional District of North Okanagan) have voted to be GMO Free. At the Association of Vancouver Island and Coastal Communities meeting in April 2013, the same resolution as above was adopted by 51 municipalities.

In addition the UBCM has endorsed four resolutions expressing concern about genetically engineered crops in 1999: concerning monopolization of our food supply, 2006 and 2009; concerning mandatory labeling; and 2012 concerning the GE apple.

My concerns about genetically engineered crops and animals are as follows:

Safety Questions

- GE crops are not an extension of traditional breeding methods (or hybridization), they are created by inserting new gene sequences into organisms, often from unrelated species.
- GE crops have not been demonstrated to be safe; the standards for judgment by the Canadian Food Inspection Agency (CFIA) and Health Canada are lax. When the CFIA reviews an application for a novel food, its "evidence" comes from the corporation making the application and this data is kept secret. There is no independent testing of GE crops or animals in Canada, so the bottom line is we don't know if these crops are safe or not.

Corporate Control

- GE crops are about making profits for companies, often large multinationals. Five agricultural biotechnology corporations now control most of the technology needed to develop GM crops, as well as the agrochemicals and crop germ-plasm and seeds.
- GE seeds are patented which allows companies to take control over living organisms.


Pollen Drift

- Contamination of non-GE crops by GE crops is inevitable
- Some species, such as canola, cross-pollinate more easily than others. If you are next to a farm growing GE canola it is impossible to grow non-GE canola because of contamination from GE pollen.
- The same is likely with some of the GE crops that have recently been approved or are now being developed, for example the GE alfalfa (recently approved) GE apple (under development). This will lead to significant economic loss for organic farmers, who use alfalfa as a rotational crop.
- Now GE alfalfa has been approved it will make growing conventional and organic alfalfa impossible over the long term.

There is consensus across British Columbia that we urgently need to consider other possibilities than GE crops, and to support farmers transitioning away from growing GE crops to sustainable farming practices.

I hope I can count on your support in this crucial matter, by voting in favour of GE Free BC.

HOW CAN I AVOID GM FOODS?

Our government does not require labeling.

But you can still make a choice:

1. Eating certified organic food is one way you can avoid GM food because GM is prohibited in organic farming. This includes organic dairy, eggs and meat because animals in organic farming are not fed GM grains like corn or soy.
2. You can avoid eating processed foods with corn, canola and soy ingredients.
3. You can buy cane sugar to avoid eating sugar from GM sugarbeets.
4. Support farmers who fight GM: buy food directly from farmers who do not plant GM corn, canola or soy or use GM grains for meat, dairy or egg production.

WHAT IS GENETIC MODIFICATION?

Genetic modification (GM) is recombinant DNA technology, also called genetic engineering or GE.

With genetic engineering scientists can change plants or animals at the molecular level by inserting genes or DNA segments from other organisms. Unlike conventional breeding and hybridization, the process of genetic engineering enables the direct transfer of genes between different species or kingdoms that would not breed in nature.

WHAT GM FOODS ARE ON THE MARKET?

Four GM crops are grown in Canada: **corn**, **soy**, **canola** and **white sugar beet** (for sugar processing). These are widely used as ingredients in processed foods. There is also now some GM sweetcorn on the market.

- GM papaya, cotton and some types of squash are grown in the U.S. and can be imported, mostly as processed food ingredients.
- GM Corn: Most of the GM corn grown in Canada is hard corn used for animal feed or processed food ingredients. There is now some GM sweetcorn sold in Canada.
- X GM Tomatoes: There are no GM tomatoes on the market anywhere in the world.
- X GM Potatoes: Monsanto took GM potatoes off the market because of consumer rejection.
- X GM Wheat: In 2004, Monsanto withdrew its request for approval of GM wheat in Canada and the US because of consumer and farmer protest. Monsanto has relaunched its GM wheat research.

ARE GM FOODS SAFE TO EAT?

We don't know what, if any, impacts GM foods could have on our health. There are many unanswered safety questions.

Many scientists warn that:

- The process of genetic engineering could create new allergens.
- Foreign DNA may be able to survive in the human gut.
- Animal feeding studies indicate liver and kidney problems.

GM foods are approved for human consumption based on company-produced science. The data is secret and is not peer-reviewed by independent scientists. Health Canada does not do its own testing. There is no mandatory labeling in Canada, and no tracking or monitoring of possible health impacts.

WHAT ARE THE ENVIRONMENTAL RISKS?

Once GM plants are released into the environment they cannot be controlled or recalled. Genetic pollution is irreversible living pollution that self-replicates. Contamination of other plants is a major problem because the genes from any crop can move, via seed and pollen flow. GM crops are resulting in increased pesticide use, herbicide tolerant weeds, and the expansion of industrial farming.

WHO OWNS GM SEEDS?

GM technology facilitates corporate control because patents on genetic sequences mean that corporations can own seeds. Monsanto is the largest seed company in the world and owns about 86% of GM seeds sown globally.
