**Purpose:** To permit the use of land for a **Personal Care Facility**

**Location(s):** 359 Nicol Street, shown on Map A

This bylaw, if adopted, will rezone the subject property from **Single Dwelling Residential (R1)** to **Community Service One (CS1)** in order to expand the adjacent **Personal Care Facility (Samaritan House)**.

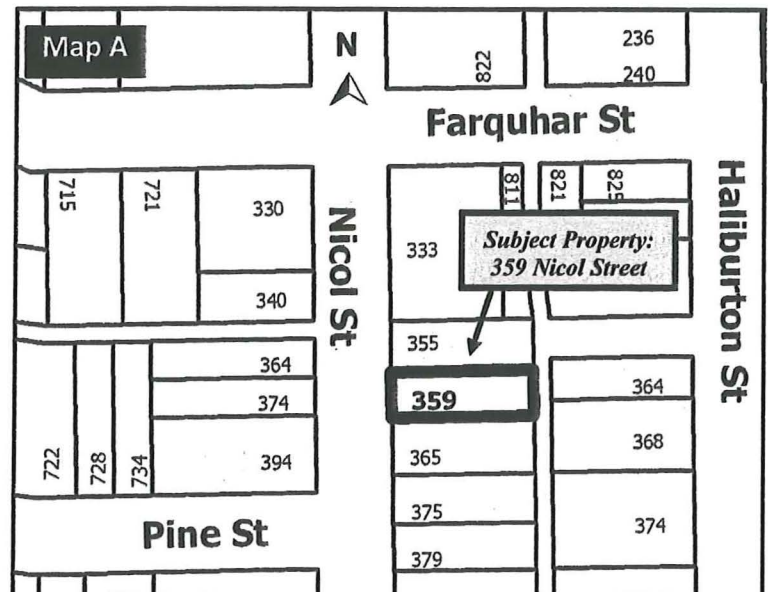

A BYLAW TO AMEND THE CITY OF NANAIMO "ZONING BYLAW 2011 NO. 4500"

---

WHEREAS the Council may zone land, by bylaw, pursuant to Sections 890, 891, 903 and 904 of the *Local Government Act*;

THEREFORE BE IT RESOLVED the Municipal Council of the City of Nanaimo, in open meeting assembled, ENACTS AS FOLLOWS:

1. This Bylaw may be cited as the "ZONING AMENDMENT BYLAW 2013 NO. 4500.043".
2. The City of Nanaimo "ZONING BYLAW 2011 NO. 4500" is hereby amended as follows:

By rezoning the lands legally described as LOT 2, SECTION 1, NANAIMO DISTRICT, PLAN 6091 EXCEPT PART IN PLAN VIP51696 (359 Nicol Street) from Single Dwelling Residential (R1) to Community Service One (CS1) as shown on Schedule A.

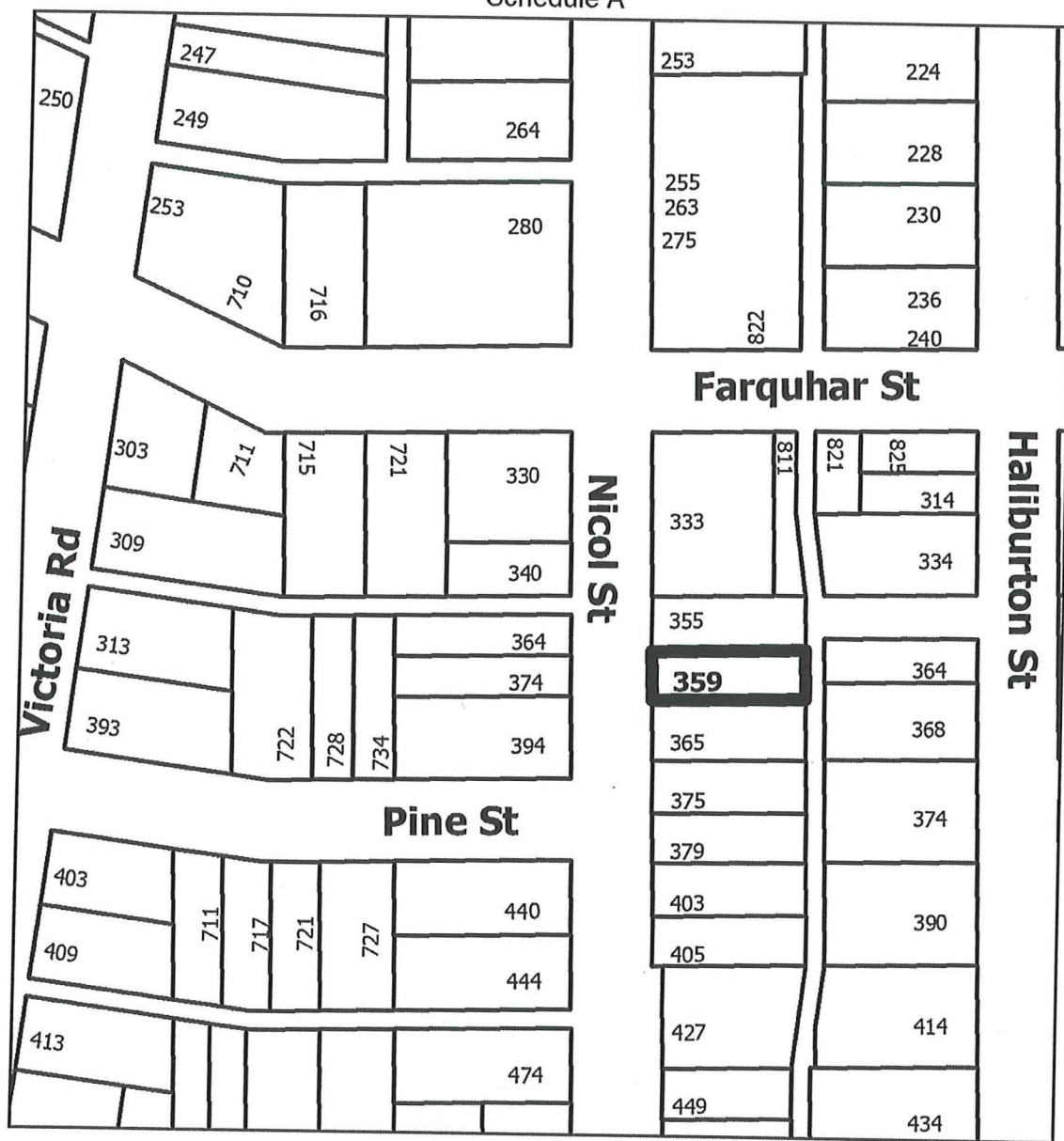
