7. NEW BUSINESS

 a) Applications received for the first round of 2012 Community Service grants were reviewed. Because of a perceived conflict of interest, E. Forrester vacated the meeting room when the St. Andrew's Presbyterian grant application was discussed.

Some of the Committee's comments were:

- Much of what is being requested is the responsibility of senior government, and could be considered downloading.
- The Nanaimo Men's Resource Centre should contact the John Howard Society regarding men's suits that were donated to the Society.
- G. Anderson left the meeting at 6:05 pm.
- St. Paul's Anglican Church, Island Crisis Care Society, and the Nanaimo Men's Resource Centre should work together. Some of their programs appear to overlap.
- SPAC should consider making a recommendation to City Council that they
 include a line item in their budget for food provision funding based on a per
 capita assessment.
- Schools receive funding for food from the Province based on how they fall on the vulnerability scale.
- If St. Paul's Church is awarded a grant, it should be targeted to specific programs around creating community.
- The grant application evaluation table should be amended to add a "suggested grant amount" column, and a column to rate each application as high, medium or low priority.
- SPAC should have a discussion at their September meeting re systemic issues.

- Having a representative from VIHA would provide a route to systemic change.
- Suggest inviting a VIHA representative to SPAC meetings as needed, and discuss the issue in question at the beginning of the meeting.
- Would like a VIHA representative to be a full-time member of SPAC, as much of what SPAC considers is aligned with health in some way. Would also provide an opportunity for SPAC to be apprised of VIHA funding opportunities.
- Consider having a VIHA representative as an ex-officio member. Being
 employees of the Province, they might have a conflict of interest if they were a
 voting member, which could skew discussion around the SPAC table.
- The difference with the School Board member on SPAC is that the School Board representative is not an employee of SD68.
- A VIHA representative could be a conduit and relay SPAC's message back to their organization.
- VIHA wants to participate on SPAC. They want to build a relationship with the City, and this would be a good place to start.

It was moved and seconded that Jan Tatlock, Director, Community Programs, Public Health & CYF Services for VIHA be invited to attend SPAC meetings as an ex-officio member, and that the seat be reviewed in future to consider making it a full member. The motion was carried.
