

NANAIMO COMMUNITY HERITAGE COMMISSION (NCHC) HELD ON WEDNESDAY, 2012-APR-04 AT 5:00 PM AT CONFERENCE ROOM #1, CITY ANNEX (238 FRANKLYN STREET)

1. Call to Order

C. Sholberg explained that one of the individuals selected as an at-large representative on the Commission has decided not to accept the position. Legislative Services is currently arranging for a new at-large representative to be appointed to the Commission.

a) Beban House (W.E. Gard):

The Parks Department is currently considering two possible tenants for the building. The building's identified seismic issues would not be of concern to these tenants, as they would not require a change of use. An update will be provided when more information is available.

b) Plaque at the Modern Café (C. Meutzner):

C. Meutzner has been approached by the owner of the Modern Café, who is interested in having a plaque created and installed on the exterior of his building, similar to the plaque installed on the Free Press Building.

c) Morden Mine Support (J. Hofman):

J. Hofman noted that the Friends of Morden Mine (FOMM) have been lobbying senior government officials and MLAs at the Provincial forefront to lock down financial support for work identified in the Morden Mine Park site plan.

d) Letter to MLA Leonard Krog (C. Sholberg):

C. Sholberg noted that a letter was sent to MLA Leonard Krog, thanking him for attending the 2012 heritage summit and also for advocating the cultural and economic importance of the Morden Mine revitalization project at the BC Legislature.
