## 1. BYLAW NO. 4500.009


Purpose: To permit the use of land for two residential dwelling units.

Location(s): 2171 Salmon Road

File No.: RA283

This bylaw, if adopted, will rezone the subject property from Single Dwelling Residential (R1) to Duplex Residential (R4) in order to facilitate construction of two residential dwelling units on the lot.

The subject property is legally described as LOT 4, SECTION 11, RANGE 8, MOUNTAIN DISTRICT, PLAN VIP86807, and is shown on Map A.



### 2. BYLAW NO. 4500.010


Purpose: To permit the use of land for two residential dwelling units.

This bylaw, if adopted, will rezone the subject property from Single Dwelling Residential (R1) to Duplex Residential (R4) in order to facilitate construction of two residential dwelling units on the lot.

The subject property is legally described as LOT A, SECTION 16, WELLINGTON DISTRICT, PLAN VIP89167, and is shown on Map B.

# 3. BYLAW NO. 4500.011

Purpose: To permit the use of land for a small lot subdivision.

Location(s): 5341 Dunster Road

This bylaw, if adopted, will rezone the subject property from Single Dwelling Residential (R1) to Single Dwelling Residential – Small Lot (R2) in order to facilitate a two lot subdivision.

The subject property is legally described as LOT 1, SECTION 5, WELLINGTON DISTRICT, PLAN 23180, and is shown on Map C.


