Yes same for boxing and mma - \$50. per bout for refs and \$30. per bout for judges. For title fights refs get \$75. and judges \$50. and for international belts the refs and judges get whatever the rate is set by the international sanctioning body.

Hope that helps.

While I have your attention Ed - I think the CBF should stay as the sanctioning body for boxing and rejuvenate the sport of boxing in Canada. We have to have more dual meets (Edmonton vs. Calgary or Alberta vs. BC or BC vs Quebec whatever.) We also need international matches like Canada vs Mexico or whatever! If the CBF was a sanctioning body again, they could get into strategic planning and work to make the sport grow. Right now no one is showing the leadership needed - and the sport is slipping through our fingers.

As Commission members we are always struggling with different provincial approaches and tribal approaches and municipal approaches. We each have to deal with governments and have not taken advantage of what others have done before us on similar matters. What we also need is a federation of Canadian combative sports commissions so the actual staff of commissions can compare approaches, budgets, strategies, government Bylaws and statutes, staffing, benefits, sharing access to each others events, etc.

These two structures can work together - but I really think the CBF has to revitalize itself in terms of boxing before attempting to get involved with mma. Just my opinion, but one I have shared with Tim Dunlap and with Eric Hunter on more than one occasion.
