1. CALL THE OPEN MEETING TO ORDER:

The Regular Meeting of the Cultural Committee was called to order at 4:15 p.m.

2. INTRODUCTION OF LATE ITEMS:

3. ADOPTION OF AGENDA:

It was moved and seconded that the amended Agenda be adopted. The motion carried unanimously.

4. ADOPTION OF MEETING NOTES:

- (a) Meeting Notes of the Regular Cultural Committee Meeting held Wednesday, 2010-SEP-08, at 4:15 p.m., in the Bowen Park Complex Conference Room.

It was moved and seconded that the Meeting Notes be adopted as circulated. The motion carried unanimously.

5. DELEGATIONS: Late Delegation.

It was moved and seconded that the Late Delegation be permitted to address the Cultural Committee. The motion carried unanimously.

- (a) Mr. Brent Meunier, 5030 Lost Lake Road, Nanaimo, BC, V9T 5E4, speaking to the Cultural Committee:
- (i) in opposition to recommendation C in the Staff Report "City Purchase Of Temporary Public Art", page 140 on the 2010-OCT-13 Cultural Committee Agenda; and,
  - (ii) in support of public participation in the selection of one piece of art annually as previously endorsed at the 2010-SEP-08 Cultural Committee meeting.

Mr. Meunier provided a power point presentation on the Lake Cowichan program, and requested that the motion be adopted by the Cultural Committee as amended to read:

*"That the Cultural Committee recommends that the Parks Recreation and Culture Commission:*

- a) *Repeat the temporary art program in accordance with the request by the Nanaimo Art Gallery and as approved by the Cultural Committee motion of 2010 Sept 08 and the Parks Recreation and Culture Commission motion of 2010 Sept 22."*

It was moved and seconded that Item 8.(a) Staff Report "City Purchase of Temporary Public Art", be moved forward in the Agenda for discussion following the delegation presentation. The motion carried unanimously.

6. STAFF REPORTS:

(a) City Purchase of Temporary Public Art.

*Staff's Recommendation: That the Cultural Committee recommends that the Parks, Recreation and Culture Commission:*

- a) *keep temporary and permanent public art commissioning processes separate;*
- b) *repeat the temporary art program in accordance with the request by the Nanaimo Art Gallery and as approved by the Cultural Committee motion of 2010-SEP-08 and the Parks, Recreation and Culture Commission motion of 2010-SEP-22; and,*
- c) *consider commission of a permanent public art piece in accordance with the Community Plan for Public Art from the 2011 Funds.*

It was moved and seconded that the Staff recommendation be adopted with an addendum that consideration be given next year for expansion to both the permanent art and temporary art programs. Following discussion, the motion was withdrawn.

It was moved and seconded that the staff recommendation be adopted. The motion carried. **Opposed: Commissioner Lance.**

It was moved and seconded that in 2011 the Cultural Committee receive recommendations from staff on how to add permanent art to the City as selected by citizens. The motion carried. **Opposed: Commissioner Avis.**

7. COMMISSION REPORT: (Commissioner Pattje.)

(a) Vancouver Island Symphony Line Item Funding Request.

Commission adopted the recommendation that the Vancouver Island Symphony submit their request for approval of \$25,000 as a budget line item to the City of Nanaimo 2012 Budget.

(b) City Purchase of Temporary Public Art Pieces.

Commission was advised that the motion regarding this matter was intended to read:

"Cultural Committee's Recommendation: That the Parks, Recreation and Culture Commission:

- a) invite the Community to vote for their favourite piece of temporary public art each year; and further,
- b) recommend that Council approve the annual purchase by the City of that piece of temporary public art as selected by the community, for display as public art in the park."

Commission referred the matter back to the Cultural Committee for discussion at their next meeting. [Note: dealt with under Item 6.(a)]

It was moved and seconded that the Commission Report presented by Commissioner Pattje be received. The motion carried unanimously.






