Following my presentation in New Orleans on the need for Cmsns to regulate or ban amateur MMA, Bernie and I discussed the following example that we would like shared with the membership.

Shaine Clark Emmons 115-639 is issued a MMA id by Minnesota on 6-14-10.

Emmons fights on an amateur card in MINN. on 3-19 but does not get id'd. He fails to answer the bell for round two and gets suspended for 30 days for an injured leg.

Emmons is granted a pro. fight by MINN. on 4-23-10 with the prior noted fight being his only recorded experience.

On 4-23-10, Emmons is submitted via armbar in round one.

Emmons next fights in MINN. on 6-19-10 and is KO'd in round one.

Emmons is placed on a 60 day KO suspension and indefinite suspension pending medical clearance from MINN.

On 6-25-10, while still under both medical suspensions and just one week after the KO, Emmons fights in IOWA and gets KO'd in round two. Emmons fights in IOWA as an AMATEUR.

On 6-26-10, the very next night, Emmons goes to WISC. and fights as an AMATEUR and gets TKO'd, referee stoppage due to strikes, in round one.

Emmons gets TKO'd or KO'd three times in one week, twice while under medical suspension, and as an amateur while already having two pro fights.

Again, regulate or ban the amateurs!!!

I think that the "Red Flag" needs to come from the fighter's home jurisdiction, or the jurisdiction of his last sanctioned fight. So, if a fighter was licensed in Edmonton and then fights in Ft Mac, then Edmonton would revoke his license, and Red Flag him – also inform all the commissions he has had his license revoked. The next commission can't revoke anything because they have not yet licensed him. So the red flag has to come from a commission who issued him a license.

On an aside, I just had a letter forwarded to me (it was sent to an old email address) from the lawyer of the Ft McMurray promoter. You and Shirley (and I think a couple others) received it as well. I won't go into the contents, but I wanted to make a point. This is not to "sell" the CBF to everyone, but I point out that municipal and provincial commissions (which are an extension of their respective governments) are walking a fine line when dealing individually with other municipalities (in this case). I know the politicians and administrators cringe when one of their entities criticizes another jurisdiction. This is why the CBF is important. The commission in the CBF are at arm's length when it comes to these sorts of situations. It is the CBF that is sending the letters to the jurisdiction on behalf of all commissions in Canada – not naming any specific commissions. Food for thought.

Good point Ed - when you say "suspension" you then fall into the bylaw requirement to allow for an appeal,etc. which is a process in most bylaws, which brings with it other issues.

The problem with the red flag idea however, is knowing who is responsible to put the red flag on file if the unsanctioned fight was in another jurisdiction? You can't have people running around red flagging fighters in someone else's jurisdiction - too easy for the system to be abused. Everyone should only concern themselves with what goes on in their jurisdiction (meaning when such fighters want to come to your jurisdiction after being in an unsanctioned event.) It is doubtful organizers of unsanctioned events are going to cooperate - after all they are already running unsanctioned events! Organizers of unsanctioned events don't normally report to any data base about results or suspensions.

The issue needs proper wording - if medical "suspension" is an issue - then a "medical precaution" may work. In this jurisdiction our bylaw says we can revoke or suspend a fighter's license if it is "in the public good to do so". A medical precaution seems like a pretty good reason. Each person in their own respective jurisdiction has to find their own comfort level in dealing with these fighters when they come calling to your jurisdiction.

I believe that everyone's regulations, and what they can or cannot do may be different from jurisdiction to jurisdiction.

The problem with a one year suspension, is that legally, I don't think you can suspend a license beyond what you originally issued it for. If it was due to expire in April, you can't suspend it until October, because after April he doesn't have a license with you anymore. A medical suspension is a different issue. Most commission will honor a medical suspension, however, if a fight did not take place in your jurisdiction, and you did not see a fight or license the fighter for that match, I don't believe you can arbitrarily suspend him. If you have all the commissions on board, you can red flag these names on MMA, Llc, or Fightfax, with a notation for them to contact his home jurisdiction for more information before issuing a license. But I don't think you can issue the suspension in a fight not occurring under your jurisdiction.

I agree with the 60, 90 180 or 360 day moratorium on allowing them to fight in your jurisdiction (the longer the better until these guys learn), but I don't think it can be a suspension – I think it needs to be a move on your own commissions' part, to revoke his license and not issue a new license (if his old one has expired) and the red flag will notify other commissions of your actions and the reasons, and ask them to follow your lead and not issue a license.

I have a comment and food for thought for everyone.

My original suggestion to our Commission was to suspend for one year from the date of the event working on the premise as suggested in Ed's comments of suspending for one year. A further suggestion was to suspend to the term of the license and review if and when the license would be renewed. Our bylaw allows for suspension, revocation or refusal of a license as long as the penalty is very specific to the safety, health and well being of the combatant in question or the general public. I believe unsanctioned events where we can't trust the proper regulatory process has been undertaken to protect the combatants participating in the show falls into that mandate.

Talk around the table did not support something that long and there was suggestion to suspend for 60-days with full medical requirements. I am reporting back to our Commission next week on this matter for a final decision. At the end of the day, I will support what my Commission directs. But I would like to report back to my Commission that there is talk in the Alberta industry of making the suspensions stronger to send a very clear message.

My thought and suggestion is would everyone be willing to work on a 90-day suspension with full medicals? (Again, I think this is light but is more palatable than 60 days). The reason I am wanting to present this to my Commission is that a 60-day suspension is the minimum a combatant would receive for fighting on a sanctioned card for a KO suspension. Potentially it could be longer, dependent on the severity of the injuries and medial follow-up required. What would be the incentive to not take the unsanctioned show when combatant risks nothing more than what could be potentially assessed at a sanctioned show? (Other than having to provide full medical paperwork again - much of that has to be provided every 3 months anyway). Even 90 days may not be enough. 180??

I can tell all of you from speaking with a person who was directly impacted by our stand on this matter, he did not want to be suspended for a year because that was what was originally being discussed. It sent a very strong message and neither he or his manager wanted to have him fighting on an unsanctioned show or risk having him suspended for up to 1 year. I doubt they would want to even take a six month suspension.

I appreciate everyone's feedback and review of this suggestion.

I will also throw out this:

Often, commissions will require that a fighter show a valid license from their "home" commission before being licensed in their jurisdiction for a fight.

I don't know how every commissions' regulations are written, but perhaps a clause under licensing stating that anyone found to be fighting in an unsanctioned event shall automatically cause a revocation of their current license.

That would possibly eliminate some fighters from falling through the cracks. Additionally, of course, an email to all commissions (and MMA Plc and Fightfax – perhaps a "red flag" under his name?) stating the fighter has had his licensed revoked might also be of value.

Hi Ed:

Because of the concern of fighters fighting in unsanctioned events, and then showing up as a potential medical risk in our jurisdiction at a subsequent fight, we have adopted the following ECSC policy that, in a condensed version, goes something like this:

if a fighter competes in an unsanctioned event, their previous medical information is no longer considered valid by the ECSC for licensing to fight in Edmonton, following their competing in an unsanctioned event. Therefore to be licensed to fight in Edmonton after fighting in an unsanctioned event, a fighter has to redo their CT brain scan or MRI-brain, must redo their blood work, eye examination and ECG. In addition, since we have no way of knowing their post fight medical status, they are automatically given a 60 day "medical risk suspension" from fighting in the Edmonton jurisdiction."

We feel this policy protects our commission and should serve as a deterrant for fighters who wish to continue to compete in this jurisdiction, from accepting to fight in unsanctioned events. Ideally, other commissions may wish to adopt a similar policy.

You are exactly right – the communication has to improve, but of course with unregulated events happening, and without one unified voice encompassing the entire country in response to these events, the result likely won't change in terms of stopping them. As we are seeing with Ft McMurray, even when there is a somewhat unified response, so long as there are municipal politician and administrators who don't know, and don't care to learn about how important regulation is, this will continue, unfortunately. Here is a fighter that slipped through the cracks:

Timothy James Coletti who fights under the name TJ Coletti:

On August 20th, 2010 TJ Coletti fought on a card fighting Wes Ranger in Quebec where he received a TKO. Here is a summary of the final moments of the fight:

Ranger finds his range and lands a big overhand right that floors Coletti. Ranger comes in for the finish with a few shots from the top and the ref waves off the fight.

Obviously a TKO due to strikes.

Then on August 28th (8 days after his first TKO) he fights on an unsanctioned card in Ontario, since there is no Commission there would be no way of checking the suspension 8 days earlier.

But according to a fight summary Colleti is defeated by strikes a mere 40 seconds into the first round earning him another TKO.

On September 18th, 2010 TJ Colleti is fighting on the KOTC card at Cold Lake where he once again defeated by strikes in the first minute of the first round and suffers another TKO

So:

In the space of 30 days this fighter was TKO'd 3 times and happened to slip by the cracks.

Can we get a handle on this type of thing?

If true, this is very disconcerting. I would suggest we have to find a way to better communicate issues such as this.

We would need pro sanctioning for one bout. My eldest son Gabriel Varga has been offered a shot at the WKN pro Super Lightweight World title.
