

## NOTICE OF PUBLIC HEARING 2009-APR-02 at 7:00 pm

Notice is hereby given that a Public Hearing will be held on Thursday, **2009-APR-02**, commencing at **1900 hours (7:00 pm)** in the **Shaw Auditorium**, **Vancouver Island Conference Centre**, **80 Commercial Street**, **Nanaimo**, **BC** to consider proposed amendments to the City of Nanaimo "OFFICIAL COMMUNITY PLAN BYLAW 2008 NO. 6500".

## 1. BYLAW NO. 6500.004

Purpose: To redesignate the subject property to allow for a comprehensive, mixed use resort development of recreational, commercial and residential use.


Location(s): 950 Phoenix Way

This bylaw, if adopted, will amend Map 1 (Future Land Use Plan) of the "OFFICIAL COMMUNITY PLAN BYLAW 2008 NO. 6500" by redesignating a portion of 950 Phoenix Way from 'Industrial' to 'Resort Centre' to provide for a comprehensive mixed use resort development of recreational, commercial and residential uses.

The proposed amendment will provide for development of a golf course, and residential and commercial uses. This amendment would be an addition to the existing Cable Bay Resort Centre area, and would also be subject to preparation of a comprehensive Master Plan and Phased Development Agreement prior to development of the site, with specific policies related to land use, transportation and mobility, utilities and public services.

The subject property is legally described as a portion of Lot 4, Sections 21 22 and 23, Range 2, and Section 21, Range 3, Cedar District, Plan VIP65621, and is shown on Map A.
