1. CALL THE OPEN MEETING TO ORDER:

The Inaugural Meeting of the Cultural Committee was called to order at 4:00 p.m. on behalf of the Cultural Committee by Suzanne Samborski, Senior Manager, Recreation and Culture Services.

2. INTRODUCTIONS & NOMINATION / APPOINTMENT OF CHAIR:

Round table introductions by members and staff.

Diana Johnstone nominated Eveline O'Rourke for the position of Chair, Cultural Committee. This nomination was seconded by Lynne Fraser. Discussion followed. There were no other nominations.

It was moved and seconded that Eveline O'Rourke be appointed as Chair of the Cultural Committee for her term of appointment on the Cultural Committee to 2010-FEB-24.

3. CULTURAL COMMITTEE BINDER REIVEW:

Suzanne Samborski provided a review of the Cultural Committee binders for the members.

A handout, entitled "Parks Recreation and Culture – Cultural Committee Structure and Roles" was provided staff for member's binders.

It was agreed to, at this point in the Agenda, bring forward the review of Art in Public Places by Kirsty MacDonald. Kirsty provided an overview and passed around photographs on the first piece of public art, entitled "Songbird" a large sculpture of a tuning fork being installed in the Diana Krall Plaza. Explanation of the Spirit Square at Maffeo Sutton Park was provided. Kirsty advised that hopefully within 2-3 weeks a DRAFT Public Art Plan will be mailed to members for their review.

(c) Cultural Forum Project Committee – Lynda Avis advised that there was great difficulty in coming up with suitable, interesting topics. Last year's event was cancelled due to lack of interest. General discussion regarding the status of the Committee. Perhaps the Forum isn't the method that education should best be delivered. It was felt that more lead time is required to promote interest in this type of event. Simon Schachner, Lynne Fraser, Joanne Husband were selected for membership on this Committee. These members will approach community individuals to participate on the project committee.

6. MEETING DATES:

Discussion was held with regard to the meeting dates and times as adopted by the Parks, Recreation and Culture Commission at their Inaugural Meeting held on 2009-FEB-25. It was agreed by the Cultural Committee members that their meetings should commence at 4:15 p.m. rather than at 4:00 p.m. as moved and adopted by the Commission.

It was moved and seconded that the Cultural Committee recommend that the Parks, Recreation and Culture Commission review the Cultural Committee meeting start time and approve the amendment from 4:00 p.m. to 4:15 p.m. on the first Wednesday of every month, with date exceptions as previous adopted, in order to better accommodate the members of the Cultural Committee. The motion carried unanimously.

(a) Commissioner Johnstone advised that Council had received an e-mail regarding the tunnel under Northfield Road that, at one time, had a Jeff King mural. This was vandalized and then painted over by the City. It is now a mess with garbage and graffiti. If the Woodlands School Art students did a mural of their own, then they would probably respect it and have the nearby Tim Horton's donate garbage cans as the majority of the garbage is from fast food wrappings. It was noted that this would come out of the Parks Department budget and also that Jeff King should have been contacted. This should go hand in hand with making improvements – it was felt it was always a mess despite the presence of the Jeff King mural. Staff advised that Jeff Ritchie, Senior Manager of Parks, is following up on the matter and is contacting the individual who sent in the e-mail.
