**EXECUTIVE SUMMARY REPORT
TO NANAIMO ATHLETIC COMMISSION
ED GARNER, JULY 24, 2008**

1. The past Don Arnott event, supervised by myself with Joe Martin in attendance went smoothly for the most part, no major issues that didn't resolve themselves. There was one fighter, Josh Shepherd that won the middleweight division, that obviously had more amateur experience than Don's own guidelines, he should not have been on the card and some form of reprimand to Don should be in order. Maybe Don could provide more info about the fighter and explain his actions.
2. The officials we have here in Nanaimo are very good (Jim Kipp, Gord Racette and Mike McDonald) and we have several qualified judges in the area. Once again these officials are appointed by the commission, should answer to only the commission and be paid by the commission.
3. The commission should set up its own bank account to write cheques or pay cash directly to these officials, this is done in Edmonton, Richmond, Montreal and anywhere else I have ever attended fights.
4. We should have dressing room supervisors at all fights, and they should be paid. We should get 4 or 5 windbreaker jackets screened with NAC to identify these officials.
5. At all times we should strive to have all of our officials either trained or certified, through any of the many one day seminars that are held. Most participants will contribute to their tuition and travel if necessary, and this gives us a legitimate credential when there is a dispute. This is also basic to our due diligence to protect the city legally.
