



Elevator Project

Brief History of the Club

The Nanaimo Curling Center (Club) (NCC) started in 1947 at the Nanaimo Civic Arena with 32 rinks comprising three men and one ladies event bonspiel. The Club had 43 members in 1948. Curling started on a regular basis in 1949 on one sheet of ice during public skating at the Civic Arena. After two years of searching and negotiating for a rink site, a lease with the City of Nanaimo was acquired. The Nanaimo Curling Center (Club) was duly registered as a not-for-profit society, and construction of a four-sheet rink began in 1950 on the site of what is now the parking lot. The rink was completed in 1951 and ready for the fifth bonspiel. A fifth sheet was installed in 1953, clubrooms were added in 1958 and a liquor license was obtained in 1961. The Ladies Club and the Hangover League started in 1953 and by 1960 the Men's Senior League started. The club ran at full capacity and it became apparent that a larger facility was needed. After a fund-raising drive, construction of a new eight-sheet facility began in the spring of 1969i, which opened it doors later that December.

Of note is the fact that both rinks were built without any financial burden to the taxpayers of the community. The original rink was built at a cost of \$ 60K with money raised by sale of memberships and debentures. The current facility cost \$300K to build, with funds raised in the same fashion. There were many hundreds of hours of volunteer labor, machining and supervisory time involved in both projects. As a result, we have an excellent facility that is not only a credit to its members, but is an available to the community for any number of functions during the off and on season.

The history of the Nanaimo Curling Club over the years has shown that the Club has remained strong due to its volunteers willing to work hard.

We have past the 50th anniversary of the Nanaimo Curling Club by maintaining these simple standards that were established by its founding members, executives and directors so many years ago.

The Nanaimo Curling Center (Club) organizes and manages recreational and competitive curling in the Nanaimo area. Our Board of Directors and Membership are comprised of residents from all walks of life. They volunteer thousands of hours annually, taking responsibility for the direction and operation of the club to ensure it meets community and members' needs. The NCC provides regular scheduled league play for men, women, senior ladies, senior men, senior mixed, juniors, visually impaired, Special Olympics athletes, school program as well as wheel chair curling started this year.

The Nanaimo Curling Center (Club) has over 4500 curlers and spectators come through our center each season.

Activities and Programs

- Junior Programs emphasis sportsmanship, etiquette, skill and team development, goal setting and achieving.
- School Program introduces young students to a life long sport; we believe physical activity is a critical part of every child's education. Etiquette and fairplay is also an important part of what we teach. Curling is not a sport that relies on physical size to produce its best athletes, it is a non-contract sport, and team co-operation is key to success in curling. Over 780 students took part last year in the program.
- Nanaimo's Special Olympics and Visual Impaired Program have produced Provincial Champions over the years.
- Our daytime and evening leagues have adults of all ages participating. Last season 1484 spots where filled. We host 10 15 Bonspiels & Playdowns each season with over 1330 persons curling over 3-4 day period. The NCC has already built 2 handicap washrooms -1 on the main level and the other upstairs in the Banquet / Lounge area.

Our Center (Club) has been fund raising for this project for since 2004, however we are still in need of help with the short fall.

The cost of the Elevator Project is - \$ 225,750.00 (estimation is based on last years estimate \$ 215,000.00 plus a 5% increase)





Dear Sir,

I am writing to you on behalf of Bowen Park Seniors to ask the Parks, Recreation and Culture Commission for APPROVAL IN PRINCIPLE for a special recreational project.

During this past year, our board became aware of an extremely worthwhile project which we would like to see become a reality for our senior community here in Nanaimo. The project focuses on a Senior Wellness Park with a myriad of exercise equipment, designed for safe usage by the senior population but at the same time is appropriate for use by any individual over 13 years of age.

Such a park, believed to be the first of its kind in Canada, was installed in Tsawwassen this year. This Senior Wellness Park is based on an idea from a similar facility located in Beijing, China, and was installed at a cost of \$150,000, mainly with funds raised by the local Lions Club. The exercise equipment is designed to develop flexibility and strength, as well as promoting fall prevention.

Our board has been investigating the progress of the park in Tsawwassen for several months, and on Monday, May 5th, we visited the site, and had informative discussions with both the individual with whom the idea originated, as well as local municipal parks staff who installed the equipment.

The Tsawwassen Seniors Wellness Park has been installed in an area which abounds in seniors housing facilities which is proving an ideal location, and the park has already experienced a high success and usage rate. Nanaimo, with its large and ever-growing seniors' population certainly has many locations for the installation of such a park. Oliver Woods Community Center would be an ideal location due to the large "over 55" population that exists around it, occupying various forms of housing, such as retirement bungalows, patio homes, condominiums and designated seniors residences. Parks staff has walked the site at Oliver Woods with board members and various installation positions for this equipment have been noted; perhaps in single stations along the walking path or in two clusters situated at either end of the path.

The development of a Seniors Wellness Park in Nanaimo could be achieved by forging many appropriate partnerships in order to raise funds for the initiative. Support can be sought from the City of Nanaimo, both the Provincial and Federal governments, local service clubs, as well as other organizations such as the Royal Canadian Legion and BC Hydro. Private businesses could be approached to sponsor each exercise station which would prove to be a continuous promotional advertising tool for the particular business.

Bowen Park Seniors is desirous of spearheading this initiative, and will also donate money towards this project but we will need the co-operation of other partners such as those mentioned above, to raise the entire sum that is necessary. We applied to the BC Seniors Games (Nanaimo) 2008 Legacy Fund and at the time of writing this letter, I do know our submission was successful but I do not know how much we have received.

In today's society, we are constantly reminded of the importance of exercise at any age but as we get older, exercise is of paramount importance if we are to preserve good quality of life. A Seniors Wellness Park is an excellent opportunity for individuals to exercise in a safe environment, without time or increased financial constraints, while experiencing the beauties of natural surroundings.

Re: Proposal for Phase Two of DIGS Community Garden-Project

Background: On May 31st last year, DIGS was given a \$15,000 grant by your Committee to proceed with Phase One of our plan for a community Garden on Protection Island.

For us, it has been a very successful year. To create the garden, we have built 15 raised beds; filled them with 30 yards of soil, driven and cemented in posts; stretched wire; moved sheds; created 2 arbors; painted and planted and made a garden of which we are very proud.

In the process we have made new friends; shared our tools and machinery; given freely of our time and fostered a wonderful sense of community. We have benefitted from some wonderful donations, including cash, machinery, a complete garden shed and even a greenhouse. Our latest initiative is a children's gardening programme, called "Little Diggers", which will run every Saturday from May until September. DIGS current membership is 37; Little Diggers membership is 11 and we like to think that we are not done yet. With your consent, we would like to proceed with Phase Two, which is outlined below.

Proposal for Phase Two

DIGS proposes extending our community garden eastward by 30' (see attached map). This would give us room for 8 new raised beds, a perimeter bed along the fence, and a greenhouse. DIGS proposes offering these 8 raised beds to the islanders as allotment beds, subject to the rules outlined in our garden guidelines. In the perimeter beds DIGS plan to create a heritage apple orchard using cuttings from island trees.



The initial phase of DIGS activity on Smugglers Park on Protection Island consists of communal beds in which usage is open to all though there is a small membership fee expected of each participant. However, it is to all intents a community activity.

The space used so far is not large though by no means insignificant because there is no great amount of park area on this island and in particular there is not much open green space. Now we learn, rather casually, that Parks is considering allowing <u>DIGS</u> to expand into more park space to create beds <u>DIGS</u> would rent to individual gardeners.

Objections have been made by those who think that park space should not be appropriated for private use. Some want to be able to use the green space, I see the expansion of DIGS as opening the way to privatization of other park areas on the island and even privatization of the beach accesses. This may be an alarmist view, but it merits your consideration.

DIGS has today called a meeting for June 19 at which they will present their proposal in a well-structured way allowing just 15 minutes towards the end of the session for general discussion. 'Next steps' are to be decided upon and presumably presented to Parks to support the DIGS application for expansion.

Because of a conflict I cannot attend that event, but I would urge you to consider that the results of that meeting are likely to present a one-sided view. Would you consider inviting PI residents who oppose the expansion to speak at the Parks meeting at which a decision is to be made?

Dear Commission:

Your support of the Douglas Island Garden Society (DIGS) venture at Smuggler's Park on Protection Island over the past year has helped to create a wonderful Community Garden as I'm sure Jim Plasteras can attest from his visit to the Grand Opening on May 25th. The generous funding combined with the dedication and hard work of many volunteers has created a garden that is intelligently laid out, welcoming, and ideally suited to both successful gardening and community gatherings.

I am aware that on June 25th the DIGS executive will present a proposal to change the nature of the garden by expanding eastward to create 8 private plots. I first became aware of this proposal on May 28th 2008. In the couple weeks since then, there has been some very difficult email conversations via our island listserve in the community here regarding this transition to private plots. There has been no public meeting to discuss this. The email conversations have been difficult, as there has been no flexibility on the part of DIGS directors to invite community feedback. Although I've heard no one speak against the existing garden – in fact, most people seem to be quite impressed with it – there have been serious concerns expressed about the appropriateness of the addition of private plots. These private plots are to be held by the successful plot-holder in perpetuity. There is nothing in the available DIGS material to reference what to do should the demand for private plots get untenable. The plot-holder, once successful, has the plot for life – or until they move, get tired of gardening, or do something against DIGS instructions. In this intimate community, where everyone knows each other, it is hard not to imagine considerable tension developing between the 8 people who have a private plot in the park, and those who wish they had one.

The initial letter of Parks approval signed by Larry McNabb on May 31, 2007 was not made public until one year later, at the repeated request of islanders to try to find out what formal status the community garden had obtained from the Parks Board. Had the letter from Mr. McNabb been posted in a timely manner, the community would have had a chance to acclimatize to this change and request a community meeting during which interested parties could express themselves and brainstorm how best to adapt the private plot model to our environment. In the absence of this document many people understandably but incorrectly believed that the garden was only ever intended to consist of communal plots.

Given that this transition to private plots is taking place on park land it would seem greater consideration would be mented to communicate effectively with the community, affording it an opportunity to come to an understanding about these changes.

Because of The Commission's support and the dedication of the volunteers a garden now exists that I hope will continue to flourish. This may not be possible if islanders are not given enough time to accommodate the notion of private plots—to work out if they want them, and if so, how to manage them.

I feel that further discussion in our community and together with the Parks Board would be beneficial and time well spent before a second phase is fully approved as presented.

PRESENTATION:

I wish to speak to the Community Garden project on Protection Island, in particular the phase 2 expansion of 8 plots and their potential designation as private allotments.

The existing garden consists of communal beds only. Private allotments are being presented as a necessary part of the community garden here, but there are examples where this is not the case. Locally there is a communal garden called Spring Ridge Commons active since 1999, that has no allotments and sits on School Disctrict 61 property at Chambers Street and Gladstone Avenue in Fernwood. Another example is Bamfield Commons that sits on parkland in Bamfield Park in Esquimalt that also has no allotments. I would suggest that while buzzwords like ecological, green and sustainable may be appropriately applied to the notion of locally grown food, by comparison in the case of a privately controlled plot on parkland built from materials supplied by the Parks Board, and where all the produce created is the property of the plot-holder, that what is being defined is a form of ownership that has a great deal more in common with privatization than it does with being green.

It is possible that the 8 new beds in phase 2 will also be approved for communal use. This would be in keeping with the nature of the public park lands upon which the garden rests. In the case that this Commission decides to move toward allowing private allotments however, I am requesting that consideration be given to the following:

- Because of it's size and small population, Protection Island has a unique culture. The
 rules sometimes used to govern allotment gardens elsewhere may not be a good fit in this
 community.
- A public tennis court is an example of a kind of specific usage allotment on public lands. The
 court is "allotted" to you until a queue is formed for the court, whereupon your "allotment" is then
 on a timer. Obviously a garden allotment will require a longer access priviledge time, but I would
 argue that as with tennis courts it is essential to enforce such a limit.
- In the Douglas Island Garden Society (DIGS) proposal there is no reference to any time limit for ownership of these plots. Their proposal suggests that as long as someone follows the rules they can hang onto their plot indefinately.
- The DIGS board recently wrote in describing their postion in favour of allotments and how they might be allocated, "We don't know if people will want full beds or partial beds. What we do know, however, is that we are flexible and will do all we can to accommodate residents who want a bed." I would suggest that a minimum sized plot be the starting position and that access to multiple plots occur only when demand for plots is met. The bias should be toward including all those interested in participating in the garden, even if the plots must get smaller to do so.
- This could be fairly readily done by:
 - 1. dividing the projected 8 plots into smaller allotments to include more people, and
 - 2. in the case that a waiting list for allotments exist, ensuring that plots are only held for a maximum period.

The benefits accrued especially in these early stages, would be that more people get a chance to find out if this gardening approach works for them, and in a community where everyone knows everyone else the chances of resentments building between neighbours with plots and those without, would be significantly lessened. Even if you didn't have a plot, the wait time required before getting one would not seem overly daunting.

Suggested Recommendations:

- **1** -That the Commission define a minimum plot size that favours more participation over having people on waiting lists.
 - I believe these projected 8 plots of phase 2 are planned to be 4' x 24'. If the minimum plot size were defined as 4' x 8', for example, up to 24 people could be supplied with private plots.
 - Conversely there should also be maximum plot size available for private use, for example one of the 8 plots at 4' x 24'. If less than 8 people wanted a private plot then the remaining plots would revert to communal status until demand for allotments increased.
- **2** -That the Commission mandate that in the case where a waiting list exists for an allotment that any given allotment not be held longer than a fixed period of time (for example, one or two years).
 - At the start of the new season all those who have held an allotment for the maximum time would be entered into a lottery and whosever's name is drawn would then relinquish their allotment in favour of any person in line. The person surrendering the plot could then put themselves back in line for access to an allotment the following year.

If the Commission decides that allotments are to be approved for this garden then something like the process suggested above would also allow a fairly clear indication of demand for allotments over the next few years, and this could inform any potential future garden expansion plans. It would also allow for adjustments and acceptance in the community for this specific usage of park lands.

Thank you for your support of our community and your time in consideration of this matter.





RECOMMENDATION:

That the Parks, Recreation and Culture Commission:

- 1. approve proceeding to Phase Two of the DIGS Community Garden Project including eight new beds to be offered to the islanders as allotment beds.
- 2. approve allocation of an additional \$2,000 from the 2008 VIP fund for implementation of Phase Two.

EXECUTIVE SUMMARY:

At the 2007-MAR-28 Commission meeting, Commission allocated a \$15,000 grant from the VIP Program for Phase One of the DIGS Community Garden Project. After completion of one year of the project, staff report that the project has been successful and are recommending support of Phase 2 of the DIGS Community Project.

BACKGROUND:

With Commission approval and funds from the VIP Program, DIGS created a community garden at Smugglers Park on Protection Island that included fifteen beds built for community use on a one year trial basis. The project has been successful from a community perspective as well as in terms of crop production.

Private donations of cash, machinery and equipment, in addition to the \$15,000 City contribution, has added to the projects success. To date \$11,188 of the \$15,000 has expended. The Society has budgeted \$5,000 for Phase Two therefore, they are requesting an additional \$2,000 from the VIP Capital Fund.

Phase Two includes eight raised beds and a greenhouse. DIGS proposes offering the eight raised beds to the islanders as allotment beds (as per their original Concept Plan). The Society would advertise the new plots to island residents and then at DIGS February 2009 AGM the names would be randomly drawn. With Commission support, construction of Phase Two will begin this fall.

Although new for City of Nanaimo's park system, the allotment of personal planting beds is a common practice for community gardens throughout North America.

RECOMMENDATION:

That the Parks, Recreation and Culture Commission recommend that Council approve the renewal of the License of Use Agreement between the City of Nanaimo and the Boys and Girls Club of Central Vancouver Island for the Chase River Activity Centre at 1400 Cranberry Avenue for the five year period from 2008-JUL-01 to 2013-JUN-30 at an annual rental of \$1.00 in addition to an administrative fee of \$125.00 upon renewal of the license.

EXECUTIVE SUMMARY:

The "Guidelines Establishing the Value of Rent for Lease or License Agreements to Non-Profit Societies" as recommended by the Parks, Recreation and Culture Commission were adopted by Council at their meeting of 2007-JUL-09. The guidelines to assist with determining nominal rent for non-profit societies are as follows:

- 1. The primary service offered provides a demonstrable public benefit.
- 2. Participation or membership is available to a broad demographic in the community.
- 3. The Society provides the only opportunity, or one of only a few opportunities, for the service, activity or benefit in the community.
- 4. The Society does not compete directly with the business community in the service it provides or the Society's services compete with the business community, but are offered in very different ways, or are accessible to persons who do not normally have access to the services or facilities in the private sector.
- 5. Taxpayers will expect the City to provide the service if the entity declines to.
- 6. There is a unique distinguishing feature.

The above guidelines were used in reviewing the renewal of the License of Use Agreement for the Boys and Girls Club of Central Vancouver Island for the use of the land and building at 1400 Cranberry Avenue. The conclusion was that the service provided by this organization meets the guidelines and an annual rent of \$1.00 was appropriate.

BACKGROUND:

Currently the City of Nanaimo has a license agreement with the Boys and Girls Club of Central Vancouver Island for occupancy of the Chase River Activity Centre at 1400 Cranberry Avenue which expires 2008-JUN-30. At the 2008-FEB-27 Parks, Recreation and Culture meeting, it was recommended that a five-year license renewal with the Boys and Girls Club of Central Vancouver Island to occupy the entire Chase River Activity Centre/Fire Hall facility be approved by Council.

Re: Renewal of License of Use Agreement For Boys and Girls Club

Page 2.

The fee recommended for the occupancy of these premises is \$1.00 annually over a five-year term as well as a \$125.00 administration fee.

In this agreement:

- The City grants the "Licensee" a right to use the land for the purpose of the enjoyment and recreation of members of the public and for no other purpose.
- The Licensee covenant with the City to pay all taxes, rates, licenses, duties and assessments. In addition, the Licensee pays, as they become due, all water, sewer, garbage, gas, oil, telephone and electric light and power used on the license area.
- The Licensee will, at all times during the term of this agreement, at its own cost and expense, repair, maintain and keep the license area in good order and repair.

The Licensee will take out, and maintain during the term, a policy of General Public Liability Insurance against claims for bodily injury, death or property damage arising out of the use and occupancy of the license area by the Licensee in an amount of not less than five million dollars.

In assessing the rent applicable to this Licensee under the guidelines, the following factors were considered:

- The primary service offered by the Licensee provides a demonstrable public benefit.
- Participation or membership is available to a broad demographic in the community
- This organization is one of only a few who provides these services or benefits in the community.
- This organization does not compete directly with the business community in the services it provides.
- Taxpayers will expect the City to provide these services if the organization declines to.

Given that the services provided by the Boys and Girls Club of Central Vancouver Island meet well with the stated guidelines, staff is recommending a five-year license renewal at an annual fee of \$1.00 per year in addition to an administrative fee of \$125.00 for this organization.

LICENSE OF USE

THIS AGREEMENT made the

BETWEEN:

CITY OF NANAIMO

500 Bowen Road Nanaimo, British Columbia V9R 1Z7

(the "Municipality")

OF THE FIRST PART

AND:

Boys and Girls Club of Central Vancouver Island. #20 Fifth Street Nanaimo , British Columbia V9R 1M7 (the "**Licensee**")

OF THE SECOND PART

WHEREAS:

- A. The Municipality is the owner of land and building described in Schedule "A" to this Agreement (the "Land");
- B. The Licensee wishes to be granted this license of use to use the Land and building and the Municipality has agreed.

NOW THEREFORE THIS AGREEMENT WITNESSES that in consideration of the fee paid by the Licensee to the Municipality and in consideration of the premises and covenants and Agreements contained in this Agreement, the Municipality and the Licensee covenant and agree with each other as follows:

1.0 RIGHT TO OCCUPY

1.1 The Municipality, subject to the performance and observance by the Licensee of the terms, conditions, covenants and agreements contained in this Agreement and to earlier termination as provided in this Agreement, grants to the Licensee a right by way of license for the Licensee, its agents, employees, and invitees to use the Land and for the purpose of the enjoyment and recreation of members of the public and for no other purpose.

2.0 RESERVATION OF RIGHTS

2.1 The Municipality hereby reserves to itself from the grant and the covenants made by it to the Licensee under clause 1 above the right for the Municipality, its agents, employees, contractors and subcontractors to have full and complete access to the Land to carry out any operations associated with the Municipality's use of the Land.

3.0 LICENSE FEE

- In consideration of the right to use, the Licensee shall pay to the Municipality the sum of **One Dollar** (\$1.00) in each year of the Term.
- The Licensee shall pay to the municipality the sum of **One Hundred Twenty**Five **Dollars** (\$125.00) upon the execution of this agreement.

4.0 TERM

4.1 The Term of the License granted under this Agreement shall be from the 1st day of July, 2008 to the 30th day of December, 2013 unless earlier terminated under this Agreement.

5.0 RATES

- 5.1 The Licensee shall pay all taxes, rates, duties and assessments whatsoever, whether federal, provincial, municipal or otherwise charged upon the Licensee or the Municipality as a result of the Licensee's occupation of or use of the Land. Without in any way restricting the generality of the foregoing, the Licensee shall pay to the Municipality, G.S.T. of 5% on the Licence fee.
- 5.2 The Licensee shall pay all estimated charges for water, sewer, garbage, gas and electricity used on the premises. The Occupier will make their own arrangements for telephone service and pay all charges as they become due.

6.0 CONSTRUCTION

- 6.1 The Licensee shall not construct or place any buildings or structures or make any improvements on the Land, unless prior to any construction, it has:
 - (a) obtained the Municipality's approval in writing to the site plans, working drawings, plans, specifications, and elevations; and
 - (b) obtained a building permit from the local government authority having jurisdiction authorizing the construction of the buildings and structures set out in the permits and the plans and specifications attached to it; and

- (c) obtained all required inspections, and the work shall be carried out at the cost of the Licensee; and
- (d) delivered final as built drawings to the Municipality.
- 6.2 The Licensee shall not occupy the buildings without first obtaining an occupancy certificate.
- 6.3 The Licensee shall, at its cost, maintain any buildings, structures or improvements constructed or placed on the Land during the Term. Including interior painting, custodial, plumbing, and electrical at all times to a standard of maintenance to the satisfaction of the City.

7.0 INSURANCE

- 7.1 (a) the Licensee will take out and maintain during the term of the License a policy of general public liability insurance against claims for bodily injury, death or property damage arising out of the use of the use of the premises by the Licensee in the amount of not less than five million dollars per single occurrence or such greater amount as the Municipality may from time to time designate, naming the Municipality as an insured party thereto and shall provide the Municipality with a certified copy of such policy or policies;
 - (b) all policies of insurance shall contain a clause requiring the insurer not to cancel or change the insurance without first giving the Municipality thirty days prior written notice;
 - (c) if the Licensee does not provide or maintain or enforce the Insurance required by this Agreement, the Municipality may take out the necessary insurance and pay the premium for periods of one year at a time and the Licensee shall pay to the Municipality as additional License fees the amount of the premium immediately on demand;
 - (d) if both the Municipality and the Licensee claims to be indemnified under any insurance required by this Agreement, the indemnity shall be applied first to the settlement of the claim of the Municipality and the balance, if any, to the settlement of the claim of the Licensee;
 - (d) the deductible on the policy of the Insurance shall be not more than five thousand dollars.

8.0 INDEMNIFICATION

8.1 The Licensee releases and will indemnify and save harmless the Municipality, its elected and appointed officers, employees and agents from and against all lawsuits, damages, costs, expenses, fees or liability which the Licensee or any of them or anyone else may incur, suffer or allege by reason of the use of the Land by the Licensee or by any member of the public using any building, structure or improvement built or placed by the Licensee on the Land or the carrying on upon the Land of any activity in relation to the Licensee's use of the Land.

9.0 BUILDERS LIENS

9.1 The Licensee will indemnify the Municipality from and against any liens for wages or materials, for damage to persons or property caused during the making of or in connection with any excavation, construction, repairs, alterations, installations and additions which the Licensee may make or cause to be made on, in or to the Land.

NOTICES

- 8.2 It is hereby mutually agreed: Any notice required to be given under this Agreement shall be deemed to be sufficiently given:
 - (a) to be delivered at the time of delivery and
 - (b) if mailed from any government post office in the Province of British Columbia by prepaid registered mail addressed as follows:
 - (i) if to the Municipality:

(ii) if to the Licensee:

Boys and Girls Club of Central Vancouver Island #20, Fifth Street

or at the address a party may from time to time designate, then the notice shall be deemed to have been received forty-eight hours after the time and date of mailing. If, at the time of mailing the notice, the delivery of mail in the Province of British Columbia has been interrupted in whole or in part by reason of a strike, slow-down, lock-out or other labour dispute,

then the notice may only be given by actual delivery of it.

9.0 TERMINATION

9.1 If the Licensee is in default on the payment of License fees, or the payment of any other sum payable under this Agreement, or is in breach of this Agreement, and if the default continues after the giving of notice by the Municipality to the Licensee, then the Municipality may terminate this Agreement and reenter the Land and the rights of the Licensee with respect to the Land shall lapse and be absolutely forfeited.

10.0 FORFEITURE

10.1 The Municipality, by waiving or neglecting to enforce the right to forfeiture of this Agreement or the right of reentry upon breach of this Agreement, does not waive the Municipality's rights upon any subsequent breach of the same or any other provision of this Agreement.

11.0 FIXTURES

11.1 Unless the Licensee upon notice from the Municipality removes them, all buildings, structures or improvements constructed on the Land by the Licensee shall at the termination of the Agreement, become the sole property of the Municipality at no cost to the Municipality.

12.0 REPAIRS BY THE MUNICIPALITY

- 12.1 (a) If the Licensee fails to repair or maintain the Land or any building, structure or improvements on the Land in accordance with this Agreement, the Municipality may, by its agents, employees or contractors enter the Land and make the required repairs or do the required maintenance and the cost of the repairs or maintenance shall be a debt due from the Licensee to the Municipality;
 - (b) In making the repairs or doing the maintenance the Municipality may bring and leave upon the Land the necessary materials, tools and equipment and the Municipality shall not be liable to the Licensee for any inconvenience, annoyance, loss of business or other injuries suffered by the Licensee by reason of the Municipality effecting the repairs or maintenance;
 - (c) The Licensee releases the Municipality, its elected and appointed officers, employees and agents from and waives any claim, right, remedy, action, cause of action, loss, damage, expense, fee or liability which the Licensee may have against any or all of them in respect of this Agreement or its performance or its breach except insofar as such claim, right, remedy,

action, cause of action, loss, damage, expense, fee or liability arises from the negligence of the Municipality, its elected and appointed officers, employees and agents.

13.0 TREE CUTTINGS, EXCAVATIONS AND HAZARDOUS SUBSTANCES

- 13.1 (a) The Licensee will not carry on or do or allow to be carried on or done on the land any cutting, clearing or removal of trees, bushes or other vegetation or growth or any excavation or disturbance of the surface of the Land and shall not bring on or deposit any soil or fill on the Land except with the written consent of the Municipality;
 - (b) The Licensee will not bring on, deposit, store, spray or apply nor cause or permit to brought on, deposited, stored, sprayed or applied on the Land or to any trees, bush or vegetation on the Land any chemical fertilizer, herbicide, pesticide or other chemical or petroleum product or any substance which is capable of contaminating the Land or any water on the Land.

14.0 CLEAN UP

14.1 At the end of the term, the Licensee shall clean up the Land and restore the surface of the Land as reasonably as may be possible to the condition of the Land prior to the commencement of the term of this Agreement.

15.0 REGULATIONS

15.1 The Licensee will:

- (a) comply promptly at its own expense with the legal requirements of all authorities, including an association of fire insurance underwriters or agents, and all notices issued under them that are served upon the Municipality or the Licensee;
- (b) indemnify the Municipality from all lawsuits, damages, loss, costs or expenses that the Municipality may incur by reason of non-compliance by the Licensee with legal requirements or by reason of any defect in the Land or any injury to any person or to any personal property contained on the Land. The Licensee shall be responsible for any damage to the Land occurring while the Licensee is exercising its rights under this Agreement.

16.0 NO COMPENSATION

16.1 The Licensee shall not be entitled to compensation for any loss or injurious affection or disturbance resulting in any way from the termination of the License or the loss of the Licensee's interest in any building, structure or improvement

built or placed on the Land.

17.0 MISCELLANEOUS

- 17.1 (a) The Licensee warrants and represents that the execution of this Agreement by the Licensee on behalf of a group or organization is a warranty and representation to the Municipality that the Licensee has sufficient power, authority, and capacity to bind the group or organization with his or her signature;
- 17.2 (b) In consideration of being granted the use of the Land, the Licensee agrees to be bound by the terms and conditions of this Agreement and, if the Licensee represents a group or organization, the Licensee agrees to inform all responsible persons associated with the group or organization of the terms and conditions of this Agreement;
 - (c) The Licensee covenants and agrees to use the Land in accordance with the terms of use attached to this Agreement as Schedule "B";
 - (d) This Agreement shall not be interpreted as granting any interest in the Land to the Licensee;
 - (e) Waiver of any default by a party shall not be interpreted or deemed to be a waiver of any subsequent default.

18.0 INTERPRETATION

- 18.1 (a) That when the singular or neuter are used in this Agreement they include the plural or the feminine or the masculine or the body politic where the context or the parties require.
 - (b) The headings to the clauses in this Agreement have been inserted as a matter of convenience and for reference only and in no way define, limit or enlarge the scope or meaning of this Agreement or any provision of it.
 - (c) That this Agreement shall enure to the benefit of and be binding upon the parties hereto and their respective heirs, executors, successors, administrators and permitted assignees.
 - (d) This Agreement shall be construed in accordance with and governed by the laws applicable in the Province of British Columbia.
 - (e) All provisions of this Agreement are to be construed as covenants and agreements as though the word importing covenants and agreements were used in each separate paragraph.



RE: FRANK CRANE ARENA ELEVATOR

RECOMMENDATION:

That the Parks, Recreation and Culture Commission's direction is sought.

EXECUTIVE SUMMARY:

The need to construct an elevator at Frank Crank Arena to provide access to persons with disabilities has been discussed for many years. In 1994, Staff began reviewing location options and developing site design and engineering plans. The proposed location of the elevator minimizes building retrofit and structural changes resulting in a lower cost alternative.

An initial tender for consideration was released in 2007. The bids received were substantially higher than the funds allocated. Project specifications were adjusted to decrease construction costs and a request was made through the 2008 budget process to increase capital funding. A second tender was released in the spring of 2008 and bids received meet current funds available for the project.

At the regular Parks, Recreation and Culture Commission Meeting of 2008-MAY-28 the Commission raised concerns regarding the proposed location's limitations. The Commission recommended a site visit prior to awarding the contract.

BACKGROUND:

In 2004, plans to construct an elevator at Frank Crank Arena began with the development of site design and engineering plans.

An initial tender budgeted at \$140,000 was released in 2007. The bids received were substantially higher than the funds allocated with the most competitive bid coming in at \$249,000. Project specifications were adjusted to decrease construction costs and a request was made through the 2008 budget process to increase capital funding.

The allocated funds were forwarded to 2008 with a request for an additional \$75,000. A tender went out in April 2008 with new specifications. Three competitive bids were received that are within budgeted amounts and contractors are ready to proceed if the tender is awarded.

Concerns regarding the proposed location were brought forward for discussion at the 2008-MAY-28 regular Commission meeting. The primary concerns are that the location is not the best for those with disabilities and would constrain other users during busy events at the facility. As per Commission's request, a site meeting at Frank Crane Arena was held with Commission members, staff and the project Engineer on 2008-MAY-04 to review the proposed location and other possible locations.

Report to Commission Re: Frank Crane Arena Elevator Page 2.

In addition to meeting with Commission on site, Staff have reviewed the proposed location, design and specifications of the elevator to ensure the elevator would meet user needs. There have been site meetings with the project engineer and a representative from Access Nanaimo.

The Access Nanaimo representative concurred that the slope to access the elevator may be problematic for three out of ten of their clients. During the site visit it was also indicated that the exterior ramp accessing the main entrance of Frank Crane Arena posed a challenge for some of their clients as well.

From the noted concerns and discussions, staff offers three options for Commission's consideration:

Option A - Proceed with Current Location

The current location of the elevator minimizes building retrofit and structural changes resulting in a lower cost alternative. This location meets building codes and was considered acceptable in discussions with the Access Nanaimo representative. The construction of the elevator as proposed is within current funds allocated in 2008 Parks, Recreation and Culture capital plan and could be complete this year.

Option B – Identify Alternate Locations

The second option involves two alternate locations that have been identified and evaluated throughout the elevator planning process but not processed with because of cost and impact to the building. One location would access through the warm room and the second would access through the music room. Both locations would result in approximately \$200,000 of additional costs (minimum), resulting in a final project cost of \$350,000 - \$400,000.

Either location is considered more desirable as they are centrally located and would be accessed at ground level without having to use an interior ramp. However, there are further structural considerations including seismic upgrades and substantial mechanical relocations, along with re-design and engineering work required. Additional funds for this option would need to be considered in the 2009 Parks, Recreation and Culture Capital Plan review.

Option C - Comprehensive Facility Upgrade Plan

Beban Park Complex is now over 35 years old and the need for re-development, retrofitting and renovation is an ongoing requirement. The Five Year Capital Plan identifies infrastructure work to ensure its long-term operation (arena floor, roofing, mechanical upgrades, etc). There are also aesthetic improvement options such as washroom upgrades, exterior and interior painting and potential reconfiguration in the Social Centre, arenas and swimming pool(s) to ensure the facility is relevant to the needs and wants of current and future users.

Option C would direct staff to proceed with developing terms of reference, for Commission consideration, of a comprehensive facility upgrade plan that would encompass the arenas, swimming pool and social centre and their relationship with the whole of Beban Park. The

existing capital plan could be incorporated into the plan allowing for more inclusive upgrades to the facilities. By considering at the elevator as part of the whole, the final location would look at the needs of all users and where it might best serve current and future needs.

A more comprehensive improvement plan for the facility is preferred as identified in Option C; however, this option would delay the elevator project for at least another year.

That the Parks, Recreation and Culture Commission recommend that Council:

- 1. approve the Concept Plan for Maffeo Sutton Park as a long term guide for park improvements as identified in Park Plan Vision Schedule "A".
- 2. approve the Spirit Square development area, as identified in Schedule "B", as Phase 1 for improvements.
- 3. direct staff to proceed with detailed design of the Sprit Square with the goal to start construction by this year.

EXECUTIVE SUMMARY:

Maffeo Sutton Park has developed over the years from an industrial site into a destination urban waterfront park. The site was recently awarded a \$500,000 Spirit Square Grant from the Provincial Government. Planning for the Spirit Square, and overall park redevelopment, provides an opportunity to enhance this premier waterfront park.

The Spirit Square is required to be under construction by the end of 2008. When the Concept Plan and Spirit Square location is approved, detailed design and construction drawing preparation will begin. It is expected that the detailed design process will continue throughout the summer and that tendering for the Spirit Square portion of the park improvement plan will occur in October 2008.

BACKGROUND:

The concept for Maffeo Sutton Park improvements began in 2004 during the New Nanaimo Centre Referendum process. The following goals for the park improvements were developed at that time:

- Enhance key park features such as performance spaces, play spaces and waterfront access.
- Maintain existing amount of parking stalls and enhance access to the park.
- Improve pedestrian and multi-use circulation routes.
- Improve public amenities in the park
- Enhance the park for special events and public use.
- Increase public open space along the waterfront.
- Add historical and industrial interpretation within the park.
- Include a phasing plan to maintain access through development.

The February 2008 Provincial announcement that Nanaimo was awarded a grant under the Spirit Square program accelerated the park planning process and required construction of the Spirit

Square portion to begin in 2008. In early 2008, Consultants were hired to assist staff in park improvement process. Staff also liaised with a number of stakeholders, including the general public, special event groups, Nanaimo Port Authority, Millennium Development Corporation, Snuneymuxw First Nations and Service Clubs.

A public open house was held on 2008-MAY-15 to review two park improvement concepts. Each concept highlighted the park setting, enhanced park access and circulation, improved public amenities, reviewed annual park functionality including special events, and incorporated a Spirit Square as a central community gathering place. Approximately 200 people attended the open house with over 80 survey respondents. Overall, the stakeholders and public appreciated many elements in the concept plans including the covered performance space, increased physical and visual access to the park, the incorporation of rest stops along the promenade and the development of a hard surface Spirit Square.

As a result, a refined concept plan was developed that blends the public and stakeholder input, preferred site character and optimal site organization. This concept plan features a central Spirit Square that can be tendered for completion in 2008 to meet the grant requirements. As recommended by Commission at their regular meeting on 2008-MAY-28, this conceptual vision was presented to the public at a second open house on 2008-JUN-12. Public input was favorable for the overall park vision and Spirit Square.

Both open houses were advertised twelve (12) times each as display ads in three of the local papers. Eight large signs were placed in the park well in advance of the open houses to alert park users to the events. Press notices were also sent out to the local papers, television and radio stations.

Detailed design and construction drawing preparation will begin once the improvement plan and Spirit Square location are approved by Council. The detailed design process will continue throughout the summer and tendering for the construction of the Spirit Square will be conducted this fall. Further development of Maffeo Sutton Park will occur in multiple phases as allocated through the Capital Budget process.

The following highlights are the park initiatives for May 2008. Regular maintenance tasks are not listed.

PARK DEVELOPMENT AND SPECIAL PROJECTS

- A second open house for the Maffeo Sutton Park redevelopment project was held 2008-JUN-12 at Bowen Park. The new site plan has been presented to key stakeholders including the Nanaimo Port Authority, Snuneymuxw First Nations, Department of Fisheries and Oceans, Nanaimo Lions Club and City staff.
- Two summer students have joined the Park Operations team. One is currently working on interpretive signage for Oliver Woods Community Centre and the Bowen Park Side Channel trail. The other is assisting in the Community Plan for Public Art and the Urban Forest Plan.

VOLUNTEER IN PARKS (VIP)

- The grand opening of the DIGS Community Garden was held 2008-MAY-25 with about 100 people in attendance.
- A VIP newsletter has been circulated to all volunteers in the various facets of the program to celebrate accomplishments and communicate all the VIP activities. The newsletter was also posted on the City website.
- Tree planting has occurred at Carmanah Park and an RFP for playground equipment has been submitted to vendors for response.
- New playground equipment for Nob Hill Park has been ordered. The neighbourhood installation is scheduled for 2008-SEP-20. Signs detailing the upcoming park improvements have been placed on site.
- The Gyro Club have pledged \$20,000 toward the multi-use court development at Deverill Square Park. The new playground will be constructed in the fall of 2008 with the sport court being anticipated for 2009.

SPORTS, TOURISM AND OUTDOOR EVENTS

Recreation Coordinator Highlights

- Hiking programs continue to be very popular and all sessions are full. Additional classes are being added to accommodate waitlists.
- Community Hoops has 60 people registered. This is a community partnership with Vancouver Island University.
- Parks Day is planned 2008-JUL-19 in Bowen Park with community agencies invited to participate. Entertainment, salmon BBQ, interpretive tours and free activities will be offered for all ages.
- Staff met with Wayne Pealo, Recreation Management Program, and other instructors from Vancouver Island University to discuss future opportunities for students with interpretive projects and research-based projects in Bowen Park.

Manager of Sports Tourism and Outdoor Events Highlights

- Sport & Cultural Tourism contacts this month include: Marine Festival, VICC Grand Opening, Gutbuster Half Marathon, Harbour City Half Marathon, Cultural Capital projects, V.I. Raiders Football, White Rapids Swim Club, Dragon Boat Festival.
- Staff met with the Vancouver Island Raiders to discuss continued use of Caledonia Park (temporary storage and press box) and Harewood Field (field fix-up and storage).
- Staff met with VIEX, Marine Festival, Dragon Boat and RCMP to discuss 2008 Beer Gardens.
- Work continues on implementing the fees and charges for Live Site use. There has been quite a bit of interest from community organizations wanting to access the screen.

TRAIL DEVELOPMENT

- The stairs and boardwalks at Jack Point Park are being replaced where needed. One set of stairs has been completely replaced with the remainder to be completed by the end of the month.
- Sections of the Parkway Trail have been cut and repaved where tree roots have caused damage.
- Spring brush cutting of all trails is underway and will continue until the end of the month and then repeated in July.

MAINTENANCE AND CONSTRUCTION

- Rotary Field House is progressing well. The building is now at lock-up stage, with doors and windows now installed. Electricians, mechanical, plumbing, heating and other sub-trade contractors are well underway with completion scheduled for August.
- A kayak storage rack and an equipment cupboard have been added to the Brechin Community Paddling Dock. The Auxiliary Coast Guard are now operating out of the new boat house and are looking forward to the grand opening of both facilities.
- Loudon Park Development has been completed for this year. The canoe and kayak float has been relocated and the new accessible fishing dock and connecting walkways have been installed. The fishing dock has been well used (with reports of trout being caught). Two gates have been installed at the entrance to the new parking lot to help secure the area at night and a mural will be painted on two sides of the existing washroom building (when the weather improves).
- The Nanaimo Lions Club signs have been replaced to complete the upgrades at the Bowen and Harewood Lacrosse boxes.

UTILITY

The broken concrete slabs around the Swy-a-Lana Lagoon have been replaced.



- New float ropes have been installed at Loudon Park, Westwood Lake and Brannen Lake.
- The new swim raft and floats at Departure Bay beach have been installed for the summer.
- An irrigation line was installed at Loudon Park parking lot.
- Irrigation was also installed on both sides of the Cliff Street entrance to Maffeo Sutton Park.
- Irrigation was installed for 5 planters at the entrance to Serauxmen Sports Fields.
- 500' of vandalized irrigation wiring was replaced at Duke Point.
- The spring ditching program was completed at Bowen Park, Elaine Hamilton Park and Westwood Lake Park.

HORTICULTURE AND SPORTS FIELDS

- Horticulture crews have installed annual flower displays. Cool weather this year is slowing plant growth.
- Summer planters were installed downtown after the long weekend.
- Cool weather has made ideal conditions for turf grass growth and crews have had to cut most downtown parks twice per week this season.
- City gardeners designed the annual plantings and some of the foundation plantings for the Vancouver Island Conference Centre.

TURF AND PARKS

- Two neighbourhood parks, Carmanah Way Park and Shadow Mountain Park were cleaned of debris, rotodaironed, levelled up and re-seeded.
- The beach clean-up was done at Departure Bay by Graf Excavating and everything looks good.
- With the excessive rainfall, grass cutting has been a challenge with most fields requiring 2-3 cuts a week.

URBAN FORESTRY

- Seventy-four phone calls regarding tree issues were received, resulting in fifty-five site visits.
- Seven Tree Removal Permits were approved for various sites.
- Six Tree Management Plans are under review.
- Work is in process on the Urban Forest Plan, with two Open Houses scheduled for the end of June. The first will be at Oliver Woods Community Centre on 2008-JUN-24 and the second on 2008-JUN-26 at the Maffeo Sutton Park Pavilion.
- Tree planting on Victoria Road and Dawes Street is completed.
- 26 columnar purple beech trees were planted at the Cliff Street entrance to Maffeo Sutton Park.

PROGRAMS

Swimming lessons had 451 people enrolled in May, compared to 423 in 2007. The Nanaimo Riptides hosted 250 swimmers at their long course invitational swim meet at Nanaimo Aquatic Centre (NAC) on 2008-MAY-24 and 25. Extra length swimming was offered at Beban during the meet to accommodate customers from NAC. The Nanaimo White Rapids Swim Team is once again operating the Kin Pool, which is now open for the season.

Throughout May, 47% of the total arena hours booked were ice bookings at Cliff McNabb which accounted for 40% of May arena attendance.

Oliver Woods Community Centre (OWCC) has now been operational for 16 weeks. An evaluation of registered programs indicates that Preschool and Youth programs account for 44% of registration, Adult Fitness 37%, Adult Arts and Culture 10%, Seniors 5%, and Special Needs and drop-in 4%. Birthday parties are proving very popular at OWCC. Afterschool Care will expand to OWCC in the fall.

Summer staff was hired and completed an orientation at OWCC on 2008-JUN-02. Because of new safety regulations concerning 15 passenger vans, summer daycamps activities will focus more on intown trips rather than out of town attractions.

Arts Alive registration began 2008-MAY-01 and now has 334 registered participants.

PROJECTS

A movie held at NAC during youth week encouraged positive interaction between youth and lifeguards. The success of this event led to the development of Youth Only Nights planned at NAC in the fall. A youth resource guide will be distributed to youth prior to the end of the school year.

Cleaning products at some facilities are being changed to "green" products.

OWCC playground opening is anticipated for mid-June. Banner arms and banners have been installed on parking lot light posts.
