#### EXECUTIVE SUMMARY:

The Vancouver Island Symphony and TheatreOne organizations had requested multi-year funding through the Cultural Operating Grant. The Cultural Operating Grant guidelines permits approval of longer term funding to be established for not-for-profit professional arts organizations. That request can be for up to three years, or for the current length of the term remaining for the existing Council, whichever is shorter.

#### **BACKGROUND:**

Both the Vancouver Island Symphony and TheatreOne organizations were interviewed by the Cultural Committee. Each organization has received funding through this grant during the past several years. TheatreOne has recently had a significant change in their Board and staff team. The Board is exploring new options and the achievement of the Society's objectives. The Parks, Recreation and Culture Commission, through its Culture Committee, reviewed these requests in detail and made the above recommendations at their meeting held 2007-JAN-24.

## STAFF REPORT

RE: 2007 LOCALMOTION GRANT APPLICATION

#### STAFF'S RECOMMENDATION:

That Council authorizes the grant applications to the Provincial LocalMotion Program for the Terminal Park Intersection/Terminal Park Access and the Mostar Connector Trail.

#### **EXECUTIVE SUMMARY:**

At the 2006 UBCM Convention, Premier Campbell announced new funding programs for Local Government to access. The LocalMotion program is a \$40 million fund that will provide \$10 million over a four year time frame. The program funds capital projects in a 50:50 cost sharing arrangement based on the total cost of the project. The maximum amount a local government can receive under the LocalMotion program is \$1 million per year.

The program supports applications for capital projects that encourage improved physical fitness, reduced risk of traffic crashes, reduced air pollutants and meets the diverse needs of seniors, young families and all British Columbians. Construction projects such as bike paths, walkways, greenways and improved access for people with disabilities qualify.

#### BACKGROUND:

The City of Nanaimo continues to be proactive in working towards many of the criteria of the LocalMotion program through development of infrastructure that encourages physical activity, increases the safety of our cyclists and pedestrians, reduces pollution in our community, and meets the diverse needs of our residents and visitors. Two capital works projects, the Terminal Park Intersection/Terminal Park Access and the Mostar Trail Connector, have been identified as capital projects that support these criteria and qualify for submission under the LocalMotion grant program.

The Terminal Park Intersection capital project will include the installation of a fully actuated traffic signal and pedestrian signal where Terminal Avenue meets Terminal Park Mall. Lighting will be installed at the intersection and along the E&N Trail to improve the visibility of pedestrians and cyclists. The capital upgrade will increase pedestrian and cycle safety, encourage physical activity in the community and minimize the risk for accidents.

The Mostar Trail Project, an 800 metre trail in length, will run on the west side of Mostar Road and link the E&N and Parkway multi-purpose Trails. Mostar is a heavily traveled road with vehicle transport accessing the Nanaimo Parkway and the north end commercial, industrial and residential districts of the community. In addition to this 3 metre wide trail connector, a 1.5 metre wide sidewalk will be added on the east side of Mostar. The works are to be built in conjunction with left

turn lane construction on Mostar Road at Boban Drive and roadway widening on Mostar Road between Boban Drive and Jordan Avenue. This project will improve safety for pedestrians, cyclists and commuters, while encouraging increased recreational and pedestrian use.

The estimated total project cost for the Terminal Park Intersection/Terminal Park Access is \$341,625 and \$298,750 for the Mostar Trail Connector. The LocalMotion program will fund up to 50% of these project costs should the applications be approved. Both projects are currently in City Council's 2007 Capital Budget. The application deadline for the LocalMotion program is 2007-FEB-16.

RE: 2007 SPIRIT SQUARES GRANT APPLICATION

#### STAFF'S RECOMMENDATION

That Council authorizes the grant applications for the Spirit Squares Program for the planning and design of Maffeo Sutton Spirit Square and Piper Spirit Square.

#### **EXECUTIVE SUMMARY:**

At the 2006 UBCM Convention, Premier Campbell announced new funding programs for Local Government to access. The Spirit Squares Program provides for phased allocation of funds. \$50,000 is available to local government in Phase 1 to assist in the planning and design of a community Spirit Square. Upon completion of Phase 1 the community can apply for Phase 2 capital funding of up to \$500,000 per Spirit Square for a maximum of two Spirit Squares.

To celebrate British Columbia's 150<sup>th</sup> anniversary of its founding as a Crown Colony, the program encourages applications for development or redevelopment of a park or plaza to create a community gathering place that is open and welcome to all. The Spirit Square is intended to enhance the social, cultural and economic life of the community while building on its history and natural features. The area will allow residents and visitors to play, browse, shop, entertain and be entertained.

#### BACKGROUND:

With the downtown revitalization project underway, the City of Nanaimo is re-developing two civic spaces, Maffeo-Sutton Park and Pipers Park. These parks embody the concept of the Spirit Square and qualify for application under Phase 1 for planning and design of the Spirit Square program with a future submission into Phase 2 for capital funding.

The Maffeo Sutton Spirit Square project will see a redeveloped and improved community and events gathering place. The redevelopment will help celebrate the history and heritage of our community by bringing people together in the park through special events, public art displays and historical and cultural interpretation. It will also improve the interface of the park with commercial areas of the downtown core. The vision for the Maffeo Sutton Spirit Square is to accommodate a wide range of activities in the park that support our City while creating a unique identity for the waterfront and downtown.

Built in the 1900s, and one of the first parks in Nanaimo, the Piper Spirit Square project will build on the history and heritage of our community. Piper Park is nestled between the location of the new Vancouver Island Conference Centre and the Nanaimo Harbour. The vision for Piper Park is to create an attractive downtown park that interfaces with adjacent facilities while being physically

and visually linked to the waterfront and downtown. It will be a community gathering place and location for community events while incorporating public art and historical interpretation within the park.

The City has set aside \$1,650,000 for the planning, design and construction of the Maffeo Sutton Spirit Square and \$520,000 respectively for the Piper Spirit Square. In Phase 1, the Spirit Squares Program will fund up to \$50,000 for the planning and design costs should the applications be approved, with a requirement to submit additional applications for Phase 2 funding for the construction costs of the squares. Both projects are currently in City Council's 2008 Capital Budget. The application deadline for Phase 1 of the Spirit Squares program is 2007-FEB-16.
