- What are the gaps and how to mobilize services
- Action plan to end homelessness and housing strategies
- Setting priorities based on asset mapping and gap analysis
- Point in Time Count
- Coordinating vision between service providers
- Health assets and resources
- Increasing detox and treatment beds
- Youth and indigenous people
- The Ministry of Mental Health and Addictions “A Pathway to Hope”

- Ideas gathered through design labs and online surveys and summits held
- Challenges not anticipated
- Developing a backbone organization
- Subcommittees struck
- Location of supportive housing development and negative community feedback
- Importance of starting public engagement early

- Community feedback and compassion fatigue
- The communication strategy
- Early public engagement and consultation
