1. CALL THE PUBLIC SAFETY COMMITTEE MEETING TO ORDER:

The Public Safety Committee Meeting was called to order at 3:31 p.m.

2. <u>INTRODUCTION OF LATE ITEMS</u>:

- (a) Agenda Item 6(b) Community Engagement Task Force correct agenda heading to Direction from Council: Councillor Armstrong re: Safety Concerns Related to Schools and Playgrounds (Discussion from Special Council Meeting 2018-JAN-22) and add delegation from Katherine Rollwagen.
- (b) Add Agenda Item 7(b) Correspondence from Zoe Ann Larsen, dated 2018-FEB-26, regarding homelessness and derelict buildings downtown.
- (c) David Lemire advised that he would be bringing forward an item under Agenda Item 7 Other Business, regarding Discussion Regarding Modular Housing Process.
- (d) Councillor Armstrong advised that Alison Evans was in attendance and wished to address the Public Safety Committee as a late delegation regarding Agenda Item 6(b)
 Direction from Council: Councillor Armstrong re: Safety Concerns Related to Schools and Playgrounds (Discussion from Special Council Meeting 2018-JAN-22).

It was moved and seconded that Agenda Item 7(a) - Correspondence from Zoe Ann Larsen, dated 2018-FEB-26, regarding homelessness and derelict buildings downtown, be added to the Public Safety Committee Agenda, 2018-MAR-01. The motion carried unanimously.

It was moved and seconded that Agenda Item 7(b) – Discussion Regarding Modular Home Process be added to the Public Safety Committee Agenda, 2018-MAR-01. The motion carried unanimously.

It was moved and seconded that Alison Evans be permitted to address the Public Safety Committee as a late delegation regarding Agenda Item 6(b) - Direction from Council: Councillor Armstrong re: Safety Concerns Related to Schools and Playgrounds (Discussion from Special Council Meeting 2018-JAN-22) with a five-minute time limitation. The motion carried unanimously.

3. <u>ADOPTION OF AGENDA:</u>

It was moved and seconded that the Agenda, as amended, be adopted. The motion carried unanimously.

4. <u>ADOPTION OF MINUTES:</u>

It was moved and seconded that the Minutes of the Public Safety Committee Meeting held in the Boardroom, Service and Resource Centre, 411 Dunsmuir Street, Nanaimo, BC, Thursday, 2018-FEB-01, at 3:30 p.m. be adopted as circulated. The motion carried unanimously.

5. REPORTS:

(a) Community Engagement Session February 28, 2018

Karen Fry, Fire Chief and Director of Public Safety, provided a verbal update regarding the Community Engagement Session held February 28, 2018, and provided a presentation regarding Strategic Plan Update 2016 – 2019 and how it is linked to committee priorities.

Committee discussion took place regarding suggestions from the public surrounding safety concerns from the public safety engagement session and the pros and cons associated with these suggestions. It was recommended that any roadblocks to proposed ideas be explained so that people know why these suggestions where not pursued.

Karen Fry, Fire Chief and Director of Public Safety, advised that once the summary of the engagement session is compiled the Public Safety Committee will be provided a copy prior to their next meeting.

(b) Direction from Council: Councillor Armstrong re: Safety Concerns Related to Schools and Playgrounds (Discussion from Special Council Meeting 2018-JAN-22)

Introduced by Karen Fry, Fire Chief and Director of Public Safety.

Committee discussion took place regarding the following motion that Council requested the Public Safety Committee reword:

"It was moved and seconded that Council direct Staff to:

- identify schools, parks and spaces that experience a high volume of drug paraphernalia, feces, urine, condoms and other associated debris;
- develop resources to address these issues and security issues; and,
- explore the option of implementing a contract with the John Howard Society for needle pick up at Ecole Pauline Haarer Elementary School."

Committee discussion took place regarding the third bullet item. It was noted that the third bullet should be deferred to School District 68. Discussion took place regarding possible motions the committee could put forward to explore working with School District 68 regarding needle pick up and increased security measures around schools within the City.

Delegations:

- 1. Katherine Rollwagen spoke regarding actions taken to address safety concerns in parks and playground at Pauline Haarer Elementary School, the impact this is having on the perception of the park, and the changes made to facilities at the school.
- 2. Alison Evans spoke regarding Comox Park, the amount of needles present and other concerns which affect the safety of children.

It was moved and seconded that Rick Hyne be permitted to address the Public Safety Committee regarding Agenda Item 6(b) - Direction from Council: Councillor Armstrong re: Safety Concerns Related to Schools and Playgrounds (Discussion from Special Council Meeting 2018-JAN-22) with a five minute time limit. The motion carried unanimously.

 Rick Hyne requested that the Public Safety Committee act on facts and not emotional reactions when considering how to assist with homelessness and needle safety.

Karen Fry, Fire Chief and Director of Public Safety, spoke regarding the changing perceptions and education paths relating to drug users and homelessness.

J. Horn entered the Boardroom at 4:10 p.m.

John Horn, Social Planner, spoke regarding a previous attempt to operate an open space type of shelter and the issues that arose from that.

Committee discussion took place regarding the amount of needles being picked up on a daily basis. Karen Fry, Fire Chief and Director of Public Safety, spoke regarding the amount of calls the fire department received in 2017 compared with 2018. Drug use is a complex problem and is becoming more apparent. Approximately 1200 people within the community are intravenous drug users according to Island Health estimates. It is estimated that 240 needles are picked up per week.

Committee discussion took place regarding the need to prioritize strategies and work with various resources to develop a strategy to deal with the social issues facing Nanaimo.

Committee discussion took place regarding a report from John Horn, Social Planner, titled "Responses to Health, Social, and Safety Issues Downtown" that is scheduled to be presented to Council at the Finance and Audit Committee Meeting, 2018-MAR-14.

The Public Safety Committee requested that Staff provide the committee with a list of current hot spots within the City of Nanaimo.

It was noted that the Public Safety Committee encourages Council to continue to prioritize and consider the report scheduled for the Finance and Audit Committee Meeting, 2018-MAR-14, titled "Responses to Health, Social, and Safety Issues Downtown".

The Public Safety Committee requested to receive a copy of the report titled "Responses to Health, Social, and Safety Issues Downtown" as soon as it becomes available, and prior to the beginning of the next Public Safety Committee Meeting.

6. OTHER BUSINESS:

(a) Correspondence from Zoe Ann Larsen, dated 2018-FEB-26, regarding homelessness and derelict buildings downtown

Karen Fry, Fire Chief and Director of Public Safety, spoke regarding the removal of camps and a fire set outside of the former A&B Sound building downtown. She explained that an order has been sent to the owners of the building. The order requires the owner to secure the alcoves, to have a structural engineer ensure the structure is sound, to ensure there are no hazardous materials inside the building, and to keep it secure.

G. Whitters vacated the Boardroom at 4:35 p.m.

(b) Discussion Regarding Modular Housing Process

David Lemire requested an update regarding the Modular Housing Process after Council decided not to proceed with the Cranberry Avenue location during the Regular Council Meeting 2018-FEB-19.

Councillor Armstrong spoke about the public engagement efforts that Staff are doing to try to gain feedback about the modular housing proposal.

John Horn, Social Planner, explained that his understanding of the criteria for the proposed development has changed, and this changes his interpretation of what type of clients would be housed in the building. There still may be an opportunity to proceed with the Modular Housing Process, but a suitable location has not been selected.

It was requested that the Public Safety Committee be updated if there are any changes relating to the Modular Housing Process.

7. QUESITON PERIOD:

It was moved and seconded that Dean Gaudry, Owner, Greenrock Liquor Store, be permitted to speak regarding licencing of recreational marijuana businesses, with a five minute time limit. The motion carried unanimously.

1. Dean Gaudry, Owner, Greenrock Liquor Store, spoke regarding concerns for the distribution and licencing of recreational marijuana businesses, and suggested that the City use the model that is currently in place for liquor licences in Nanaimo as a template for processing recreational marijuana business licence applications.

Committee discussion took place regarding how current dispensaries could expand with the proposed legalization of recreational marijuana. It was suggested that zoning regulations will need to be reviewed regarding the production and growing of marijuana products.

8. <u>ADJOURNMENT:</u>

It was moved and seconded at 5:00 p.m. that the meeting terminate. The motion carried unanimously.

City of Nanaimo Public Safety Engagement Session Final Report

Date: March 28, 2018

Background

The City of Nanaimo, with the support of graduate students from Vancouver Island University's Master of Community Planning Program, conducted a Public Safety Engagement Session on February 28th, 2018 at Beban Park Auditorium.

The session was held using a modified World Café method with assigned topics on 12 tables. This method was selected as it encourages conversations among participants instead of the one-way flow of information characteristic of a public hearing or town hall-style event; this is a method best used to scope out issues or discuss a range of potential solutions.

Students staffed each table as facilitators and note takers, and also served as the lead facilitators for the event. The table themes/topics included:

- City Bylaws
- Emergency Management
- Future of the Community Policing and Services Office (this theme was established before recent decisions were made on this location)
- RCMP Priorities
- Public Safety Education
- Home Safety
- Empty and Derelict Buildings
- Public Disorder.

There was also a "Wild Card" table that was intended to attract participants who were interested in discussing topics outside of those identified for the event.

The event was divided into four timed segments: the first two (approximately 20 minute) segments sought to identify *issues* relating to each table topic, while the second two segments related to discussing potential *solutions*. Participants were invited to join a first table discussion and were then free to move to any other topic or to stay at their original table.

Approximately 65 individuals attended the event, which was also supported by staff from the City of Nanaimo as well as representatives of Island Health, the RCMP, various social agencies, and members of Nanaimo City Council. These expert attendees were stationed at the various tables and were available to respond to questions from the participants.

Findings

Appendices 1 and 2 detail the findings from the table discussions and the facilitated reporting back to the plenary at the end of the event.

A key word/phrase analysis was conducted for each of the topics/themes from all of the findings (note that Home Safety is not included as there were no participants at that table).

Conclusions

There was general discussion at many of the tables indicating that the issues identified were not going to be resolved at a two-hour event. It was also noted at several tables that many of the issues are interrelated, and any solutions will have to consider the range of potential impacts that could result from implementing changes. Overall, there were positive comments on the format of the meeting and support for holding future events that encourage exchanges of ideas over more adversarial meeting methods.

Recommendation

1. That the findings from this event be provided to the Public Safety Task Force for review and consideration.

CITY OF NANAIMO PARKS AND RECREATION

HOMELESSNESS ISSUES & GARBAGE CONCERNS

Parks and Recreation is responsible for maintaining 1,200 hectares of parkland, over 120 km of trails, grounds at City Hall & SARC, and portions of the downtown including Diana Krall Plaza, etc., as well as all recreation centres throughout the City of Nanaimo.

2017 saw an increase in volume of garbage collected, numbers of needles removed, and the amount of vandalism and break-ins. It also saw an increase in negative interactions with the transient population. This continues to have an impact on workload for both staff and an increased reliance on contractors. With the increasing homeless population in Nanaimo, presence of homeless in parks has increased significantly.

The following is a summary of how garbage, sharps, encampments, and vandalism are handled by the Parks and Recreation department.

STAFF RESOURCES

Within the Parks and Recreation Department, the need for sharps and garbage clean up vary by area.

- 25 Parks Operations staff are trained and do clean up on a daily basis. There are an additional 10 seasonal staff through the summer that are also involved in the clean up.
- On the Recreation Services side of the department, finding needles is less common, especially since the installation of the needle boxes in the recreation centres. All Facility Operations staff, Custodians and Lifeguards will do needle clean up on an as-needed basis.

Parks & Recreation make needle clean-up their number #1 priority at all times. Staff will attend as soon as possible once a needle(s) is reported or sighted.

STAFF TRAINING & ACCESS

- Sharps disposal and garbage are discussed formally monthly at tailgates.
- Sharps containers are at every staff location, every parks vehicle (including lawnmowers, tractors, etc.), and a minimum of one per recreation centre in staff areas. These sharps containers are disposed of at Harris House.
- Documentation provided to staff including the sharps containers map, information on disposal, safework procedures, etc.
- PPE provided through managers & Stores Personal protective equipment gloves, sharps-rated gloves, sharps containers, tongs, etc.
- All staff are able to receive the Twinrix vaccine. Personal choice, but most staff who have interaction with Bloodborne Pathogens have taken advantage of the program.

QUICK FACTS – P&R department

- 424 garbage cans in parks
- Daily clean up in the downtown core (& Comox Park)

Changes in 2017

CPTED – Crime Prevention Through Environmental Design

Parks and Recreation staff have been employing CPTED principles throughout parkland and around recreation centres to reduce issues. CPTED is the design, maintenance, and use of built environment in order to enhance quality of life and to reduce both the incidence and fear of crime.

- Measures have been mainly taken with improvements to lighting and vegetation measures. Both measures have taken steps to remove areas that offer concealment or hiding spots and to increase visibility, allowing the public to observe their surroundings more easily.
- Principle of Territoriality, designating clearly the start of parkland, have been employed at areas such as Deverill Square Gyro Park with children's artwork placed on the perimeter fencing.
- Prompt repair of vandalism or removal of graffiti: P&R staff deal with the issues promptly to display that the property is maintained and unwanted behavior is not permitted.
- Irrigation: Staff have employed the use of irrigation to deter stopping in downtown park areas due to safety concerns. Grass will be made wet, making it uncomfortable for someone to stop and rest on.

Meetings

Parks and Recreation staff meet bi-annually with RCMP, Bylaws, Animal Control and others to discuss and mitigate ongoing issues and discuss trends and prevention methods.

CONTRACTOR SERVICES

GARBAGE CONTRACT

Public garbage cans are provided throughout City parkland and trails. All **424 garbage cans** are serviced by a contractor. Cans are serviced based on location and volume from a weekly service to a daily servicing. The contractor also picks up any litter debris in a 3m radius of the can and will remove any graffiti on cans. Any other issues are reported promptly (same day) to the Parks Operations staff. **Needles are picked up by this contractor on a routine basis.**

ON DEMAND FOR ENCAMPMENT & CONTAMINATED DEBRIS

Encampments, once cleared with the assistance of the Bylaw Department, are mainly cleaned up by a contractor. Staff have now also been utilizing contractors when there is the risk of the transient debris being contaminated with drug powder and/or needles.

Work has been split between Acer Landscaping and Lone Pine Landscaping. Both companies have experience in removing the debris and will use equipment/machines where needed.

SHARPS DISPOSAL UNITS

There are now 34 units provided by Parks and Recreation divided by 22 units in 8 recreation centres, 7 units on parkland, and 5 units in the city-operated Community Services Building. Five units in parks had to be replaced with heavier duty anti-vandalism units after several thefts and tampering incidents. These units are serviced by a contractor, with a minimum of a monthly basis, depending on season and location.

JOHN HOWARD SOCIETY

PARKS OPERATIONS – Changes in Work Habits

Sweep of downtown parkland and gardens

The downtown grass crew routinely did a sweep of the downtown areas on a Monday. With ongoing issues, this was increased to a Monday / Friday sweep, then a 3-day a week sweep, and then a daily sweep. The clean up started to take too much time, so through the winter months, 1 staff person has been doing a daily sweep for a minimum of two hours, cleaning up needle debris and other garbage. Larger deposits of garbage are cleaned up by contractors. This amount of time spent on clean-up is not sustainable as we move into the busy summer season.

CHANGES AND TRENDS IN 2017 & 2018

LANDSCAPE HORTICULTURISTS

The Landscape Horticulturists have modified their work practices.

- Prior to starting work in a garden bed, depending on the size of the bed, they will devote 10 to 20 minutes doing a sweep for needles or other debris.
- Employees used to work in garden beds alone.
 Employees working downtown now work in pairs or teams.
- Work conducted in the early morning is now always done in teams.
- Modification of planting beds: Plantings are now spaced out more to reduce hidden areas. Types of plants have been switched to more streamline plants, reducing hiding spots.

PARKS CUSTODIANS

Significant changes have taken place for the Parks Custodians. Parks Custodians used to work graveyard shifts on their own. Custodians, as of January, now work in pairs and now work an early morning shift. Venting is being installed in their vehicles to reduce the risk of being exposed to noxious fumes and risk of exposure.

FACILITY CHANGES - Bowen East washrooms

Washrooms on the east side of Bowen Park have been closed since November 2017 due to vandalism and misuse. Transient populations were using it as a shelter at times throughout the day. Since closing, the locks have been snapped off 3 times.

This washroom is not the first to be locked due to vandalism. Staff have used it as deterrent and will either lock completely or shorten opening hours.

HOT SPOTS

Most of the worse areas are in the downtown core. Maffeo Sutton Park, Nob Hill Park, Diana Krall Plaza & Wharf St Loo, City Hall / SARC, Anchor Way, Piper Park, and Comox Gyro Park. Other areas checked daily are Robins Park, Beaufort Park, and Bowen Park along the Millstone River.

Issues in Maffeo Sutton Park are concentrated around areas that offer concealment and/or shelter, including, washrooms, Lions Pavilion, Memorial Wall, etc.

Issues with encampments occur in Caledonia Park, Comox Park, Bowen Park, Colliery Dam Park and May Richards Bennett Pioneer Park.

Parks Operations has been in the process of removing all dugouts to remove shelter areas. Issues with dugouts are focused at May Richards Bennett Pioneer Park and Sid Clark Gyro Park.

AGGRESSIVE BEHAVIOUR

The transient population is becoming increasingly aggressive and confrontational towards City staff members. There were several incidents this past summer with Parks Operations staff that were reported through the Violent Incident process. Staff were assaulted in a few incidents while they were in the process of cleaning up areas of the downtown. There have also been incidents with a transient group that have dogs at May Richards Bennett Pioneer Park. Other times, staff have been threatened and then vacated the area prior to further confrontation.

Needles are being jammed into toilet paper rolls, presenting a risk to staff and the public. Needles that are concealed and not found through the safety check have been sent flying when staff are operating weedeaters. A knife was found concealed in a washroom stall in Maffeo Sutton Park.

ACROSS PROPERTY LINES

Network connections and reporting structure built up with other private property owners with issues including, but not limited to, Regional District of Nanaimo, Island Corridor Foundation, Ministry of Transportation, Ministry of Transportation. These areas always prove challenging as the transient population seems to recognize where property lines start and end.

VOLUNTEER PROGRAMS

Volunteer programs have been utilized for assisting with the maintenance of parks for several years. In the past, volunteers were focused on cleaning up garbage and reducing invasive plants and reporting issues to Parks Operations. Interaction with "sharps" was broken glass. There is now concern from staff whether it is still safe to have these groups working in certain areas and we are currently looking at revising documents to include information about drug paraphernalia and exposure risk.

PARK AMBASSADORS

We have 12 active Park Ambassadors and 24 others who participate on a casual basis. Park Ambassadors are individuals who frequent a park or trail on a regular basis. Some of them will utilize sharps containers and clean up needles but that is not expected from them. Parks Operations will clean up as soon as they are reported.

ADOPT-A-PARK

We have 4 active Adopt-A-Park groups who are specifically looking after one park each and 4 other groups who are doing consistent work parties. Sharps containers are provided to them but there is no expectation to clean up needles or drug paraphernalia.

WORK PARTIES

Work Parties are one-off groups who wish to do a clean-up in our parks. These groups range from children to adults and various areas from woodland areas to beaches.
