1. CALL THE MEETING TO ORDER:

The Special Nanaimo Performing Arts Guild (the Guild) Meeting was called to order at 4:00 p.m.

2. ADOPTION OF AGENDA:

It was moved and seconded that the agenda be adopted. The motion carried unanimously.

3. PRESENTATIONS:

(a) Introduction of Guild Members

Introduced by Nikolina Vracar, Deputy Corporate Officer/Acting Chair.

Guild members and Staff briefly introduced themselves and outlined what they hoped to accomplish with the Guild.

(b) <u>Committee Orientation/Meeting Procedures</u>

N. Vracar, Deputy Corporate Officer/Acting Chair, provided an on-screen presentation included in the agenda package and outlined the role of the Guild, principles of decorum and meeting procedures.

(c) <u>Background - 25 Victoria Road/Old Victoria Arts Centre</u>

Adrienne Breen, Manager, Culture and Special Events, provided an on-screen presentation included in the agenda package advising the following:

- The Guild was established to oversee the Old Victoria Arts Centre (the OV) facility
- The City purchased the OV at 25 Victoria Road in May 2008
- There have been many upgrades to the facility including remediation of the face of the building, replacement of the roof, upgrade of the electrical panels/heating equipment, and replacement of the boiler.
 Pending work includes the front door threshold and new fencing along the front of the building
- The Interim Operating Agreement with Spotlight Academy was extended to 2025-MAR-23
- The OV is an attractive facility for users due to its downtown location, lighting grids and lights, sound system, stage, and reasonable cost to book

Guild and Staff discussion took place regarding the current model of operating the OV. Spotlight Academy is currently operating the OV under an Interim Operating Agreement. Spotlight Academy acts as the point person

for users of the OV, Allocations Staff, and contractors who need access to the space.

4. OTHER BUSINESS:

(a) <u>Draft 2025 Key Date Calendar</u>

N. Vracar, Deputy Corporate Officer/Acting Chair, provided an overview of the draft 2025 Key Date Calendar included in the agenda package.

It was moved and seconded that the "Nanaimo Performing Arts Guild Key Date Calendar – 2025" be adopted. The motion carried unanimously.

(b) Selection of Chair and Alternate Chair

N. Vracar, Deputy Corporate Officer/Acting Chair, invited the Guild members to volunteer for appointment as either the Chair or Alternate Chair of the Guild, and noted Chair training would be provided.

No Guild members sought appointment as the Chair; therefore, this topic will be added to the next meeting agenda.

It was moved and seconded that Jason Friesen be appointed as Alternate Chair of the Nanaimo Performing Arts Guild for the term ending 2026-DEC-16. The motion carried unanimously.
