Water Audit 2017- Statistics

The City's inaugural water audit was undertaken by Kerr Wood Leidal Associates Ltd. (KWL) in 2012, and a second follow up water audit was carried out by KWL in 2017. In the five period between the two water audits, numerous significant changes were undertaken to the City's water treatment, water supply and distribution systems.


- South Fork Water Treatment Plant and associated supply mains.
- Reservoir Number 1, the Energy Recovery Facility and associated supply mains.
- Numerous new water distribution mains to accommodate new developments and capital asset management replacement of old aging water pipelines, water meters and water service connections.
