RESPONSE TO HEALTH, SOCIAL SAFETY AND SECURITY ISSUES

BACKGROUND

Council Direction

- At the 2017-MAY-29 Public Hearing, Nanaimo City Council defeated the proposal to rezone 437 Wesley Street to allow a supervised consumption site
- Council directed Staff to prepare a report on short, medium and long-term responses to the concerns regarding social issues raised by residents at the Public Hearing

Consultation Process

- City Staff interviewed every merchant individually in the downtown core
- City held three open public forums: two for businesses, one for residents
- Ongoing dialogue with service providers, RCMP, Island Health, Bylaws, and School District

Top Concerns and Priorities of Businesses and Citizens

- Personal safety
- Cleanliness of city centre: garbage, discarded syringes
- Lack of information flow within the business community
- Petty theft and vandalism
- Public defecation/urination
- Open substance and alcohol use
- Extreme behaviours in public areas by inebriated/mentally ill individuals
- Congregations of users accompanied by aggressive and intimidating behaviours directed at shoppers, merchants, residents, and tourists
- Problematic public spaces (Diana Krall Plaza, Quennel Square!!!!!)

Current Responses

- Enhanced Footprints security patrols
- (9 am to 8 pm; 11 pm to 8 am)
- Enhanced clean up by Urban Clean-up Initiative (John Howard Society)
- Additional safe sharps disposal boxes
- Frequent RCMP patrols
