

EVENT CENTRE

Parking issue at 1 Port Drive

- The consultants report suggests that 100 VIP parking spots and existing on-street parking is sufficient to accommodate a potential influx of 1,500 customer parking spaces.
- 2 hour parking restrictions will mean that land surrounding the Southern Nanaimo Waterfront lands will likely have time limits increased to better accommodate event requirements.
- If the business plan is correct there could be an average of about 2 events per week.



EVENT CENTRE

For moderately larger events it has been estimated that
 1,500 customer parking spaces will be required.

- 75%-85% of this is to come from on-street parking in neighbourhoods surrounding the Event Center.
- This will use up almost all of the unused on -street parking in the southern portion of the South End Neighbourhood and the Nob Hill Neighbourhood.

Conflict Between This Bylaw and Zoning Bylaw.
 In the event of a conflict between this Bylaw and the Zoning Bylaw, the requirements of this Bylaw shall prevail.



STADIUMS, ARENAS, RINKS, SWIMMING POOLS, AND SIMILAR USES.



- REQUIRED NUMBER OF OFF-STREET PARKING SPACES
- 1 space for every 5 seats and 1 space per 5 square metres of playing surface and/or water surface area*



EVENT CENTRE

- Total seating capacity of 5700 may have less seats.
- Square footage of rink 1,579.47 square metres NHL size.
- 1 space for every 5 seats and 1 space per 5 square metres of playing surface and/or water surface area. *
- If NHL sized rink it would require 1,460 spaces



DOWNTOWN AREA

 At a previous Council meeting when this topic was brought forth, the Director of Community Development informed us, that rule did not apply for the downtown.
