SUBJECT PARTNERS IN PARKS REQUEST - LINLEY VALLEY DRIVE PARK

### **OVERVIEW**

### **Purpose of Report**

To provide Council with background information on the Linley Valley Drive Park Partners in Parks (PIP) Program request for consideration and approval.

### Recommendation

That Council:

- 1. allocate \$30,000 from the Partners in Parks (PIP) Program for Linley Valley Drive Neighbourhood Park improvements; and,
- 2. consider a name change request proposed by the neighbourhood.

### **BACKGROUND**

Linley Valley Drive Neighbourhood Park is a 3.5 hectare undeveloped neighbourhood park and will be growing in size with future phases of the Linley Point subdivision. It was acquired by the City of Nanaimo through subdivision to meet the open space needs of the neighbourhood. The Park is split zoned with the environmentally-sensitive areas near the ponds zoned as nature park (PRC-1), and, a large open space reserved for the potential development of an active play area (PRC-2).

The Park is currently undeveloped and consists of two distinct areas. The lower (PRC-1) natural area has an existing walking trail winding alongside McGregor Creek and its restored ponds. The improvements are focused in the upper (PRC-2) area which is currently a cleared lot that is rapidly filling in with invasive plants.

After a neighborhood request to better utilize and beautify this public space, a PIP start-up meeting was held on 2016-FEB-23. Many families attended and indicated support for park improvements, including installation of a playground, with design elements that educate the public about the natural character of the setting.



Other requested improvements include:

- creating an intergenerational park and gathering place for the neighbourhood;
- installation of interpretive signage and fun painted stenciling to explain the natural features in the Park;
- green grass area with shade trees and a picnic area in the PRC-2 portion of the Park;
- play area for children (natural look with a pond theme) in the PRC-2 portion of the Park;
- trail around the play zones;
- consideration of a hard surface court in the PRC-2 portion of the Park;
- consideration of a picnic shelter in the PRC-2 portion of the Park;
- removal of invasive plants and signage about native plants; and,
- a park name sign.

This Park is split zoned and the location that the improvements are requested in is zoned PRC-2. It has been designated as such in anticipation of future active recreation amenities. This Park is more than a five-minute walk (400m distance) from the closest playgrounds at Malibu Park and Kenwill Park, as well as being across dividing roads (Lost Lake and Rutherford Roads).

The Park is located on Linley Valley Drive and, as such, has been initially named Linley Valley Drive Park. Suggestions of a more meaningful name to the neighbourhood have come up through neighbourhood discussions. Changing the name may also help to distinguish this Park from the properties in Linley Valley that were recently purchased by Council. Current Name suggestions are for Macgregor Creek Park. The Gyro Club of Nanaimo is currently working with the volunteers and their involvement may influence the park name, at a later date.

Funds from the PIP program are approved and allocated on a first-come, first-served basis. Currently, \$18,243 remains from the 2016 budget to support PIP program park development with a 2017 allocation of \$50,000.

If approved, a project account will be set aside for the Linley Valley Drive Park improvements. All disbursements from the account will be City-controlled, and the project will not start until all fundraising and in-kind support is confirmed.

### **OPTIONS**

- 1. That Council:
  - 1. allocate \$30,000 from the Partners in Parks (PIP) Program for Linley Valley Drive Neighbourhood Park improvements; and,
  - 2. consider a name change request proposed by the neighbourhood.
  - **Budget Implication:** The remaining 2016 budget is \$18,243 and the 2017 budget for the program is \$50,000.
  - **Engagement Implication:** Public engagement has already been completed in PIP community process.
  - **Strategic Priorities Implication:** Meets goals for Community building partnerships.



- 2. Deny the recommendation and budget allocation.
  - **Budget Implication:** Monies will remain in the PIP account from 2016 and for 2017.
  - **Engagement Implication:** Public engagement has already been completed in PIP community process and the efforts put in by the neighbourhood would be affected.
  - Strategic Priorities Implication: Momentum amongst community partners for the project may be lost.
- 3. Approve a varied budget allocation.
  - **Budget Implication:** There is \$18,243 remaining in the PIP account for 2016 projects and \$50,000 budgeted for 2017. If a lesser dollar figure is granted, the project will either be scaled back or neighbours will have to increase fundraising.
  - **Engagement Implication:** Public engagement has already started and residents are currently volunteering in PIP community process.
  - Strategic Priorities Implication: Meets goals for Community building partnerships.

### **SUMMARY POINTS**

- A collaborative concept plan has been developed for the neighborhood that will serve as a key neighborhood park development.
- Improvements are focused on the portion of Linley Valley Drive Park that is zoned PRC-2 (not in the nature park area).
- Improvements would be implemented with assistance from the PIP grant and from volunteer efforts and donations from the neighborhood and members of the Gyro Club.

### **OVERVIEW**

### **Purpose of Report**

To provide information to Council regarding opportunities to work with the Nanaimo branch of the BC SPCA and the Ministry of Transportation as it relates to opportunities for directional signage to the SPCA from Highway 19.

### Recommendation

That the 154 Westwood Road - SPCA Signage Update report dated 2017-JAN-23 be received for information.

### **DISCUSSION**

At the Regular Council meeting of 2016-MAR-21, Council passed a resolution directing Staff to work with the Ministry of Transportation and Infrastructure (MOTI) and the BC SPCA as it relates to opportunities for directional signage to the SPCA from Highway 19 (Parkway) (Attachment A).

Staff contacted SPCA staff (Leon Davis) 2016-APR-14 to ascertain support for working toward directional signage along the Parkway, which falls under MOTI jurisdiction. SPCA staff was supportive for pursuing opportunities for directional signage along this roadway.

Following this direction, City Staff sent a formal letter to MOTI 2016- APR -20 and followed up 2016-MAY-16 and 2016-NOV-8. Correspondence was received from Anika Johal, District Development Technician on 2016-NOV-22.

Ms. Johal's response indicated that signage for the SPCA Nanaimo branch does not fit within the guidelines for provincially regulated service and attraction signage. As a result, the Ministry would not be able to facilitate installing any type of directional or guiding signage along the Nanaimo Parkway. As a courtesy, the Ministry noted that the Nanaimo Parkway is currently under review for new regulations in efforts to clean up this corridor. The Ministry's objective is to reduce distractions and enhance driver safety along this major transportation route (Attachment B).

City Staff updated SPCA staff regarding MOTI not being able to facilitate signage placement along the Parkway. As a result, Staff discussed the opportunities of additional directional signage on City roads (East Wellington/Westwood/Jingle Pot). SPCA staff is supportive of pursing this opportunity, particularity at the Westwood Road /Jingle Pot Road intersection as



SPCA visitors indicate this turn off is the least recognizable and results in getting lost enroute to the facility (Attachment D).

The City of Nanaimo has a *Sign Policy - Third Party Directional Signage* which states no third party directional signage or other private signage will be approved or erected on or along City streets without the applicant firstly obtaining a MOTI/Tourism BC Signing Program permit. It is understood by Staff that the intention of the above-mentioned policy is to manage sign pollution.

Council can choose to direct Staff to disregard the standing City of Nanaimo Engineering and Public Works Department Policy for Third Party Directional Signage and proposed signage opportunities.

### **SUMMARY POINTS**

- MOTI does not support installing any type of directional or guiding signage along the Nanaimo Parkway.
- City of Nanaimo has a Sign Policy Third Party Directional Signage which states no third
  party directional signage or other private signage will be approved or erected on or along
  City streets.
- Council can direct Staff to disregard Sign Policy Third Party Directional Signage and pursue direction signage options for the SCPA specifically at the Jingle Pot and Westwood Road intersection.



## ATTACHMENT C MAP WITH POSSIBLE SIGN LOCATIONS ON CITY ROAD



### **OVERVIEW**

### **Purpose of Report**

To introduce the Nanaimo Deep Discovery Centre project to Council and to obtain Council support, in principle, to enable the proponent to advance their business plan and funding model.

### Recommendation

That Council:

- 1. support in principle the concept of a Nanaimo Deep Discovery Centre; and
- 2. defer any further discussions regarding City involvement in the project until such time that the proponents return to Council with a business plan and funding model.

### **BACKGROUND**

The Nanaimo Deep Discovery Centre (NDDC) is a proposed waterfront tourism attraction for downtown Nanaimo. The project was introduced to Council at the 2016-OCT-24 Special Open Council meeting.

The NDDC would be an interactive visitor centre located on the waterfront in Nanaimo. The centre would showcase deep sea technology, local marine ecology, and First Nations culture. Attachment A contains background information on the project.

The NDDC would be educational and include a range of displays and activities, some static, some 'virtual', some 'interactive' and some 'living'.

The NDDC would be a signature waterfront building on the waterfront and create a draw for local, regional, national and international tourists to the region. It will reflect on the history, engage the present and look to the future. No specific site for the project has been identified at this point in time.

The project is being promoted by the Nanaimo Deep Discovery Association (NDDA).

The NDDA is requesting a letter of support, in principle, from Council to allow the NDDA to pursue provincial, federal and private funding and other forms of support needed to move the project forward and make it a reality.



### **OPTIONS**

- 1. That Council:
  - 1. support in principle the concept of a Nanaimo Deep Discovery Centre; and
  - 2. defer any further discussions regarding City involvement in the project until such time that the proponents return to Council with a business plan and funding model.
    - Budget Implication: The NDDA is not seeking a financial commitment from the City at this point in time.
    - **Legal Implication:** A letter of support in principle for the project does not bind Council to further investments in the project.
    - **Engagement Implication:** With support in principle from Council, the NDDA will continue their community outreach.
    - **Strategic Priorities Implication:** The project supports the goals of enhanced economic health and cultural vitality.
    - Political Implication: Support for the project shows a commitment to diversifying the local economy and enhancing the downtown core and creating destinations for tourists.
- 2. That Council not support the project.

### **SUMMARY POINTS**

- The NDDC is a proposed tourist attraction for downtown Nanaimo. The centre would showcase deep sea technology, local marine ecology and First Nations culture.
- The project is being promoted by the NDDA.
- Council is being asked to provide support in principle. Council will not be asked to make any further decisions until the NDDA returns to Council with a business plan and funding model.
- No specific site has been identified for the project.
