





PURPOSE:

To obtain Commission and Council approval of the 2016 Temporary Public Art selections.

BACKGROUND:

At their meeting held on 2015-DEC-14, the Art in Public Places Working Group reviewed a total of thirty nine (39) Temporary Outdoor Public Art submissions, and selected nine (9) for recommendation to proceed.

DISCUSSION:

Temporary public art displays are a common method for municipalities to animate outdoor spaces and parks. Viewing of the changing art pieces provides people a reason to attend the parks and "check out" new pieces of art. Because the art pieces are not permanent, they can

also be conservative or controversial, yet advance public art programs at low cost to the municipality.

Since 2010, the City of Nanaimo has been involved in a dynamic and evolving temporary public art program that enhances and animates our City's parks. Each year, outdoor artwork by some of our region's Artists is installed on a temporary basis for the enjoyed of residents and visitors. The parks essentially become outdoor art galleries and showcase Artworks for a limited period of time.

In September 2015, the City of Nanaimo Purchasing Department issued a joint Call to Artists requesting submissions for temporary outdoor art. This call closed in 2015-NOV-17, with a total of twenty one (21) artists / teams from across Canada submitting thirty nine (39) project proposals for consideration.

Outdoor venues with a special emphasis on downtown parks and the Harbourfront Walkway are available to the artists and selected pieces will be installed in May 2016 during public art week.

On 2015-DEC-14, the seven-member review working group, comprised of representatives from the Culture and Heritage Commission; a local artist, member of the design community; a member of the Nanaimo Youth Advisory Committee; and City of Nanaimo staff, met to evaluate the submissions based on the following selection criteria:

- 1. Quality of the proposal.
- 2. Suitability and durability of the proposed work (i.e. its ability to withstand a year of external installation).
- 3. Ability of the proposal to meet public safety and vandalism consideration.
- 4. Addition of cultural vitality to the public space.

Based on the criteria, the Working Group recommends that the Nanaimo Culture and Heritage Commission recommend that Council approve the following 2016 Temporary Public Art selections, further detailed in Attachment A. The budget for the 2016 Temporary Public Art program is **\$24,000** with **\$6,000** remaining for installation costs above those covered by the artists.

The Nanaimo Poetry Map is a way to rethink and re-know your city. A map, generally speaking, imposes a system of knowledge upon a place as it shows the official names of streets and buildings and basically assists the reader to find a particular location. Nanaimo's poetry map will be different. This map is intended to encourage the reader to explore the city through poetry, to understand the experiences within it differently because of the poems.

Poetry on Buses:

The Poetry on Buses project began from an idea from Naomi Beth Wakan. The concept is to have up to three (3) poems displayed on all 49 public buses in Nanaimo. The City of Nanaimo, Regional District of Nanaimo Transit Authority and the Vancouver Island Regional Library will be partnering on this project.

A "Call for Poetry" will be announced in early January with the goal to obtain 50-100 short poems (50 words or less) consisting of 3-5 lines. The poems may also be collected and published in an anthology of poetry from the project using new technology at the VIRL downtown branch.

The goal is to have this project launched in early February and an event-type launch in April to celebrate Poetry Month (hosted by the VIRL Downtown Branch).





Public Art:

• CALL FOR ARTISTS NO. 1677 for 2016 Temporary Public Art:

A "Call for Artists" was issued on 2015-SEP-10. The process was open to all artists within British Columbia and across Canada to enter a submission. The City received a total of **21 artists** submitting their proposals, with a total of **39 different projects**. There is even representation of both local and artists from across Canada.

All projects were reviewed by the Art in Public Places Working Group, with selections for the 2016 season based on category, suitability and overall program budget. These recommendations will go to Council on 2016-JAN-18 for final approval. Once approved, successful artists will be notified, staff will begin arrangements for removal of 2015 artworks (at end of April), installation of 2016 artworks (in May during Public Art Week), and creation of the 2016 Temporary Public Art brochure.

• CALL FOR ARTISTS NO. 1699 for 2016/17 Street Banner Designs:

A "Call for Artists" was issued on 2015-NOV-17. The City of Nanaimo invites amateur and professional artists and graphic designers to enter a competition for the design of community street banners to be installed on lamp posts on major streets throughout the City of Nanaimo in the summer of 2016 and 2017.

The intent of this competition is to select a banner design which creatively reflect and/or inspire Nanaimo's Culture in Horticulture theme. (local Flora- is the plant life occurring in a particular region or time, generally the naturally occurring or indigenous—native plant life. Sometimes bacteria and fungi are also referred to as flora.)

This competition closes on 2016-JAN-08.

EVENTS:

2016 Culture and Heritage Awards:

The call for 2016 Culture & Heritage Award nominations closed on 2015-NOV-17. The public had the opportunity to nominate people in the following award categories; the Excellence in Culture, Honour in Culture, Emerging Cultural Leader and the John Thomson Heritage Memorial Award.

A total of thirteen (13) nominations were received in four categories: the Excellence in Culture, Honour in Culture, Emerging Cultural Leader and the John Thomson Heritage Memorial Award.

The Culture & Heritage Awards Working Group reviewed all nominations received for the various award categories and met to make their recommendations. These recommendations will go to Council on 2016-JAN-18 for final approval. Once approved, all nominators and recipients will be notified, and staff will begin arrangements for video and photo shoots.

• 2016 Culture and Heritage Awards Ceremony (2015-APR-13): The 2016 ceremony will be themed around Nanaimo's Future with much of the entertainment being youth performances. Dance performances will include those from Snuneymuxw, Vibe Dance, Brigadoon Dance Academy and music from the Wellington Jazz.

PROFESSIONAL DEVELOPMENT:

Beginning 2016-FEB-15, I will be beginning the Indigenous Training Core Certificate program. Core ICS Training is intended for non-health professionals working in organizations such as justice, policing, child and family services, education, business, and government. Learning will be self-paced over a 6-week window to complete. At the end of the training, I will receive a Core ICS certificate.

PURPOSE:

To provide an update to the Nanaimo Culture and Heritage Commission.

PROJECT UPDATES:

Heritage Interpretive Signs:

- Newcastle Pioneers working to develop a sign that incorporates Newcastle Heritage Walk brochure content as well as brief biographical information on notable early residents, including Victor Harrison (connected with 215 Newcastle Avenue) who was a local lawyer and mayor of Nanaimo. Finalizing draft. Preparing for sign manufacture.
- Wellington Pioneers/Jimmy Claxton (Early Black American baseball player born in Wellington) – Interpretive Sign for placement (Design and installation) – working to develop, in partnership with Wellington Neighbourhood Association and Nanaimo African Heritage Society, a sign that will provide information on the history of the Wellington Area, plus a special section on Jimmy Claxton and a few other notable Wellington residents. Working on draft with Community Archives, NAHS and Wellington Neighbourhood Association.
- Westwood Lake Heritage Interpretive Sign (Design and installation) working in partnerships with descendents of the Westwood family and the City's Parks, Rec & Environment Department, the sign will provide information on Westwood Lake park, its connection to the Westwood family, and the early settlement of Nanaimo. Currently gathering historical information to prepare initial draft.

Heritage Conservation Program Review and Update:

The Heritage Conservation Program Review and Update has commenced. The following key public engagement events that have been completed to date:

• SEPTEMBER 15 - Public Open House from 4:00 pm to 8:00 pm (drop-in) at the Nanaimo Museum. Drop-in, ask questions, review the display boards and learn about the City's current

heritage program, objectives of the update, and further opportunities for input. About 30 people attended. (Completed).

- SEPTEMBER 26 Mines & Yours: Honouring Heritage in Nanaimo (Pecha Kucha Night Nanaimo Vol. 2) from 7:30 pm to 10:00 pm at the Port Theatre. Facilitated by the Nanaimo Design Nerds. Close to 100 people attended. (Completed).
- OCTOBER 15 Identifying Heritage Values Workshop Facilitated by Heritage BC, 1-4:30 p.m. at the Vancouver Island Conference Centre (Nanaimo River Room) 26 people participated. (Completed).
- OCTOBER 15 Heritage Basics Presentation Facilitated by Heritage BC, 7-9 p.m. at the Museum. Around 20 people attended. (Completed)

The next phase of the public engagement process will focus on stakeholder interviews between December, 2015 and March, 2016.

If they attracted me to further explore the place they covered, I reasoned that those poems might well encourage others to explore Nanaimo, their hometown. "Why not put them on a map," I thought."

Self nominations will not be accepted. Federal or provincial elected representatives are not eligible for nominations while they hold office. Posthumous nominations will not be accepted.

HOW IS SOMEONE NOMINATED FOR THIS AWARD?

Any individual or group may nominate a current or former long-term resident of British Columbia by completing the attached nomination form or the online form and submitting it with:

- · A letter describing the contribution of the nominee;
- · A brief personal history of the nominee;
- Two current letters of support for the nominee from individuals or organizations that describe the value and impact of the nominee's contributions to his/her community.

HOW ARE THE AWARD RECIPIENTS CHOSEN?

An Advisory Council of independent community leaders reviews the nominations and selects approximately 30 award recipients. The Council will consider the impact of the nominee's contribution and commitment to the community.

In the Spring, recipients will attend a formal ceremony at Government House in Victoria. The Lieutenant Governor and the Premier of British Columbia are invited to present the recipients with the British Columbia Community Achievement Medallion, a special commemorative medallion designed by renowned BC artist, Robert Davidson. Also, recipients will receive a lapel pin signifying their award.
