The Regular Council Meeting was called to order at 4:12 p.m.

- (i) the receipt of advice that is subject to solicitor-client privilege, including communications necessary for that purpose;
- (k) negotiations and related discussions respecting the proposed provision of a municipal service that are at their preliminary stages and that, in the view of the Council, could reasonably be expected to harm the interests of the municipality if they were held in public; and,
- (n) the consideration of whether a Council meeting should be closed under a provision of this subsection or subsection (2).

- (b) <u>Point in Time Homeless Census</u>

Introduced by John Horn, Social Planner.

Signy Madden, United Way, John McCormick, John Howard Society, and Violet Hayes, Island Crisis Care Society, provided a presentation regarding the 2018 Point in Time Homeless Census in the City of Nanaimo.

(c) Nanaimo's Homelessness Coalition 5-Year Plan

Introduced by John Horn, Social Planner.

Signy Madden, United Way, John McCormick, John Howard Society, and Violet Hayes, Island Crisis Care Society, provided a presentation regarding the recently completed multi-year plan to end homelessness.

Delegations:

1. Darren Rinaldi spoke regarding homelessness in other countries, a potential injunction regarding Discontent City and advised he would like to see the City take bold steps to solve the problem in Nanaimo.

It was moved and seconded that Council receive the delegation from Darren Rinaldi regarding Nanaimo's Homelessness Coalition 5-Year Plan. The motion carried unanimously.

2. Amber McGrath spoke regarding the displacement and criminalization of the homeless and how homeless people will transition into affordable housing.

By unanimous consent Council permitted Kevin Donahue to speak instead of Noah Ross.

3. Kevin Donahue spoke regarding the housing vacancy rate in the City of Nanaimo, the reaction of the community regarding Discontent City and the limited affordable housing options for homeless in Nanaimo.

It was moved and seconded that Council accept all of the delegations regarding the Nanaimo Homelessness Coalition 5-year Plan. The motion carried unanimously.

It was moved and seconded that Council receive the Nanaimo Homelessness Coalition 5-year Plan report. The motion carried unanimously.

(d) Presentation from Jan Hastings, Nanaimo Recycling Exchange (NRE), Regarding Business Case

Jan Hastings, Executive Director, Nanaimo Recycling Exchange, and Ben Geselbracht provided a presentation regarding the business case for the Nanaimo Recycling Exchange.

The Council meeting recessed at 8:55 p.m. The Council meeting reconvened at 9:08 p.m.

Delegations:

- 1. Ian Gartshore spoke regarding Nanaimo Recycling Exchange's request to invest in its proposed Zero Waste Centre.
- 2. Tim McGrath spoke regarding the current garbage and recycling pick up and alterative uses for the funds.
- 3. Craig Cookman, Vancouver Island Recycling and Waste Industry Coalition, spoke regarding their support for the NRE in their position as an educator around recycling zero waste and advised that they do not support them as an operator or opposition of the private sector.
- 4. Arnold Erikson spoke regarding the services the private sector offers and advised he believes that the funding the NRE has requested should be spent elsewhere in the community.
- 5. Clint Thomson was not in attendance.
- 6. Mark Graf spoke regarding the importance of having a variety of locations throughout the City to drop off recyclables and in opposition to the potential tax increase if Council were to provide funding for the project.
- 7. Joe Mayzes was not in attendance.
- 8. Stacy Abbot spoke regarding recyclables in major facilities, challenging other facilities to attain zero waste and potentially having the NRE work out of private sector facilities.
- 9. Chris Sharpe spoke regarding his concerns with funds potentially provided to the NRE and how the recycling landscape and private business have evolved and developed over time.

Acting Mayor Thorpe asked for a second time if Joe Mayzes and Clint Thomson were in the audience and wished to speak. They were not in attendance.

It was moved and seconded that Council receive the delegations from Ian Gartshore, Tim McGrath, Craig Cookman, Arnold Erikson, Mark Graf, Stacy Abbot and Chris Sharpe regarding the Nanaimo Recycling Exchange. The motion carried unanimously. It was moved and seconded that an in depth legal review take place regarding the Nanaimo Recycling Exchange's request, prior to referring request to Staff. This will allow Council to be fully informed of the long-term legal and financial obligations. The motion carried unanimously.

7. <u>MAYOR'S REPORT</u>:

Acting Mayor Thorpe advised of three announcements:

- 1. The Greater Nanaimo Chamber of Commerce will be hosting Nanaimo Night Market which will run Thursday nights from 5 p.m. 9 p.m. starting Thursday, June 21, 2018 continuing until August 30, 2018 on Commercial Street from Terminal Avenue to Church and Chapel Streets. - 2. The City of Nanaimo's Sort Toss Roll program has been recognized in two award categories by the Solid Waste Association of North America (SWANA) in their 2018 Excellence Awards. SWANA describes the award winners as representing the most innovative and dynamic organizations throughout North America as judged by their peers. Acting Mayor Thorpe congratulated all the staff who worked on this project.
- 3. Acting Mayor Thorpe announced that the City of Nanaimo recognizes that we have an issue with homelessness, that there is a need for increased social housing, and read aloud the following statement authorized by Council:

The City of Nanaimo does not support the continuation of the Tent City at 1 Port Place. We are attempting to address the concerns of downtown residents and business owners. The City is currently seeking to secure alternative shelter options.

The City is taking a prudent and balanced approach to address the public concerns on the Tent City. The City urges any members of the public who have been negatively impacted by the Tent City, and who wish to make a sworn statement, to email our solicitors at <u>office@govlaw.ca.</u>

Counsel for the City of Nanaimo, Troy DeSouza, has advised that it is the City's intent to proceed to court during the last week of June, 2018. Mr. DeSouza has stated "The public will best be served by bringing this matter before a Justice of the Supreme Court of British Columbia to resolve the competing concerns."
