BYLAW NO. 5351.13

A BYLAW TO AMEND "BUSINESS LICENCE BYLAW 1998 NO. 5351"

WHEREAS pursuant to Section 8(6) of the *Community Charter*, as amended or re-enacted from time to time, Council may, by bylaw, regulate in relation to business;

AND WHEREAS the Council of the City of Nanaimo wishes to amend "Business Licence Bylaw 1998 No. 5351" to provide for the operation of mobile food vendors;

THEREFORE, BE IT RESOLVED that the Council of the City of Nanaimo in open meeting assembled, hereby ENACTS AS FOLLOWS:

1. Title

This Bylaw may be cited as "Business Licence Amendment Bylaw 2018 No. 5351.13".

2. Amendments

"Business Licence Bylaw 1998 No. 5351" is hereby amended as follows:

(1) By changing the wording in Subsection 8.7.3 (c) of Section 8, Regulations from "Food cart locations: annually, on a first come, first served basis" to the following:

"Food cart locations: daily, on a first come, first served basis."

(2) By deleting Table III in Schedule 'A' in its entirety and replacing with the following therefore:

- (3) By adding item (c) to Subsection 1.10 of Schedule 'E', Mobile Food Vending as follows:
- (c) Diana Krall Plaza: 7:00 a.m. to 3:00 a.m.
- (4) By deleting Subsection 2.12 of Schedule 'E', Mobile Food Vending in its entirety.
- (5) By changing the wording of item (iv) in Subsection 3.3 (a) Fixed Locations of Schedule 'E', Mobile Food Vending from:
- "City of Nanaimo parks as authorized by the Director of Parks, Recreation and Environment" to the following:
- "City of Nanaimo parks as authorized by the Director of Parks and Recreation"
- (6) By adding item (vi) to Subsection 3.3 (a) Fixed Locations of Schedule 'E', Mobile Food Vending as follows:
- "(vi) Specified parks in Table I of this Schedule".
- (7) By inserting in Subsection 3.3 (b) Special Zones of Schedule 'E' Mobile Food Vending, after "(i) Stewart Avenue – from Newcastle Avenue to Zorkin Road", as follows:
- "(ii) Queen Elizabeth Promenade"
- and renumbering the subsequent item in sequential order.
- (8) By changing the wording in Table 1 of Schedule 'E', Mobile Food Vending as follows:
- from "Table I – PERMITTED FOOD TRUCK & FOOD TRAILER LOCATIONS IN CITY PARKS" to "TABLE I – PERMITTED MOBILE FOOD VENDING LOCATIONS IN CITY PARKS" and,
 - from "At designated locations in the following city parks as authorized by the Director of Parks, Recreation and Environment" to "At designated locations in the following city parks as authorized by the Director of Parks and Recreation"
- (9) By adding the following in alphabetical order to Table I of Schedule 'E', Mobile Food Vending:

- (10) By deleting in its entirety "Map 1 On-Street Food Truck Locations" in Schedule 'E', Mobile Food Vending and replacing with the attached "Map 1 On-Street Food Truck Locations", which forms part of this bylaw.

This bylaw shall come into full force and effect immediately following adoption.
