(a) Additional Community Planning and Development Committee Meeting

Karin Kronstal, Social Planner, advised that an additional meeting at the end of the summer was needed to allow time for the Community Planning and Development Committee to consider the final draft of the Affordable Housing Strategy document for endorsement to Council. The dates suggested for this extra meeting were Tuesday, 2018-AUG-28 or Thursday, 2018-SEP-06. It was noted that a Regional District of Nanaimo Board meeting also scheduled for 2018-AUG-28 presented a conflict for Councillor Brennan. 6. PRESENTATIONS:

(a) Affordable Housing Strategy Implementation Plan – Project Update

Karin Kronstal, Social Planner, provided a presentation regarding implementation of the Affordable Housing Strategy. Discussion amongst committee members ensued; topics included:

- incentivising rentals for both new developments and existing homes
- pre-zoning areas to allow for more rental units;
- evaluating the effects of short-term rentals (i.e. Airbnb) on long-term rental unit supply;
- encouraging infill in established neighbourhoods by easing restrictions on carriage homes and secondary suites;
- looking at the potential for inclusionary zoning policies;
- considering parking needs and maintaining neighbourhood character when increasing density in neighbourhoods;
- creating family-friendly housing by encouraging larger units near public amenities for children;
- protecting the viability of mobile home parks; and,
- having effective public transportation in close proximity to high density housing areas.

Public feedback regarding the Affordable Housing Strategy will be sought through an online survey and open house scheduled for August. The final document will be brought to a Council meeting in September for Council's consideration.
