# 5. <u>DELEGATIONS:</u>

(a) Nanaimo Aboriginal Youth Advisory Council: Raising Awareness regarding Youth Homelessness

The Nanaimo Aboriginal Youth Advisory Council provided Council with recommendations to support youth facing homelessness within the community, which included:

- Create a youth homeless coordinator position within the City to support youth and collect data about youth homeless experiences
- Support projects for youth supportive housing complexes
- Support a low barrier, culturally based youth drop in centre
- Create a supported youth position on the Health and Housing Taskforce
- Build a stronger relationship with youth in the community to ensure youth voice is captured in City strategies, projects and initiatives.

## (b) Tanya Hiltz regarding the Stone Soup Kitchen

Andrew Homzy on behalf of Tanya Hiltz, Stone Soup Kitchen, requested a facilitated meeting between Stone Soup Kitchen and City Staff. He advised:

- The space is needed, established, zoned, permitted, well used and helps connect homeless with health agencies
- Free service that hasn't cost the City or Province money
- 18/20 residents on Wisteria Lane support Stone Soup
- Thanked volunteers and donors for providing meals for 16 months.
