- reduce the flanking side yard setback from 3.0m to 1.5m for mobile home pad area 16.

(i) 507 Milton Street - Acceptance of Project Under the Revitalization Tax Exemption Bylaw

It was moved and seconded that Council approve the Revitalization Tax Exemption Agreement for a proposed 27-unit mixed-use building at 507 Milton Street. The motion carried unanimously.
