Please be advised that the Nanaimo RCMP detachment has received an increasing number of police calls for service regarding a residential property located at 217 Irwin Street in Nanaimo, BC. The owner of this property is who lives at this address and is aware of the activities originating from this residence. This residential property has been the subject of past nuisance activities and has been monitored by the nuisance property committee as recently as 2014.

This property is an older residential home that is adjacent to the Deverill Square Gyro Park in Nanaimo, and some activities from this property have affected the area surrounding the park with drug use, suspicious people, suspicious activities and disturbances.

217 Irwin Street has been associated with 53 police PRIME files since January 2010 and more recently 15 police files since February 2019. Clearly, there is a marked increase in calls for service relating to this property, this year, compared to the preceding years. Of the 15 calls this year, 12 of these calls for service, or 80 percent, could be considered to have an element or elements of a nuisance as defined by the City of Nanaimo bylaw.

Constable Bain of the Nanaimo RCMP Bike Unit has reviewed the police calls for service and has attached a break down with the dates, file numbers and details of the police calls for this property. The activity from this property continues to interfere with the neighborhood's use and enjoyment of the area. Constable Bain has spoken to about the activities originating from his property, but it does not appear that he intends to take action to mitigate the issues that interfere with the neighborhood.
