- (h) an administrative tribunal hearing or potential administrative tribunal hearing affecting the municipality, other than a hearing to be conducted by the Council or a delegate of Council;
- (i) the receipt of advice that is subject to solicitor-client privilege, including communications necessary for that purpose;
- (k) negotiations and related discussions respecting the proposed provision of a municipal service that are at their preliminary stages and that, in the view of the Council, could reasonably be expected to harm the interests of the municipality if they were held in public;
- (I) discussions with municipal officers and employees respecting municipal objectives, measures and progress reports for the purposes of preparing an annual report under Section 98 [annual municipal report]; and,

Community Charter Section 90(2):

(b) the consideration of information received and held in confidence relating to negotiations between the municipality and a provincial government or the federal government or both, or between a provincial government or the federal government or both and a third party.

(b) Health and Housing Task Force Six-Month Update

Introduced by Bill Corsan, Director, Community Development and Lisa Bhopalsingh, Manager, Community Planning.

Presentation:

1. Dena Kae Beno, Turner Strategies, provided Council with a presentation regarding Nanaimo's Systems/Asset Mapping and Social Impact Project, which included next steps, key deliverables and community engagement.

(c) Supervised Consumption Site Zoning Amendments

Introduced by Bill Corsan, Director, Community Development.

Presentation:

1. Lisa Bhopalsingh, Manager, Community Planning, provided Council with a presentation regarding Supervised Consumption Site (SCS) Zoning Amendments including guidelines and a review of options.

Delegations:

- Gloria Wells, Old City Quarter Association, spoke regarding the options, whether the SCS would be temporary or permanent, impacts on the community and businesses and support from the Old City Quarter Association for a community consultant process.
- 2. Dr. Paul Hasselback, Vancouver Island Health Authority, spoke regarding past and present obstacles regarding the zoning bylaw, implementing a SCS, wording of the current zoning bylaw, and the lack of progress.

The Regular Council Meeting recessed at 9:03 p.m. The Regular Council meeting reconvened at 9:14 p.m.

F. Farrokhi returned to the Shaw Auditorium at 9:20 p.m.

It was moved and seconded that:

- a) Council endorse the proposed Siting Guidelines for Supervised Consumption Sites; and;
- b) Council direct Staff to bring forward "Zoning Amendment Bylaw 2019 No. 4500.166" (A bylaw to remove the definition for 'Drug Addiction Treatment Facility', amend the definition of 'Office Medical/Dental' to include supervised consumption sites, and add a definition for "Supervised Consumption Site" and a restriction on their operation within 200m of an Academic School) for first and second reading.

The motion was defeated.

<u>Opposed</u>: Mayor Krog, Councillors Armstrong, Bonner, Geselbracht, Hemmens, Maartman, and Thorpe.

It was moved and seconded that Council direct Staff to bring forward a zoning bylaw amendment to amend the definition of office/medical dental to be interpreted more broadly but exclude Supervised Consumption Sites (SCS), and that the topic of SCS be forwarded to the Health and Housing Task Force. The motion carried.

(e) Rezoning Application No. RA422 – 200 Hansen Road

Introduced by Jeremy Holm, Director, Development Approvals.

It was moved and seconded that "Zoning Amendment Bylaw 2020 No. 4500.172" (To rezone 200 Hansen Road from Low Density Residential [R6] and Residential Corridor [COR1] to Medium Density Residential [R8]) pass first reading. The motion carried unanimously.

It was moved and seconded that "Zoning Amendment Bylaw 2020 No. 4500.172" pass second reading. The motion carried unanimously.

It was moved and seconded that Council direct Staff to secure the vehicle turnaround covenant, blanket right-of-way, and residential units covenant should Council support the bylaw at third reading. The motion carried unanimously.

(f) <u>Development Permit Application No. DP1133 – 930 Terminal Avenue North</u>

Introduced by Jeremy Holm, Director, Development Approvals.

Delegation:

1. Joyce Troost, Joyce Reid Troost Architecture, spoke in support regarding Development Permit Application No. DP1133 – 930 Terminal Avenue.

It was moved and seconded that Council issue Development Permit No. DP1133 at 930 Terminal Avenue North with the following variances to:

- reduce the watercourse setback for St. George Creek from 15m to 7.5m;
- increase the building height from 18.0m to 18.6m;
- reduce the front yard setback from 5.5m to 3.6m;
- reduce the required number of parking spaces from 56 to 54; and,
- increase the maximum allowable percentage of small car spaces from 40% to 45%

The motion carried unanimously.

(g) Development Variance Permit Application No. DVP392 – 3358 Stephenson Point Road

Introduced by Jeremy Holm, Director, Development Approvals.

Mayor Krog requested that Council hear anyone wishing to speak with respect to DVP392.

It was moved and seconded that Council issue Development Permit No. DVP392 at 3358 Stephenson Point Road with the following variance:

• to increase the total gross floor area for accessory buildings on a lot from 90m² to 171.8m² to allow for the construction of an oversized accessory building at 3358 Stephenson Point Road.

The motion carried unanimously.

(h) Development Variance Permit Application No. DVP396 – 4461 Wellington Road

Introduced by Jeremy Holm, Director, Development Approvals.

Delegation:

1. Mike Plavetic, MJP Homes Ltd., spoke regarding DVP 396 – 4461 Wellington Road and the reasons for building the retaining wall at the back of the property.

Mayor Krog requested that Council hear anyone wishing to speak with respect to DVP396.

No one in attendance wished to speak with respect to DVP396.

It was moved and seconded that Council issue Development Permit No. DVP396 at 4461 Wellington Road with the following variance:

• increase the maximum combined height for a fence and retaining wall within the rear and side yard setbacks from 2.4m to 3.51m.

The motion carried unanimously.

(i) Development Variance Permit Application No. DVP397 – 3945 Biggs Road

Introduced by Jeremy Holm, Director, Development Approvals.

Mayor Krog requested that Council hear anyone wishing to speak with respect to DVP397.

No one in attendance wished to speak with respect to DVP397.

It was moved and seconded that Council issue Development Variance Permit No. DVP397 at 3945 Biggs Road to vary "Building Bylaw 2016 No. 7224", subject to the terms and conditions specified in Attachment A of the report. The motion carried unanimously.

(j) Development Variance Permit Application No. DVP399 – 3951 Jingle Pot Road

Mayor Krog requested that Council hear anyone wishing to speak with respect to DVP399.

It was moved and seconded that Council issue Development Permit No. DVP399 at 3951 Jingle Pot Road with the following variance:

• reduce the minimum rear yard setback requirement for the principle dwelling from 7.5m to 5.1m.

(a) "Zoning Amendment Bylaw 2019 No. 4500.133"

It was moved and seconded that "Zoning Amendment Bylaw 2019 No. 4500.133" (To rezone Unit 9, 1599 Dufferin Crescent to allow "Cannabis Retail Store" as a site-specific use in the Hospital Urban Centre [CC5] Zone) be adopted. The motion carried unanimously.

(b) "Financial Plan Bylaw 2019 No. 7307"

It was moved and seconded that "Financial Plan Bylaw 2019 No. 7307" (To confirm and adopt the 2020 – 2024 Financial Plan) be adopted. The motion carried unanimously.
