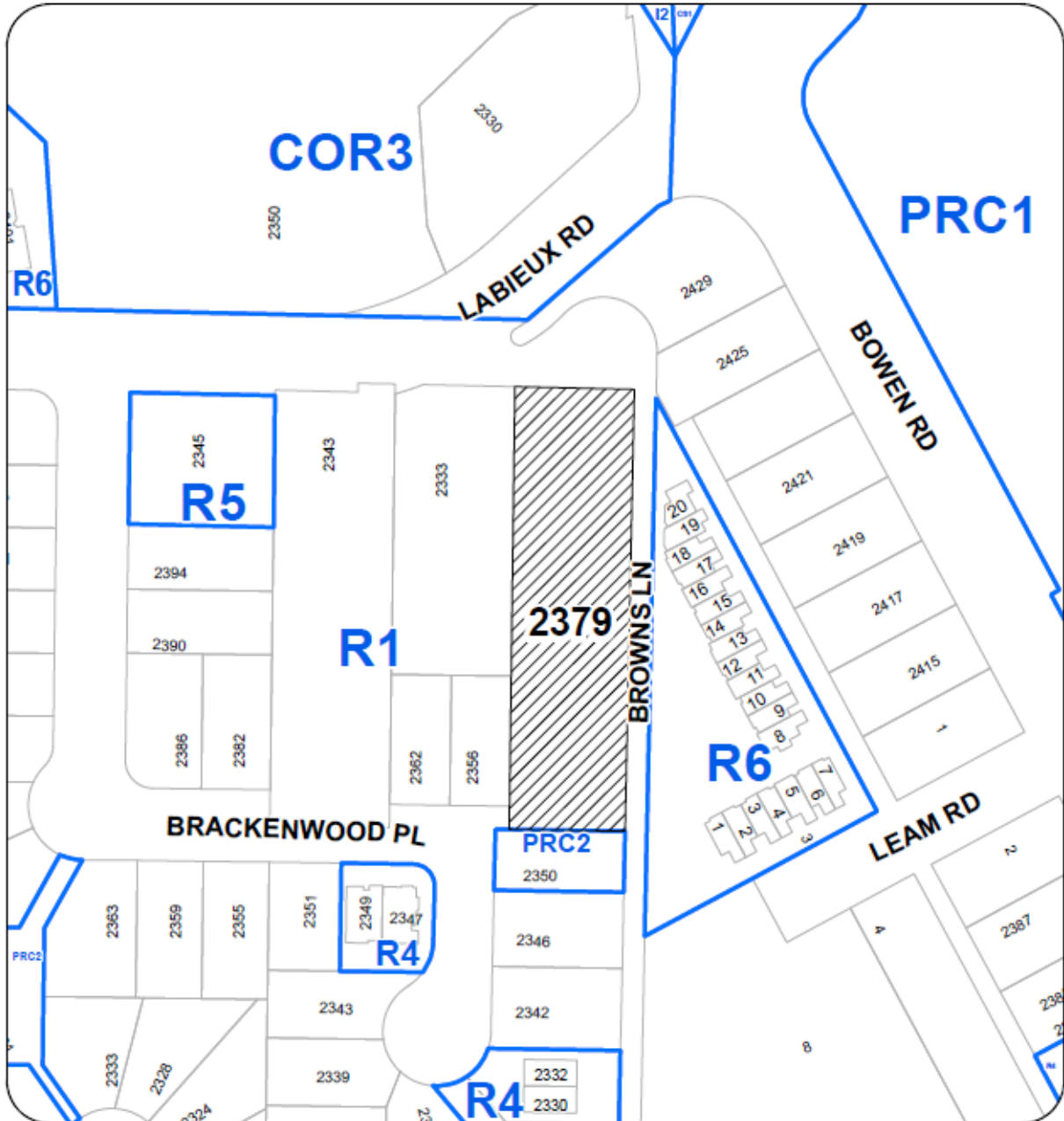

LOCATION PLAN


