



Screen Name Redacted	Given that people have limited time and resources, what is the city going to do to help executives with resources, will there be support from city staff to let residents know there is a neighbourhood association in their neighbourhood that they can join. Who is responsible for recruiting members/letting people know an association exists? What is the criteria for establishing membership? For example, does a landlord who does not live in the neighbourhood but owns property be a member? Can renters be members? How does the association demonstrate they have engaged with their membership? Is there a minimum threshold of resident members to keep an association accurate? If there is a more formalized structure to the associations, will the meeting minutes need to be sent to the city for filing? Will the executive be responsible for filing a formalized annual report?
Screen Name Redacted	Have an umbrella organization that the smaller neighbourhood associations fall under. The umbrella organization might be an incorporated non-profit or simply be a branch of the City of Nanaimo. That way, not every neighbourhood needs an entire executive team. I'm not sure that roads make the best boundary for neighbourhoods as people across from me on the street are shown as being in a completely different neighbourhood on the map. Realistically, neighbourhoods start/stop at a more natural break.

Get Involved Nanaimo is not a person to person forum for most of the time nor does this forum lobby specifically for neighbourhoods. More bureaucracy is not the answer for proper engagement. Most effective groups started out without cumbersome edits about organization.

If we impose criteria on NAs, people will not particpate. They need to be losely organized, bottoms up strucutures. I have lived in my Westwood neighbourhood for 17 years, and only recently joined our association as a result of COVID 19, and a desire to make our communities places of connection. Hosting a city wide learn about your neighbourhood association day, and sharing what projects people are doing around the city and what successes they had as a result of collaboratin would be a great way for us to learn about what postive ways NAs can support and enhance our neighbourhoods. Host them in neighbourhoods that have had success so folks can see it first hand. Maybe all of this is already happening, but I have been unaware of it, but as I mentioned, COVID and working from home has made community much more valuable to me now.

I am a dedicated member of the Westwood Lake Neighbourhood Association, aka 'Friends of Westwood,' a vibrant well-established group that has served its residents well when needed, despite the obvious intention to impose new arbitrary definitions and terms of engagement. I have volunteered and dedicated my time and energy out of a sense of duty to our community without receiving remuneration or project funding of any kind. I have seen numerous Plan Nanaimo, Official Community Plans and Reimaginations come and go, replaced by moving goalposts for new development approvals. I view our flexible and issue-driven structure as one of our strengths, resulting in better staff interactions, without the obstacle of having to exist in a 'homogenized approved fashion.' There has never been any problem with less formalized representation. The only objection has come from property developers, who don't live in our neighbourhood, and are not held to the standard intended to be imposed on us. Once again, you are asking us to choose between being independent and disempowered, or compliant and ignored. I do not believe the concept of formalization of neighbourhood groups is fair or democratic. For almost 35 years, we have faced issues, had support of staff, and presented at council without bias or

	discrimination. Please continue to show respect for our time and dedication, and our own assessment of what organizational structure works best for our community goals. This current mayor is promoting a new litmus test of false purity, a heinous exercise in delegitimization. He needs to stop wasting City's and our time and energy and resources and pay more proper attention to our concerns.

associations are made up of just a few outspoken individuals wanting "credibility" of a neighbourhood association behind them and they aren't actually a strong and inclusive voice of all those who live in that area. But I wish I had a simple solution on how to get more people involved. My best suggestion is to set up booths in the area and get the opinion from those who are actually visiting/using the space already or using space nearby already. For example parents who have an hour or more to sit and watch their kids at a baseball or soccer practice would be a great target. If I had the chance to win a West Coast Mom prize (big umbrella, \$25 GC to starbucks to warm up, headlamp for being able to go for a walk and maybe GC to soccer world or sport check to buy my kids new cleats) I'd sure sign up to provide feedback. Also, have you seen how many people attend soccer Saturday's at Beban??! You set up a booth with free coffee/hot chocolate in exchange for a quick survey and I bet you'd be happy with the numbers collected! To me this would be a way to capture a more rounded sample group of residents. I also would encourage to keep is easy. Registering to use this site deters is just one extra step to remember a password etc and I bounce off. I do understand why, because you don't want the same people filling it out over and over again but ultimately it doesn't feel like a good enough reason to have to take that extra step. Just my thoughts!

I have been a part of the neighbourhood association closest to me for a few years, including as a director. I have found that unfortunately these groups — despite often meeting organizational criteria — can tend to represent just the viewpoints of a handful of its loudest members. The membership base is often miniscule compared to the population of the community it represents and can't be seen as representative. I think community associations have their place but they should not be seen as the be all/end all for community engagement. I would much prefer other methods such as letters and surveys sent out to postal codes regarding nearby development and online survey tools. If you are going to keep using neighbourhood associations to opine on things, pls ask them to provide an accurate account of true members. I think you'll be surprised how many ppl these associations actually represent — it's often not many.

If Staff are too overworked to acknowledge, respond or act on resident concerns then it is incumbent on management to identify the shortfall and press for more manpower. If they do not believe residents concerns are legitimate then residents and volunteers are deserved a straight answer. If residents concerns do not rate as a priority, then Staff should be able to show what are the priorities and explain why. Staff's default position at present appears to be wary or downright distrustful on most issues raised by residents, either because it may tax their limited time, represent a new idea, or challenge the current thinking among staff. Staff should coordinate among departments of how resident requests are entered into the City's system, regardless of whether idea comes through individual residents, a neighbourhood association, or an ad-hoc group of residents. In the end, all of these represent residents trying to make their neighbourhoods better and more responsive to their needs.

While I admire the hard work of some of the folks involved with the HNA, I feel that they focus on their individual interests and passions for the most part, and do nothing to consult

the full community about concerns and wishes. It is a huge area

and I grant that trying to gauge the views of Harewood would be an undertaking, but if the HNA can't do this, I would prefer that the City take on this task. A current example, which pertains to Sixth Street is an indication. Yes, there is a lot of traffic on Sixth Street, as there is on many, many other roads in Harewood. This is partially a result of unbridled development with no consideration for the impact on the existing neighbourhood - sadly a pattern in Nanaimo. Not sure what the latest wish is, but at one time they were wanting to have traffic directed to Fifth and then turn on Howard. All this does is move the problem to some other "neighbours" away from the street that several of the people who are part of the HNA live on. Not sure what sort of consultation they have done, but I live on Fifth and have seen nothing. This is one example of many.

This depends on whether the City is truly interested in hearing from neighbourhoods regarding development issues, concerns about theft, tent cities or whether this is just an opportunity for the City to receive the information and not act on it. For example, the downtown neighbourhood was once a place to appreciate. It is now a "do not go" because of the violence, panhandlers, fencing and tents. A new hotel, a long overdue plan, is being built beside the Nanaimo Convention Centre. It should attract more convention business, but unless the City Council starts to address the situation downtown repeat business will be hard to get. This is just one example of Re-Imaging Nanaimo. What is the overall plan for Nanaimo? Fencing every park and bars on windows doesn't present a very safe city to visitors. The increase in Block Watch areas must be a signal to the City that something is very wrong.

Also, from what I've Experienced, communication between the city and the community association is much stronger as a whole, than communication between the community association and the community. There is an Old City Association that appears to represent residents with houses mainly between Prideaux and Pine Streets and an Old City Quarter Association representing businesses, however, City officials forget there are many residents of Strata Condos and Rental Apartments between Prideaux and Wallace that are not represented.
Screen Name Redacted	City should be listening to and be more attentive to community issues. Public involvement (forget your slogans and lip service) should be actively listened to and engaged and not taken for granted.
Screen Name Redacted	Ensure that the doughnut model includes "Political Voice" under the empowerment function with appropriate indicators; Hire a specialists who understands community engagement to advise all departments including planning, transportation, parks & rec etc on effective community engagement; Understand IAP2 and how to use it; ensure there is a community consultation section in all reports going to council; require that developers obtain community input on all development applications not just rezoning & OCP amendments; have council meet with neighbourhood associations at least once a year to discuss issues and challenges; involve community associations at the beginning of project proposals, not in the middle or at the end.
Screen Name Redacted	I think the City does a poor job of public engagement. In the past there were more committees (ie safety, downtown etc.) that held meetings and published minutes and some transparency existed. Now there are far too many meetings held in camera where decisions are made that are far reaching and no public input is considered or recorded. Results are publicized but seldom is that process getting there. Time passes, then the taxpayer is hit with three consecutive years of tax increases in a row. Several neighborhood associations would have had a lot to say as would the Chamber of Commerce and many downtown businesses, but
