




Community Engagement Task Force Recommendations

The proposed engagement strategy supports 4 of the 6 CETF recommendations:


- Be committed to working more closely with the community to improve engagement and participation in Council decisions, so that residents feel empowered to be more active in shaping their community and future.
- Begin with something as simple as a published calendar of what Council intends to engage residents about over the next year.
- Ensure that existing methods for community engagement are fully understood and utilized.
- Consider how to improve community engagement through advertising, social media and online technology.

Mayor's Leaders' Table

- ► Established to continue the work that began in 2020 with the Mayor's Task Force on Recovery and Resilience
- ► Purpose is to ensure the continued advocacy of projects and programs to support capital infrastructure asks
- ► Membership will include the Mayor and 5-7 additional members

Mayor's Leaders' Table

Recommendation:

That the Governance and Priorities Committee recommend that Council endorse the Mayor's Leaders' Table terms of reference as attached to the staff report dated 2023-FEB-13.



Advisory Committee on Accessibility & Inclusiveness (ACAI)

- ▶ First established in 2019 to promote social and political equity within existing and proposed City plans, policies, bylaws and infrastructure and make recommendations to ensure that they are inclusive and accommodating to citizens of all ages, abilities and walks of life.
- ► The ACAI fulfills the new legislated requirement for organizations (including municipalities) to have an accessibility committee.
- Membership requirements will need to be adjusted to ensure compliance with legislation.

ACAI Proposed Membership

- ▶ Thirteen voting members, of which there are:
 - Two members of Council
 - Five members appointed on behalf of non-profit organizations dedicated to matters of accessibility, diversity and/or inclusion
 - Five members-at-large
 - One youth representative (age 15-24)
- ► At least half of the members would be persons with disabilities or persons representing a disability-serving organization
- Indigenous representation must be included




ACAI

- ➤ City Plan acts as the City's Accessibility Plan, with implementation built into the Integrated Action Plan
- ► ACAI would be required to review and update the accessibility actions every 3 years, in line with the new legislation
- ► Opportunity to review City Plan's "Empowered Nanaimo" goals and identify opportunities to support the related policies
- ➤ Staff will amend ToR based on Council feedback and return for endorsement
