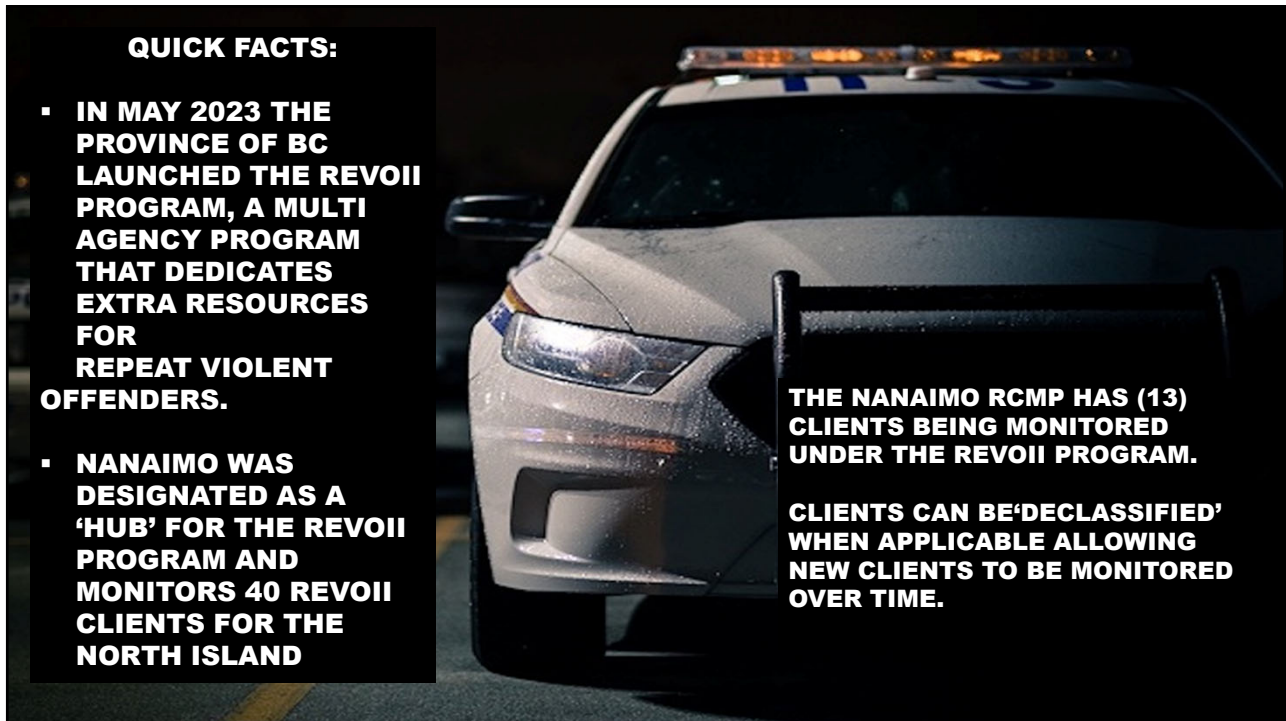




**NANAIMO RCMP SPECIAL INVESTIGATIONS AND TARGETED ENFORCEMENT

QUICK FACTS:

- **IN MAY 2023 THE PROVINCE OF BC LAUNCHED THE REVOII PROGRAM, A MULTI AGENCY PROGRAM THAT DEDICATES EXTRA RESOURCES FOR REPEAT VIOLENT OFFENDERS.**
- **NANAIMO WAS DESIGNATED AS A 'HUB' FOR THE REVOII PROGRAM AND MONITORS 40 REVOII CLIENTS FOR THE NORTH ISLAND**

THE NANAIMO RCMP HAS (13) CLIENTS BEING MONITORED UNDER THE REVOII PROGRAM.

CLIENTS CAN BE 'DECLASSIFIED' WHEN APPLICABLE ALLOWING NEW CLIENTS TO BE MONITORED OVER TIME.

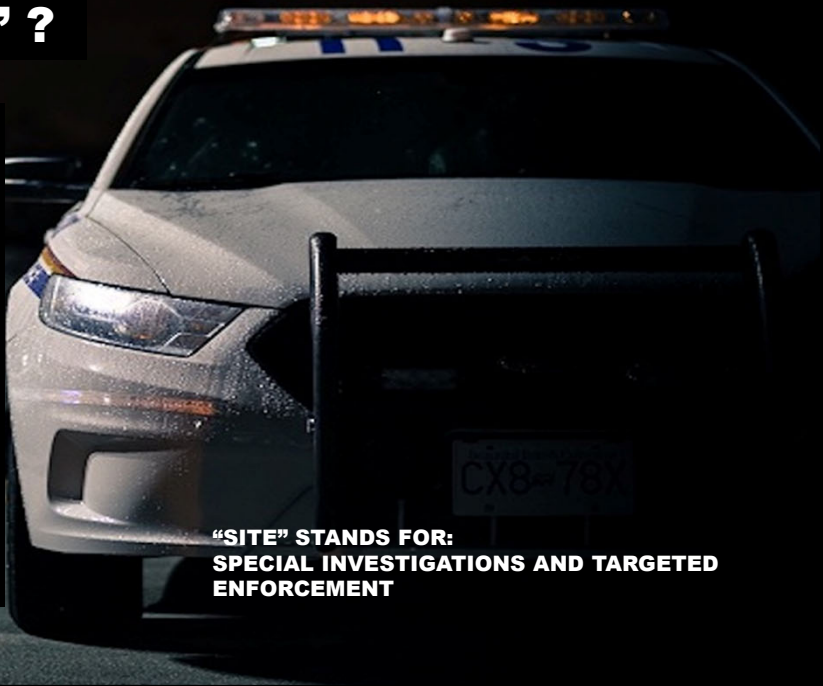

WHAT IS "SITE" ?

WHEN THE REVOII PROGRAM WAS LAUNCHED, THE RCMP OF BRITISH COLUMBIA WAS GIVEN RESOURCES TO ASSIST INVESTIGATIONS INTO REPEAT VIOLENT OFFENDERS. THE BC RCMP CREATED A UNIT CALLED "SITE" TO ADMINISTER THE FUND.

THE BC RCMP "SITE" ALLOWS FOR SPECIAL FUNDING REQUESTS AS WELL AS SPECIAL SUPPORT SERVICES SUCH AS; ANALYSTS, LABS AND FORENSICS.

NANAIMO RCMP'S RESPONSE:

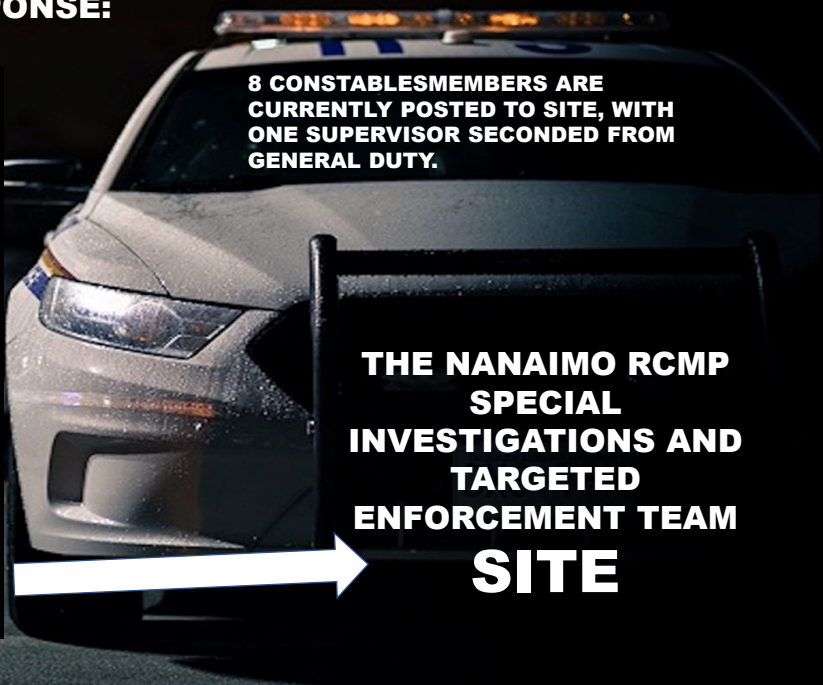
WHEN THE REVOII PROGRAM WAS LAUNCHED, THE NANAIMO DETACHMENT HAD AVAILABLE (8) CONSTABLES WHO WERE WAITING TO START ROTATIONS IN SPECIALIZED UNITS.

THE SENIOR MANAGEMENT TEAM ALIGNED ADDITIONAL RESOURCES TO SUPPORT PUBLIC SAFETY AND TARGET VIOLENT OFFENDERS AND CRIME HOTSPOTS, CREATING A NEW UNIFORMED TEAM.


WE HAVE NAMED THE TEAM ...


MANDATE OF NANAIMO SITE TEAM

OUR TEAM STARTED ON SEPTEMBER 20TH AND IS ACTIVELY DEVELOPING ITS MANDATE. THUS FAR, THE TEAM HAS PERFORMED THE FOLLOWING TASKS:

- **PATROLLING HIGH CRIME AREAS IN MARKED POLICE CARS;**
- **INVESTIGATING THE REVOII CLIENTS;**
- **COLLABORATING WITH CSO'S AND THE BIKE UNIT TO INCREASE DOWNTOWN SAFETY;**
- **ASSISTING GENERAL DUTY OFFICERS WITH CALLS INVOLVING PUBLIC VIOLENCE**

- **IDENTIFYING PROBLEM OFFENDERS THEN DEVELOP STRATEGIES TO REDUCE OFFENDING BEHAVIOUR**
- **SHARING INTELLIGENCE WITH DETACHMENT MEMBERS**
- **PARTICIPATING IN THE REVOII HUB MEETINGS**

REVOII CLIENTS:

- **THE TEAM IDENTIFIED NEW OFFENDERS AND FILLED (5) VACANIES IN THE REVOII PROGRAM.**
- **(8) OF NANAIMO'S REVOII CLIENTS ARE CURRENTLY REMANDED OR DETAINED UNTIL TRIAL. THEY ARE OUT OF THE COMMUNITY.**
- **OTHERS HAVE WARRANTS OR ARE ON CHARGE WITH RELEASE ORDERS.**

NANAIMO SITE HAS BEEN MAKING CONTACT WITH THE REVOII CLIENTS WHO ARE IN COMMUNITY AND HAVE BEEN MONITORING THEIR ACTIVITIES TO CHECK FOR CIMINAL BEHAVIOUR.

CRIME HOT SPOTS:

- **OUR PATROLLING AREA IS ADJUSTED BASED ON CRIME STATISTICS, WHICH ARE PROVIDED MONTHLY.**
- **SO FAR, THE MAJORITY OF OUR PRO-ACTIVE WORK HAS BEEN DONE BETWEEN THE CANCO AND UNIVERSITY PLAZA.**
- **WE HAVE INTERCEPTED DOZENS OF VEHICLES THAT ARE ACTIVE IN CRIMINAL ACTIVITY, LOCATED PEOPLE WITH WARRANTS, PROHIBITED DRIVERS, IMPAIRED DRIVERS AND HAVE SEVERAL DRUG TRAFFICKING INVESTIGATIONS AS A RESULT.**
