1. CALL THE MEETING TO ORDER:

The Special Council Meeting was called to order at 3:00 p.m.

5. REPORTS:

a. Alternative Approval Process Update and Next Steps

Introduced by Dale Lindsay, Chief Administrative Officer.

- An error in the "Nanaimo Operations Centre Phase One Borrowing Bylaw 2023 No. 7362" Alternative Approval Process (AAP) was confirmed
- Staff recommend that Council cancel the AAP, abandon the bylaw, and direct Staff to return to Council with options to fund the Nanaimo Operations Centre (NOC)
- The NOC continues to be a priority

Delegations:

1. Sandy Bartlett expressed concern's regarding the Alternative Approval Process' effectiveness of providing notice to citizens, requested more notification be given, and requested that Council undertake a referendum for the project.

2. Valentina Cardinalli expressed concerns regarding the costs for the Nanaimo Operations Centre (NOC) project, alternative options for the NOC, requested clarification on the cost of the future phases, and expressed concerns regarding the AAP.

It was moved and seconded that Council

- a. Cancel the current Alternative Approval Process;
- b. Abandon "Nanaimo Operations Centre Phase One Borrowing Bylaw 2023 No. 7362"; and,
- c. Direct Staff to return to Council with options to fund Phase One of the Nanaimo Operations Centre project.

The motion carried unanimously.

Council received one question from the public regarding agenda items.

7. ADJOURNMENT:

It was moved and seconded at 4:19 p.m. that the meeting adjourn. The motion carried unanimously.
