A BYLAW TO AMEND THE "OFFICER APPOINTMENT AND DELEGATION OF AUTHORITY
BYLAW NO. 7353"

That Council of the City of Nanaimo in open meeting assembled, hereby ENACTS AS
FOLLOWS:

1. Title:

This Bylaw may be cited as "OFFICER DESIGNATION AND DELEGATION OF
AUTHORITY BYLAW, 2024 NO. 7353.02".

2. Amendments:

"OFFICER APPOINTMENT AND DELEGATION OF AUTHORITY BYLAW, 2022 NO.
7353" is hereby amended as follows:

- (a) By deleting "Director, Finance" in the Definitions and replacing it with "General
Manager, Corporate Services".
- (b) By deleting "Director Finance" in Section 6.1(c) and 6.4 and replacing it with "General
Manager, Corporate Services".
- (c) By deleting "Director, Development Approvals" in section 9.5 and 9.6 and replacing it
with "Director, Planning & Development".
- (d) By deleting "General Manager, Development Services" in section 14.1 and replacing
it with General Manager, Community Services/Deputy CAO".
- (e) By deleting "General Manager, Development Services and Director, Development
Approvals" in section 16.1, 21.1, and 21.2 and replacing it with "Director, Planning &
Development".
- (f) By deleting "General Manager, Development Services and Director, Development
Approvals" in section 17.1 and replacing it with "Director, Planning & Development"
and deleting the word "are" and replacing it with the word "is".
- (g) By deleting "General Manager, Parks, Recreation and Culture" in sections 19.1, 20.1,
20.2(a), 20.4, 20.7(c), and 20.8 and replacing it with "General Manager, Community
Services/Deputy CAO".
- (h) By deleting "General Manager, Development Services" in section 20.7(a), 20.8,
22.2(a), 22.3 (e) and 26.1 and replacing it with "Director, Planning & Development".

- (i) By deleting “General Manager, Development Services” and Director, Development Approvals” in section 22.1 and replacing it with “Director, Planning & Development” and deleting the word “are” and replacing it with the word “is”.
- (j) By deleting “General Manager, Development Services or Director, Development Approvals” in section 22.2(b) and 22.4 and replacing it with “Director, Planning & Development”.
- (k) By adding the following to Schedule “A”:
