SUBJECT LEISURE ECONOMIC ACCESS PASS (LEAP) REVIEW UPDATE

## OVERVIEW

### Purpose of Report:

To provide the Advisory Committee on Accessibility and Inclusiveness (ACAI) an overview and update of the recommendations from the Leisure Economic Access Pass (LEAP) review.

### BACKGROUND

In 2020 and 2021, a review of the LEAP program was conducted and several phases were brought forward to the ACAI for input. In total, 14 recommendations were supported by the ACAI and approved by Mayor and Council. As a result, a number of changes have since been implemented to reduce barriers and help make LEAP more accessible to the community.

#### DISCUSSION

Changes to the LEAP program have been well received and there has been a significant increase in the number of LEAP passes issued as a result of these changes. The recommendations were implemented with overall goals being: 1. To reduce barriers to the application process; and 2. Increase participation in the LEAP program.

The LEAP changes align with City Plan and several goals of the Integrated Action Plan such as:

C3.3.1 – "Support equitable access for children, youth, and families to City recreational programs and facilities. Examples include the Leisure Economic Access Pass (LEAP) program, supports to sport and youth organizations, and the Health Hub at the Nanaimo Aquatic Centre."

C4.2.16 – "Implement Phase 2 of the Leisure Economic Access Pass (LEAP) program review and take steps to build partnerships within the community for administering the LEAP program."

C4.2.4 – "Continue to offer a Leisure Economic Access Pass (LEAP) to support citizens in financial need to access Parks, Recreation and Culture community programs and services."

C4.5.6 – "Offer the Leisure Economic Access Pass (LEAP) program to support citizens in financial need to access culture community programs and services."

The 14 recommendations of the LEAP review are:

1.	No longer include additional income on top of the Notice of Assessment	Complete

3.	Make the application process easier by reducing the amount of	Complete

4.	Provide an option for applying online.	Complete
5.	Revise/simplify the application form to make it more easily	Complete

6.	Offer private appointments for applicants to discuss the program with a	Complete
