SUBJECTBYLAW CONTRAVENTION NOTICE - CONSTRUCTION STARTED<br/>WITHOUT A BUILDING PERMIT – 6367 GROVELAND DRIVE

# **OVERVIEW**

#### Purpose of Report

To obtain Council authorization to proceed with the registration of a Bylaw Contravention Notice on the property title of 6367 Groveland Drive.

#### Recommendation

That Council direct the Corporate Officer to file a Bylaw Contravention Notice at the Land Title and Survey Authority of British Columbia under Section 57 of the *Community Charter* for the property located at 6367 Groveland Drive for construction started without a building permit in contravention of "Building Bylaw 2016 No. 7224".

### BACKGROUND

Building regulations for the City of Nanaimo are outlined in the "Building Bylaw 2016 No. 7224" and are enforced by the Building Inspections section and where necessary, Bylaw Services.

Where construction has been undertaken without a building permit, and in violation of the Building Bylaw, a report is brought forward for a resolution of Council to file a Bylaw Contravention Notice on the property title under Section 57 of the *Community Charter*. The purpose of registering a Bylaw Contravention Notice on the title of the affected property is to advise those with an interest in the property of the regulations contravened, to provide disclosure to future owners and to protect taxpayers against potential claims with regard to the regulations contravened.

### DISCUSSION

An inspection conducted on 2025-MAR-05, as a result of a business licence application for a short-term rental licence, revealed a suite had previously been constructed in the dwelling without a permit. A Stop Work Order was posted on the dwelling and correspondence was forwarded to the owner advising that a building permit was required for the work. An incomplete building permit application (BP130819) was received on 2025-MAR-28 to legalize the suite. The requested documentation to complete the application was not supplied and the application was subsequently cancelled. A new application (BP130948) was received on 2025-MAY-21 but is also incomplete.

Pursuant to Section 57 of the *Community Charter*, it is recommended a notice be registered on the property title to reflect the work completed without a permit or inspections in contravention of "Building Bylaw 2016 No 7224".

This matter will be referred to Bylaw Services for enforcement action.

## SUMMARY POINTS

- Construction requiring a building permit was undertaken without first obtaining a permit.
- The deadline to submit a building permit application has passed.
- Registration of a Bylaw Contravention Notice is required on the title of the affected property to advise those with an interest in the property of the regulations contravened, to provide disclosure to future owners and to protect taxpayers against potential claims with regard to the regulations contravened.
- Further to the registration of the notice, this matter will be referred to Bylaw Services for further enforcement.
