# **OVERVIEW**

# **Purpose of Report**

The purpose of this Report is to bring forward Bylaws which will establish a Local Area Service as requirement to provide financing for properties that are participating in the City of Nanaimo's Home Energy Retrofit Financing Program.

### **BACKGROUND**

On 2024-JUL-08, Council directed Staff to "apply to the Federation of Canadian Municipalities (FCM) Community Energy Efficiency Financing (CEF) program for pilot funding to support a Property Assessed Clean Energy (PACE) style home energy financing program and if successful, launch a PACE style home energy financing program for Nanaimo residents" and allocate up to \$200,000 from the Climate Action Reserve to support the program. On 2024-DEC-04 the City was notified that their CEF application for a \$458,000 grant was approved.

On 2025-APR-07 Council adopted "Home Energy Retrofit Financing Program Bylaw 2025 No. 7393" to establish the Home Energy Retrofit Program. The retrofits are intended to reduce residential greenhouse gas emissions, increase energy efficiency and improve climate resiliency.



The first program application intake was closed on 2025-MAY-15. The City received and evaluated 37 applications.

Currently, twenty-three households meet the program criteria and have submitted a petition (see example petition in Attachment A) and are ready to move forward to the next step of the creation of a Local Area Service for the provision of interest-free financing of up to \$15,000. Additional Local Area Service bylaws are anticipated to be brought forward in the fall for the remaining eligible households.

The financing can be used for any of the following eligible retrofits:

- Switching from fossil fuel space heating to an electric heat pump.
- Installing **solar panels** where the homeowner already has electric heating.
- Installing a backup battery where solar panels are already in place.
- **Building envelope upgrades** to reduce air leakage and improve energy efficiency, such as door and window replacements or adding insulation.
- Non-energy related measures that might impede energy retrofits or enhance health and wellbeing, such as better filters in heat pumps. These measures must be combined with one of the above retrofits. No more than 30% of the individual amount financed can be used to support non-energy measures

The establishment of the Local Area Service, in combination with a Financing Agreement, is necessary to allow payments to contractors and recover the financing amount through a parcel tax bylaw. The financed upgrades will be paid back over 10 years through property taxes, with the returned funds reinvested into the program. Although the Financing Agreement is interest free, unpaid parcel taxes are subject to the same penalties and interest legislation as property taxes.

Following the establishment of the Local Area Service Bylaws, participating properties will submit their EnerGuide Evaluations and preferred contractor quote and enter into a Financing Agreement with the City of Nanaimo. Contractors will then be permitted to complete the work. Upon receiving and approving all required documentation, contractors will be paid directly by the Program operator and the financing amount will be added to the parcel tax roll to initiate payment over 10 years.

#### **DISCUSSION**

In accordance with Sections 212(3) and (4) and (6) of the *Community Charter*, the Deputy Corporate Officer has certified that the petitions associated with establishing each local area service are sufficient and valid.

  - Financial Implications: There are no new financial implications at this time, as the project budget and all funding sources have been confirmed.

#### **SUMMARY POINTS**

- The Home Energy Retrofit Financing Program intake was closed on 2025-MAY-15.
- 23 Nanaimo households have signed petitions to create a Local Area Service.
- The financing will be used to pay for retrofits intended to reduce residential greenhouse gas emissions, increase energy efficiency and improve climate resiliency.
