 FEES AND CHARGES AMENDMENT BYLAW
 A BYLAW TO AMEND THE “FEES AND CHARGES BYLAW 2021 NO. 7336”

The Council of the City of Nanaimo, in open meeting assembled, enacts as follows:

1. Title:

This Bylaw may be cited for all purposes as “Fees and Charges Amendment Bylaw 2025, No. 7336.14”.

2. Amendments:

“Fees and Charges Bylaw 2021 No. 7336” is hereby amended as follows:

2.1 By deleting the Cemetery Fees within Schedule “A” and replacing them with the following:

Note: Cemetery fees do not include any applicable taxes such as GST. All fees shall be payable by the Applicant at the time of application.

2.2 By deleting Schedule B.

2.3 By amending the following in the Parks fees section within Schedule "A":

2.3.1 adding the following after the definitions section:

"Note: The following rental fees are per hour and do not include any applicable taxes."

2.3.2 deleting the words "Field 1" from the Artificial Turf Fields section and replacing it with the word "Artificial".

2.3.3 deleting the word "2nd" from the Artificial Turf Fields section and replacing it with the word "Second".

2.3.4 deleting the words "Harewood East" and "Harewood West" from the Artificial Turf Fields section and replacing them with "Harewood Artificial Turf-East" and "Harewood Artificial Turf-West"

2.3.5 deleting the Fields "A" description and replacing it with the following:

"Fields "A"

Elaine Hamilton Field, May Richards Bennett Pioneer Park Fields, Beban Gyro Fields 1, 2 & 3, Caledonia Park Field, Serauxmen Third Street Sports Fields 1, 2, 3 & 4".

2.3.6 deleting "Harewood Centennial Park Sherry Small Field" and "Practice Area" from the Fields "B" section.

2.4 By amending the following in the Recreation fees section within Schedule "A":

2.4.1 deleting the Group 1 description from the Community Centre and Activity Centre Rates section and replacing it with the following:

"Beban Dressing Rooms 1 or 2, Beban Stage, Bowen Room 2, 3 & 4, Cliff McNabb Conference Room, Frank Crane VIP Room".

2.4.2 adding ",Commercial Kitchens" after the words Tree Frog Room in the Community Centre and Activity Centre Rates Group 2 section.

2.4.3 deleting the word "Activity" from the Community Centre and Activity Centre Rates Group 3 section.
