### 1. CALL THE SPECIAL COUNCIL MEETING TO ORDER:

The Special Council Meeting was called to order at 9:00 a.m.

### 2. ADOPTION OF AGENDA:

It was moved and seconded that the Agenda be adopted. The motion carried unanimously.

Councillor Yoachim entered the Boardroom at 9:01 a.m.

### 3. CORPORATE SERVICES:

### (a) 2018 – 2022 Financial Plan Amendment Bylaw

Introduced by Laura Mercer, Manager of Accounting Services.

It was moved and seconded that the report titled "2018 - 2022 Financial Plan", dated 2018-APR-30, be received for information. The motion carried unanimously.

It was moved and seconded that Council provide direction on how Staff should allocate \$966,000 out of the 2018 operating budget in order to reduce the 2018 property tax increase from 3.01% to 2.0% based on the report titled "2018 - 2022 Financial Plan", dated 2018-APR-30. The motion carried unanimously.

It was moved and seconded that Council direct Staff to remove the Treasury and Risk Manager position from the 2018 Operational Budget. The motion carried unanimously.

It was moved and seconded that Council direct Staff to remove the Director of Communications and Community Engagement Position from the 2018 Operational Budget. The motion carried.

Opposed: Mayor McKay, Councillors Armstrong and Brennan

It was moved and seconded that Council direct Staff to remove the Chief Operations Officer position from the 2018 Operational Budget. The motion carried.

Opposed: Councillors Armstrong, Brennan and Thorpe

It was moved and seconded that Council direct Staff to allocate \$100,000 from the 2017 General Capital Reserve Surplus to fund Project Management. The motion carried. <a href="https://doi.org/10.2016/nc.2016/nc.2016/">Opposed: Mayor McKay, Councillors Armstrong, Brennan and Thorpe</a>

It was moved and seconded that Council direct Staff to allocate \$170,000 from the 2017 Surplus to offset the cost of snow removal. The motion carried.

<u>Opposed:</u> Councillors Armstrong, Brennan and Thorpe

Councillor Yoachim vacated the Boardroom at 10:20 a.m.

It was moved and seconded that Council direct Staff to allocate \$110,000 from the 2017 Surplus to fund the 2018 Election. The motion was <u>defeated</u>.

Councillor Yoachim returned to the Boardroom at 10:23 a.m.

It was moved and seconded that Council direct Staff to allocate \$20,000 from the 2017 Surplus to fund the Community Engagement Program. The motion carried.

<u>Opposed:</u> Mayor McKay, Councillors Armstrong, Brennan and Thorpe

Mayor McKay requested that the following motion be reconsidered:

"It was moved and seconded that Council direct Staff to allocate \$110,000 from the 2017 Surplus to fund the 2018 Election."
