As a leading anti-violence organization operating from feminist principles, Haven Society will achieve this mission by providing a range of services, public education, and advocacy.

- To provide and maintain shelter for women of all ages, who have been physically, sexually, and/or emotionally abused and for their children.
- To provide a range of programs and services including information, counselling, crisis support, and advocacy services for women, children, youth, and families who are experiencing physical, sexual, and/or psychological violence in their lives.
- To develop and provide innovative programs and services that reflect feminist principles.
- To provide other related services to individuals affected by violence in accordance with a commitment to diversity.
- To initiate violence prevention activities and promote public awareness of violence against women and children.
- To cooperate with other social agencies in the community.
- To promote changes in social policy and legislation to support the Mission.

#### 11. Summary of Idea:

#### **Recreational Activities for Outreach Program Clients**

We would like to offer the clients in our Outreach Program—women who have experienced violence and are homeless or at risk of homelessness—some recreational activities in the city during the summer. Currently, we do whatever free activities we can, which often entail going for walks and watching other people enjoying all types of fun activities. We would like to offer clients the opportunity to also try some of these activities.

Participants for the recreational activities would come from three of our programs:

• **Outreach Services** are provided to women who have experienced or are at risk of abuse, threats, or violence, and their dependent children. Services include Rent Subsidy support and community based support for women and their families that addresses systematic barriers to securing safe affordable housing, and reduces harms associated with violence and issues associated with homelessness.

In 2017, 573 women and their children were served.

• Homeless Prevention Program (HPP) provides housing assistance and case management to women and their families who are homeless or at risk of homelessness and have experienced violence or are at risk of violence.

In 2017, 188 referrals were received.

• The Boundary Social Housing Project provides long-term affordable housing and support services for women who have experienced violence and are homeless or at risk of homelessness.

In 2017 and currently, our floor at Boundary has been fully occupied with 16 women.

We would like to offer each of the following activities for 10 clients:

- 1) A Visit to Newcastle Island
- 2) Kayaking and Canoeing on Westwood Lake

Recreational activities offer physical, mental, and emotional health benefits, and they promote social bonds. For vulnerable people such as our clients, participation in recreational activities builds confidence and self-esteem, increases self-reliance, and enhances life management.

12. For what purpose do you plan to use this City fund? (Please be specific and note that capital expenditures are not permitted.)

We will use the \$656 from the City to pay for the following activity expenses: ferry, boat rentals, staff wages, and mileage.

#### 13. How will your idea benefit Nanaimo?

Our clients' ability to participate in activities enjoyed by the people around them promotes social inclusion and strengthens social bonds because they can identify with the experience of others. Interacting with other people in the course of activities builds

social cohesion which is integral to the building of social capital in neighbourhoods and in our city.

### 14. How will your program be marketed?

This program will only be available to the clients of our Outreach Programs and its availability will be shared with clients during their meetings and interactions with our Outreach Workers.

#### 15. How will you evaluate the success of the program?

We will evaluate the program's success by the number of participants for both activities and their immediate feedback for each activity.
